L 9	That \$17A-3-14 of the Code of West Virginia, 1931, as amended,
20	be amended and reenacted to read as follows:
21	ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF
22	CERTIFICATES OF TITLE.
23	\$17A-3-14. Registration plates generally: description of plates:

- issuance of special numbers and plates; registration
- 2 fees; special application fees; exemptions;
- 3 commissioner to promulgate forms; suspension and
- 4 nonrenewal.
- 5 (a) The division upon registering a vehicle shall issue to the 6 owner one registration plate for a motorcycle, trailer, semitrailer 7 or other motor vehicle.
- 8 (b) Registration plates issued by the division shall meet the 9 following requirements:
- 10 (1) Every registration plate shall be of reflectorized
 11 material and have displayed upon it the registration number
 12 assigned to the vehicle for which it is issued; the name of this
 13 state, which may be abbreviated; and the year number for which it
 14 is issued or the date of expiration of the plate.
- 15 (2) Every registration plate and the required letters and 16 numerals on the plate shall be of sufficient size to be plainly 17 readable from a distance of one hundred feet during daylight: 18 *Provided*, That the requirements of this subdivision shall not apply 19 to the year number for which the plate is issued or the date of 20 expiration.
- 21 (3) Registration numbering for registration plates shall begin 22 with number two.

- 1 (c) The division may not issue, permit to be issued or 2 distribute any special registration plates except as follows:
- 3 (1) The Governor shall be issued two registration plates, on 4 one of which shall be imprinted the numeral one and on the other 5 the word one.
- 6 (2) State officials and judges may be issued special 7 registration plates as follows:
- (A) Upon appropriate application, the division shall issue to 9 the Secretary of State, State Superintendent of Schools, Auditor, 10 Treasurer, Commissioner of Agriculture and the Attorney General, 11 the members of both houses of the Legislature, including the 12 elected officials of both houses of the Legislature, the justices 13 of the Supreme Court of Appeals of West Virginia, the 14 representatives and senators of the state in the Congress of the 15 United States, the judges of the West Virginia circuit courts, 16 active and retired on senior status, the judges of the United 17 States district courts for the State of West Virginia and the 18 judges of the United States Court of Appeals for the fourth 19 circuit, if any of the judges are residents of West Virginia, a 20 special registration plate for a Class A motor vehicle and a 21 special registration plate for a Class G motorcycle owned by the 22 official or his or her spouse: Provided, That the division may 23 issue a Class A special registration plate for each vehicle titled

- 1 to the official and a Class G special registration plate for each 2 motorcycle titled to the official.
- 3 (B) Each plate issued pursuant to this subdivision shall bear
- 4 any combination of letters and numbers not to exceed an amount
- 5 determined by the commissioner and a designation of the office.

- 7 number of vehicles titled in the name of the qualified applicant.
- 8 Persons desiring the special registration plate shall offer

- 11 name of a qualified applicant depicting the Gold Star awarded by

- 2 (vi) The organization's lettering, logo, image or message to
- 3 be placed on the registration plate, if created, may not be
- 4 obscene, offensive or objectionable as determined by the

- 2 by this chapter.
- 3 (62) The commissioner may issue special registration plates to
- 4 a resident next-of-kin of a member of any law-enforcement agency of
- 5 the United States or this state killed in line of duty as follows:
- 6 (A) Upon appropriate application, the division shall issue a
- 7 special registration plate designed by the commissioner after
- 8 consultation with the West Virginia Chiefs of Police Association,
- 9 the West Virginia Sheriffs' Association, the West Virginia Troopers
- 10 Association or the Division of Natural Resources for any number of
- 11 vehicles titled in the name of a qualified applicant.
- 12 (B) The next-of-kin shall provide sufficient proof of
- 13 eligibility and relationship as required by the commissioner.
- 14 (C) The division shall charge a special initial application
- 15 fee of \$10 in addition to all other fees required by law. This

- 18 (D) The division shall charge an annual fee of \$15 for each

- 1 (d) The minimum number of applications required prior to 2 design and production of a special license plate shall be as 3 follows:
- (1) The commissioner may not begin the design or production of 5 any license plates for which eligibility is based on membership or 6 affiliation with a particular private organization until at least 7 one hundred persons complete an application and deposit with the 8 organization a check to cover the first year's basic registration, 9 one-time design and manufacturing costs and to cover the first year 10 additional annual fee. If the organization fails to submit the 11 required number of applications with attached checks within six 12 months of the effective date of the original authorizing 13 legislation, the plate will not be produced and will require 14 legislative reauthorization: Provided, That an organization or 15 group that is unsuccessful in obtaining the minimum number of 16 applications may not request reconsideration of a special plate 17 until at least two years have passed since the effective date of 18 the original authorization: Provided, however, That the provisions 19 of this subdivision (1) are not applicable to the issuance of 20 plates authorized pursuant to subdivision (60) subdivisions (60) 21 and (62), subsection (c) of this section.
- 22 (2) The commissioner may not begin the design or production of 23 any license plates authorized by this section for which membership

1 or affiliation with a particular organization is not required until 2 at least two hundred fifty registrants complete an application and 3 deposit a fee with the division to cover the first year's basic 4 registration fee, one-time design and manufacturing fee and 5 additional annual fee if applicable. If the commissioner fails to 6 receive the required number of applications within six months of 7 the effective date of the original authorizing legislation, the 8 plate will not be produced and will require legislative 9 reauthorization: Provided, That if the minimum number of 10 applications is not satisfied within the six months of the 11 effective date of the original authorizing legislation, a person 12 may not request reconsideration of a special plate until at least 13 two years have passed since the effective date of the original 14 authorization.

- (e) (1) Nothing in this section requires a charge for a free prisoner of war license plate or a free recipient of the Congressional Medal of Honor license plate for a vehicle titled in the name of the qualified applicant as authorized by other provisions of this code.
- 20 (2) A surviving spouse may continue to use his or her deceased 21 spouse's prisoner of war license plate or Congressional Medal of 22 Honor license plate until the surviving spouse dies, remarries or 23 does not renew the license plate.

- 1 (3) Qualified former prisoners of war and recipients of the 2 Congressional Medal of Honor may obtain a second special 3 registration plate for use on a passenger vehicle titled in the 4 name of the qualified applicant. The division shall charge a 5 one-time fee of \$10 to be deposited into the State Road Fund, in 6 addition to all other fees required by this chapter, for the second 7 special plate.
- 8 (f) The division may issue special ten-year registration 9 plates as follows:
- (1) The commissioner may issue or renew for a period of no 11 more than ten years any registration plate exempted from 12 registration fees pursuant to any provision of this code or any 13 restricted use antique motor vehicle license plate authorized by 14 section three-a, article ten of this chapter: *Provided*, That the 15 provisions of this subsection do not apply to any person who has 16 had a special registration suspended for failure to maintain motor 17 vehicle liability insurance as required by section three, article 18 two-a, chapter seventeen-d of this code or failure to pay personal 19 property taxes as required by section three-a of this article.
- 20 (2) An initial nonrefundable fee shall be charged for each 21 special registration plate issued pursuant to this subsection, 22 which is the total amount of fees required by section fifteen, 23 article ten of this chapter, section three, article three of this

- 1 chapter or section three-a, article ten of this chapter for the 2 period requested.
- 3 (g) The provisions of this section may not be construed to 4 exempt any registrant from maintaining motor vehicle liability 5 insurance as required by section three, article two-a, chapter 6 seventeen-d of this code or from paying personal property taxes on 7 any motor vehicle as required by section three-a of this article.
- (h) The commissioner may, in his or her discretion, issue a 9 registration plate of reflectorized material suitable for permanent 10 use on motor vehicles, trailers and semitrailers, together with 11 appropriate devices to be attached to the registration to indicate 12 the year for which the vehicles have been properly registered or 13 the date of expiration of the registration. The design and 14 expiration of the plates shall be determined by the commissioner. 15 The commissioner shall, whenever possible and cost effective, 16 implement the latest technology in the design, production and 17 issuance of registration plates, indices of registration renewal 18 and vehicle ownership documents, including, but not limited to, 19 offering Internet renewal of vehicle registration and the use of 20 bar codes for instant identification of vehicles by scanning 21 equipment to promote the efficient and effective coordination and 22 communication of data for improving highway safety, aiding law 23 enforcement and enhancing revenue collection.

1 (i) Any license plate issued or renewed pursuant to this
2 chapter which is paid for by a check that is returned for
3 nonsufficient funds is void without further notice to the
4 applicant. The applicant may not reinstate the registration until
5 the returned check is paid by the applicant in cash, money order or
6 certified check and all applicable fees assessed as a result
7 thereof have been paid.

NOTE: The purpose of this bill is to provide for the issuance of special license plates stating "I Support Veterans".
