19	§33-17A-4. Notification and reasons for a transfer, declination
20	or termination.
21	(a) Upon declining to insure any real or personal property,
22	subject to this article, the insurer making a declination shall

- 1 provide the insurance applicant with a written explanation of the
- 2 specific reason or reasons for the declination at the time of the
- 3 declination. The provision of such insurance application form by
- 4 an insurer shall create no right to coverage on the behalf of the
- 5 insured to which the insured is not otherwise entitled.
- 6 (b) A notice of cancellation of property insurance coverage by
- 7 an insurer shall be in writing, shall be delivered to the named
- 8 insured or sent by first class mail to the named insured at the
- 9 last known address of the named insured, shall state the effective
- 10 date of the cancellation and shall be accompanied by a written
- 11 explanation of the specific reason or reasons for the cancellation.
- 12 (c) At least thirty days before the end of a policy period, as
- 13 described in subsection (c), section three of this article, an

  7 lightning, wildfire, extreme low or high temperature, snow or ice,
- 9 <u>failed to maintain the property and that failure to maintain the</u>

  18 disaster in which a state of emergency has been declared by the

  21 a major disaster declaration or emergency declaration has been
  22 issued by the President of the United States pursuant to the
  23 provisions of 42 U.S.C. \$5122.

NOTE: This bill was recommended for introduction and passage by the Joint Committee on the Judiciary. The bill prohibits the nonrenewal or cancellation of a property insurance coverage policy as a result of certain claims arising from natural causes under certain circumstances.
