That the Code of West Virginia, 1931, as amended, be amended 24 by adding thereto a new section, designated \$19-1-11, to read as

1 follows:

2 ARTICLE 1. DEPARTMENT OF AGRICULTURE.

3 §19-1-11. Veterans and Warriors to Agriculture Fund; findings;
4 cooperation with other departments; disbursements.

5 (a) Legislative findings: --

6 (1) West Virginians have a longstanding tradition of service 7 in the Armed Forces of the United States that dates back to the 8 creation of the state, many of them leaving their occupation as 9 farmers to take up arms against the enemy.

10 (2) Veterans of the Armed Forces of the United States return 11 to West Virginia are often unable to find gainful employment, 12 resulting in an alarming rate of unemployment amongst veterans and 13 a blow to West Virginia's economy.

14 (3) In addition to physical wounds, veterans also often face 15 other hardships, such as post-traumatic stress disorder, traumatic 16 brain injuries, and other afflictions that may render a veteran 17 prone to homelessness, difficulty assimilating back into society, 18 and other personal and domestic problems.

19 (4) Agriculture is a critical ingredient in West Virginia's 20 economy and it has potential to have an even bigger impact on the 21 economy. Agriculture offers solitude in its work which, in addition 22 to offering meaningful employment, has been shown to be therapeutic 23 to those suffering from physical and emotional afflictions similar

1 to what veterans face upon returning from combat. Exploring 2 opportunities to engage West Virginia's veterans in agriculture is 3 beneficial to the health and welfare of veterans, as well as to the 4 future of West Virginia's agriculture economy.

5 (b) Legislative Intent. -- It is the intent of the 6 Legislature that the Department of Agriculture create and maintain 7 a program to encourage, support and develop West Virginia veterans 8 into the field of agriculture.

9 (c) (1) In order to increase the number of veterans involved in 10 agriculture and widen the scope of veteran activities and 11 opportunities in agriculture, the Department of Agriculture shall programs introduce veterans to 12 develop to agricultural 13 opportunities and support veterans currently working in 14 agriculture. These activities and opportunities include, but are 15 not limited to returning post-mine land to an agriculture purpose, 16 expanding the apiary industry, exploring niche crops, developing 17 livestock and increasing the aquaculture industry.

18 (2) The Department of Agriculture shall have the opportunity 19 to call upon any state department, or officer of the state or 20 county, to cooperate in furthering this effort, and it shall be the 21 duty of any such department or officer, upon request of the 22 commissioner, to render the assistance required. The commissioner 23 may also cooperate with any corporation, nonprofit organization, 24 individual or other entity to further this effort.

1 (3) The Department of Veterans' Assistance shall work in 2 conjunction with the Department of Agriculture and the State's 3 Adjutant General to assist in recruiting, training and verifying 4 the status of veterans eligible under this program, as well as 5 developing and supporting program elements.

6 (d) Notwithstanding any provision in this code to the 7 contrary, should the Department of Agriculture deem it necessary to 8 provide land for activities within this program, it is exempt from 9 purchasing requirements as they relate to the competitive leasing 10 of state property.

(e) There is hereby created in the State Treasury a separate special revenue account, which shall be an interest bearing account, to be known as the "Veterans and Warriors to Agriculture Fund." The special revenue account shall consist of moneys derived from leasing of the Department of Agriculture's property associated with this program, moneys from the Department of Agriculture's farm account not utilized for farm operations, private or charitable donations, all amounts appropriated by the Legislature to maintain and operate the programs, and all interest or other earnings from moneys in the fund.

(f) Moneys in the special revenue account shall be appropriated to the Department of Agriculture and used exclusively, an accordance with appropriations by the Legislature, to pay costs, fees and expenses incurred, or to be incurred that support the

1 programs developed to aid veterans.

2 (g) Any balance remaining in the special revenue account at 3 the end of any state fiscal year shall not revert to the General 4 Revenue Fund but shall remain in the special revenue account and 5 shall be used solely in a manner consistent with this section.

6 (h) Disbursements from the special revenue account shall be 7 authorized by the commissioner.

NOTE: The purpose of this bill is to grant the Department of Agriculture the authority to create and maintain a program to encourage, support and develop West Virginia veterans into the field of agriculture. The bill creates the Veterans and Warriors to Agriculture Fund. The bill makes findings and establishes intent. The bill exempts the Department of Agriculture from certain competitive bidding requirements. The bill requires state departments to work together. The bill sets forth funding requirements. The bill sets forth disbursements.
