10	A BILL to amend and reenact $\$5B-2F-2$ of the Code of West Virginia,
11	1931, as amended, relating to creating the Energy Development
12	Fund; allowing the Division of Energy to accept and use gifts,
13	donations and contributions; and authorizing expenditures.
14	Be it enacted by the Legislature of West Virginia:
15	That §5B-2F-2 of the Code of West Virginia, 1931, as amended,
16	be amended and reenacted to read as follows:
17	ARTICLE 2F. DIVISION OF ENERGY.
18	§5B-2F-2. Purpose; Office of Director for Energy Development;
19	director to be member of Public Energy Authority;
20	division to develop energy policy and development
21	plan; contents of energy policy and development plan;
22	division to promote energy initiatives.

(a) Effective July 1, 2007, the Division of Energy is created 1 2 as a state agency under the Department of Commerce. The division 3 may receive federal funds, gifts, donations or contributions from 4 individuals, organizations or corporations. All moneys collected 5 shall be deposited in a special account, hereby created in the 6 State Treasury, to be known as the Energy Development Fund. 7 Expenditures from the fund shall be for increasing efficiency of 8 energy use, increased development of new and existing domestic 9 energy sources and increased energy self sufficiency and may be 10 used to establish grants to further the purposes of this section, 11 and are not authorized from collections but are to be made only in 12 accordance with appropriation by the Legislature and in accordance 13 with the provisions of article three, chapter twelve of this code 14 and upon fulfillment of the provisions of article two, chapter 15 eleven-b of this code: Provided, That for the fiscal year ending 16 June 30, 2015, expenditures are authorized from collections rather 17 than pursuant to appropriation by the Legislature.

18 <u>(b)</u> The division shall be administered by a director, who
19 shall be appointed by the Governor, by and with the advice and
20 consent of the Senate, and shall continue to serve until his or her
21 successor is appointed and qualified as provided. The director
22 shall be selected with special preference and consideration given
23 to his or her training, experience, capacity and interest in energy

- 1 policy and development activities.
- 2 (c) The creation of the division is intended to provide
  3 leadership for developing energy policies emphasizing the increased
  4 efficiency of energy use, the increased development and production
  5 of new and existing domestic energy sources, the increased
  6 awareness of energy use on the environment and the economy,
  7 dependable, efficient and economical statewide energy systems
  8 capable of supporting the needs of the state, increased energy self
  9 sufficiency where the ratio of indigenous to imported energy use is
  10 increased, reduce the ratio energy consumption to economic activity
  11 and maintain low-cost energy. The energy policies and development
  12 plans shall also provide direction for the private sector.
- (d) The director shall administer the daily operations of the Public Energy Authority provided under the provisions of chapter five-d of this code. The director shall also have authority over the Office of Coalfield Community Development, created by the provisions of article two-a of this chapter, and the energy efficiency program existing under the West Virginia Development Office which are hereby transferred to the division. The director shall effectuate coordination of these entities relative to the purposes provided in this article.
- 22 (e) The division shall develop an energy policy and shall 23 report the same back to the Governor and the Joint Committee on

- 1 Government and Finance before December 1, 2007. The energy policy 2 shall be a five-year plan setting forth the state's energy policies 3 and shall provide a direction for the private sector. Prior to the 4 expiration of the energy policy, the division shall begin review of 5 the policy and submit a revised energy policy to the Governor and 6 the Joint Committee on Government and Finance six months before the 7 expiration of the policy.
- 8 (f) The director shall be a member of the Public Energy
  9 Authority and as such shall attend and participate in all official
  10 meetings and public hearings conducted under the auspices of the
  11 authority.
- (g) The division shall prepare and submit an annual energy development plan to the Governor and the Joint Committee on Government and Finance on or before December 1 of each year. The development plan shall relate to the division's implementation of the energy policy and the activities of the division during the previous year. The development plan shall include any recommended legislation. The Public Energy Authority, the Office of Coalfield Community Development, the energy efficiency program, the Department of Environmental Protection and the Public Service Commission, in addition to their other duties prescribed by this code, shall assist the division and the director in the development of an energy policy and related development plans. The energy

1 development plan shall set forth the plans for implementing the 2 state's energy policy and shall provide a direction for the private 3 sector. The energy development plan shall recognize the powers of 4 the Public Energy Authority as to development and financing of 5 projects under its jurisdiction and shall make such recommendations 6 as are reasonable and practicable for the exercise of such powers. (h) The division shall hold public hearings and meetings with 8 notice to receive public input regarding proposed energy policies 9 and development plans. The energy policy and development plans 10 required by subsections (d) and (f) of this section shall address 11 increased efficiency of energy use, traditional and alternative 12 energy, water as a resource and a component of energy production, 13 energy distribution systems, the siting of energy facilities, the 14 increased development and production of new and existing domestic 15 energy sources, increased awareness of energy use 16 environment and the economy, energy infrastructure, the development 17 and implementation of renewable, clean, technically innovative and 18 advanced energy projects in this state. Projects may include, 19 without limitation, solar and wind energy, low-impact hydro power, 20 geothermal, biomass, landfill gas, fuel cells, renewable hydrogen 21 fuel technologies, waste coal, coal mine methane, coal gasification 22 to ultraclean fuels, solid waste to fuel grade ethanol and coal 23 liquefaction technologies.

- 1 (I) The division may propose rules for legislative approval in
- 2 accordance with the provisions of article three, chapter twenty-
- 3 nine-a of this code designed to implement an energy policy and
- 4 development plan in accordance with the provisions of this chapter.
- 5 (j) The energy policy and development plans required by
- 6 subsections (d) and (f) of this section shall identify and report
- 7 on the energy infrastructure in this state and include without
- 8 limitation energy infrastructure related to protecting the state's
- 9 essential data, information systems and critical government
- 10 services in times of emergency, inoperativeness or disaster. In
- 11 consultation with the Director of the Division of Homeland Security
- 12 and Emergency Management, the director of the division shall
- 13 encourage the development of energy infrastructure and strategic
- 14 resources that will ensure the continuity of governmental
- 15 operations in situations of emergency, inoperativeness or disaster.
- 16 (k) In preparing or revising the energy policy and development
- 17 plan, the division may rely upon internal staff reports or the
- 18 advice of outside advisors or consultants and may procure such
- 19 services with the consent of the Secretary of Commerce. The
- 20 division may also involve national, state and local government
- 21 leadership and energy experts.
- 22 (1) The division shall prepare an energy use database,
- 23 including without limitation end-use applications and

- 1 infrastructure needs for different classes of energy users
  2 including residential, commercial and industrial users, data
  3 regarding the interdependencies and sources of electricity, oil,
  4 coal, water and gas infrastructure, data regarding energy use of
  5 schools and state-owned facilities and collect data on the impact
  6 of the energy policy and development plan on the decisions and
  7 strategies of energy users of the state.
- 8 (m) The division shall promote collaboration between the 9 state's universities and colleges, private industry and nonprofit 10 organizations to encourage energy research and leverage available 11 federal energy research and development resources.
- 12 (n) The division shall promote initiatives to enhance the 13 nation's energy security through research and development directed 14 at transforming the state's energy resources into the resources 15 that fuel the nation.
- 16 (o) The Performance Evaluation and Research Division of the 17 Legislative Auditor's Office shall perform an agency review of the 18 Division of Energy in 2010 as part of its review of the Department 19 of Commerce as set forth in article four, chapter ten of this code.
- (p) The division shall work with the President of the United 21 States and his or her administration to develop a plan that would 22 allow West Virginia to become the leader in transitioning the 23 United States to a new energy future.

- 1 (q) The division is to determine the best way for West
- 2 Virginia to utilize its resources and any federal funding to
- 3 develop the technologies that are necessary for such a transition.
- 4 (r) The division is to clearly articulate West Virginia's
- 5 position on an energy solution for the United States that
- 6 encompasses clean coal, natural gas, transtech energy technologies
- 7 and renewable energy technologies.
- 8 (s) The division shall develop and distribute an informational
- 9 program and policies that emphasize the importance of West Virginia
- 10 energy resources and their positive impact on the eastern seaboard
- 11 and the nation.
- 12 (t) The division shall monitor legal challenges to the energy
- 13 industries in the state and submit a report quarterly to the Joint
- 14 Committee on Government and Finance. The report shall contain
- 15 information relating to any litigation that challenges any statute
- 16 that could affect the production, distribution and utilization of
- 17 natural resources of the state.
