10 AN ACT expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,
11 for the fiscal year ending June 30, 2015 in the amount of \$1,500,000 from the Department
12 of Military Affairs and Public Safety, Division of Corrections - Correctional Units, fund
13 0450, fiscal year 2012, organization 0608, appropriation 59200, and in the amount of
14 \$400,103.30 from the Department of Transportation, Division of Public Transit, fund 0510,
15 fiscal year 2013, organization 0805, appropriation 25800, and in the amount of \$3,861,297
16 from the Department of Administration, Risk and Insurance Management Board - Premium
17 Tax Savings Fund, fund 2367, fiscal year 2015, organization 0218, and in the amount of
18 \$1,329.28 from the Department of Health and Human Resources, Division of Health,

15 fiscal year 2015, organization 0218, in the Department of Health and Human Resources, Division
16 of Health, Uniform Health Professional Data Collection Systems Fund, fund 5109, fiscal year 2015,

20 established; and

21 WHEREAS, The Governor submitted to the Legislature the Executive Budget document, dated
22 January 14, 2015, which included a Statement of the State Fund, General Revenue, setting forth
23 therein the cash balance as of July 1, 2014, and further included the estimate of revenues for the

1 fiscal year 2015, less net appropriation balances forwarded and regular appropriations for the fiscal
2 year 2015 and further included recommended expirations to the surplus balance of the State Fund
3 General Revenue; and

4 WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
5 General Revenue, and this legislation, there now remains an unappropriated surplus balance in the
6 State Treasury which is available for appropriation during the fiscal year ending June 30, 2015;
7 therefore

8 *Be it enacted by the Legislature of West Virginia:*

9 That the balance of the funds available for expenditure in the fiscal year ending June 30,
10 2015, in the Department of Military Affairs and Public Safety, Division of Corrections - Correctional
11 Units, fund 0450, fiscal year 2012, organization 0608, appropriation 59200 be decreased by expiring
12 the amount of \$1,500,000, and in the Department of Transportation, Division of Public Transit, fund
13 0510, fiscal year 2013, organization 0805, appropriation 25800, be decreased by expiring the amount
14 of \$400,103.30, and in the Department of Administration, Risk and Insurance Management Board -
15 Premium Tax Savings Fund, fund 2367, fiscal year 2015, organization 0218, be decreased by
16 expiring the amount of \$3,861,297, and in the Department of Health and Human Resources, Division
17 of Health, Uniform Health Professional Data Collection Systems Fund, fund 5109, fiscal year 2015,
18 organization 0506, be decreased by expiring the amount of \$1,329.28, and in the Department of
19 Health and Human Resources, Division of Health, Commonly Based Fetal and Infant Mortality
20 Review Fund, fund 5131, fiscal year, 2015, organization 0506, be decreased by expiring the amount
21 of \$478.81, and in the Department of Health and Human Resources, Division of Health, Claude
22 Worthington Benedum Foundation Fund, fund 5132, fiscal year 2015, organization 0506, be

6 of \$16,700,000, all to the unappropriated surplus balance of the State Fund, General Revenue, to be
7 available for appropriation during the fiscal year ending June 30, 2015: *Provided*, That the expiration
8 of funds provided herein shall not occur until such time as the bonds authorized by the provisions
9 of section sixteen-b, article fifteen, chapter thirty-one of the Code of West Virginia for improvements
10 to Cacapon State Park and Beech Fork State Park have been sold.

11 The purpose of this supplemental appropriation bill is to expire items of appropriation and
12 cash balances in the aforesaid accounts for the designated spending units during the fiscal year 2015.
