13	§30-27-8, §30-27-8a, §30-27-10, §30-27-11, §30-27-13 and §30-27-16 of the code; and to
14	amend said code by adding thereto two new sections, designated §30-27-8b and §30-27-8c,
15	all relating to licensing of aestheticians, barbers, cosmetologists, hairstylists and nail
16	technicians; revising the membership requirements of the Board of Barbers and
17	Cosmetologists; exempting shampoo assistants and hair braiding from licensure by the Board
18	of Barbers and Cosmetologists; creating certifications; modifying barber apprentice program;
19	limiting continuing education requirements for barbers and cosmetologists; and modifying
20	the requirements to be an instructor in a school.
21	Be it enacted by the Legislature of West Virginia:
22	That the Code of West Virginia, 1931, as amended, be amended by repealing §30-27-11a
23	and §30-27-12; that §30-27-1, §30-27-3, §30-27-4, §30-27-5, §30-27-6, §30-27-8, §30-27-8a, §30-27-8a, §30-27-8a, §30-27-8b, §30-27-8
24	27-10, §30-27-11,§30-27-13 and §30-27-16 of said code be amended and reenacted; and that said
25	code be amended by adding thereto two new sections, designated §30-27-8b and §30-27-8c, all to
26	read as follows:
27	CHAPTER 30. PROFESSIONS AND OCCUPATIONS.

ARTICLE 27. BOARD OF BARBERS AND COSMETOLOGISTS.

2 §30-27-1. Unlawful acts.

(a) It is unlawful for any person to practice or offer to practice barbering, barber permanent
waving, cosmetology, <u>hair styling</u>, aesthetics, or nail care in this state without a license issued under
the provisions of this article, or advertise or use any title or description tending to convey the
impression that the person is a licensed aesthetician, barber, barber crossover, barber permanent
wavist, cosmetologist, cosmetologist crossover nail technician or hairstylist, unless the person has
been licensed under the provisions of this article, and the license has not expired, been suspended
or revoked.

(b) No salon, except through a licensee, may render any service or engage in any activity
 which if rendered or engaged in by an individual, would constitute the practices licensed under the
 provisions of this article.

(c) No school, except through a licensee, may instruct, render any service or engage in any
 activity which if taught, rendered or engaged in by an individual, would constitute the practices
 licensed under the provisions of this article.

16 **§30-27-3. Definitions.**

As used in this article, the following words and terms have the following meanings, unless
the context clearly indicates otherwise:

(a) "Aesthetics" or "esthetics" means any one or any combination of the following acts when
done on the human body for compensation and not for the treatment of disease:

(1) Administering cosmetic treatments to enhance or improve the appearance of the skin,
 including cleansing, toning, performing effleurage or other related movements, stimulating,
 exfoliating or performing any other similar procedure on the skin of the human body or scalp;

(2) Applying, by hand or with a mechanical or electrical apparatus, any cosmetics, makeups,
 oils, powders, clays, antiseptics, tonics, lotions, creams or chemical preparations necessary for the
 practice of aesthetics to another person's face, neck, back, shoulders, hands, elbows and feet up to

and including the knee;

 3 neck, back, shoulders, hands, elbows and feet up to and including the knee;
- 4 (4) The waxing, tweezing and threading of hair on another person's body;
- 5 (5) The wrapping of another person's body in a body wrap;
- 6 (6) Applying artificial eyelashes and eyebrows; and
- 7 (7) The lightening of hair on the body except the scalp.
- 8 (b) "Aesthetician" or "esthetician" means a person licensed under the provisions of this
 9 article who engages in the practice of aesthetics.
- (c) "Applicant" means a person making application for a professional license, license,
 certificate, registration, permit or renewal under the provisions of this article.
- (d) "Barber" means a person licensed under the provisions of this article who engages in the
 practice of barbering and has completed 1500 clock hours of training at a licensed school approved
 by the West Virginia Council for Community and Technical College Education.
- (e) "Barbering" means any one or any combination of the following acts when done on the
 human body for compensation and not for the treatment of disease:
- 17 (1) Shaving, shaping and trimming the beard, or both;
- (2) Cutting, singeing, shampooing, arranging, dressing, tinting, bleaching, or applying lotions
 or tonics on human hair, or a wig or hairpiece; and
- (3) Applications, treatments or rubs of the scalp, face, or neck with oils, creams, lotions,
 cosmetics, antiseptics, powders, or other preparations in connection with the shaving, cutting or
 trimming of the hair or beard.
- (f) "Barber crossover" or "cosmetologist crossover" is a person who is licensed to perform
 barbering and cosmetology. who has completed 1500 clock hours of training, is licensed as a barber,
 and completes an additional 600 hours of training to perform cosmetology.
- 26 (g) "Barber permanent waving" means the following acts done on the human body for

1	compensation and not for the treatment of disease:
2	(1) The bleaching or tinting of hair; and
3	(2) The permanent waving of hair.
4	(h) "Barber permanent wavist" means a person licensed to perform barbering and barber
5	permanent waving.
6	(i) (g) "Board" means the West Virginia Board of Barbers and Cosmetologists.
7	(j) (h) "Certificate" means an instructor certificate to teach in a school under the provisions
8	of this article a document issued by the board for additional training received through a school
9	licensed in this state or through an industry recognized program.
10	(k) "Certificate holder" means a person certified as an instructor to teach in a school under
11	the provisions of this article.
12	(1) (i) "Cosmetologist" means a person licensed under the provisions of this article who
13	engages in the practice of cosmetology and who has completed 1800 clock hours of training at a
14	licensed school approved by the West Virginia Council for Community and Technical College
15	Education.
16	(m) (j) "Cosmetology" means any one or any combination of the following acts when done
17	on the human body for compensation and not for the treatment of disease:
18	(1) Cutting, styling, shaping, arranging, braiding, weaving, dressing, adding extensions,
19	curling, waving, permanent waving, relaxing, straightening, shampooing, cleansing, singeing,
20	bleaching, tinting, coloring, waxing, tweezing, or similarly work on human hair, or a wig or
21	hairpiece, by any means, including hands, mechanical or electrical devices or appliances;
22	(2) Nail care;
23	(3) Applying by hand or with a mechanical or electrical device or appliance, any cosmetics,

6	is licensed as a cosmetologist, and completes an additional 300 hours of training to perform
7	barbering.
8	(n) (l) "General supervision" means:
9	(1) For schools, a master or certified instructor is on the premises and is quickly and easily
10	available; or
11	(2) For salons, a professional licensee is on the premises and is quickly and easily available.
12	(o) (m) "Hair braiding" means any one or any combination of the following acts when done
13	on the human body for compensation and not for the treatment of disease: Braiding, plaiting,
14	twisting, wrapping, threading, weaving, interweaving, extending or locking of natural human hair
15	or manufactured materials around human hair by hand or mechanical device.
16	(p) (n) "Hair Styling" means any one or any combination of the following acts when done on
17	the human body for compensation and not for the treatment of disease:
18	(1) Cutting, styling, shaping, arranging, braiding, weaving, dressing, adding extensions,
19	curling, waving, permanent waving, relaxing, straightening, shampooing, cleansing, singeing,
20	bleaching, tinting, coloring, waxing, tweezing, threading or similarly work on human hair, or a wig
21	or hairpiece, by any means, including hands, mechanical or electrical devices or appliances;
22	(2) The rubbing, cleansing, exercising, beautifying or grooming of another person's face,

5	chapter eighteen-b of this code, to educate persons to be licensed or issued certain permits under the
6	provisions of this article.
7	(t) (s) "Licensee" means a person, corporation or firm holding a license issued under the
8	provisions of this article.
9	$\frac{(u)}{(t)}$ "Nail care" means any one or any combination of the following acts when done on the
10	human body for compensation and not for the treatment of disease:
11	(1) The cleansing, dressing, or polishing of nails of a person;

13	(3) The cosmetic treatment of the feet up to the knee and the hands up to the elbow.

21	(z) (y) "Registration" means a registration issued by the board to a person who rents or leases
22	a booth or chair from a licensed salon owner and operator., or both, or a registration issued by the
23	board to a person who is a student in a school
24	$\frac{(aa)}{(z)}$ "Registrant" means a person who holds a registration under the provisions of this
25	article.
26	(bb)(aa) "Salon" means a shop or other facility where a person practices under a professional

2	(cc) (bb) "Salon license" means a license to own and operate a salon.
3	(dd) "Student registration" means a registration issued by the board to a student to study at
4	a school licensed under the provisions of this article.
5	(cc) "Shampoo assistant" means a person who performs only the following services:
6	(1) Shampooing and rinsing hair;
7	(2) Removing rollers or permanent rods; and
8	(3) Cleansing or other sink-related functions not requiring the skill of a basic barber.
9	§30-27-4. Board of Barbers and Cosmetologists.
10	(a) The West Virginia Board of Barbers and Cosmetologists is continued. The members of
11	the board in office on July 1, 2014 2015, shall, unless sooner removed, continue to serve until their
12	respective terms expire and until their successors have been appointed and qualified.
13	(b) The Governor, by and with the advice and consent of the Senate, shall appoint:
14	(1) One licensed cosmetologist or crossover cosmetologist;
15	(2) One licensed barber <u>or barber crossover;</u>
16	(3) One licensed barber crossover or licensed barber permanent wavist;
17	(4) One licensed aesthetician;
18	(5) One licensed nail technician;
19	(6) (3) One representative from a privately owned beauty school licensed by the West
20	Virginia Council for Community and Technical College Education; and
21	(7) (4) One Four citizen member members representing the general public.
22	(c) After the initial appointment term, the term shall be for five years. All appointments to

13	(a) An applicant for a professional license to practice as $a\underline{n}$ aesthetician, barber, barber
14	crossover, barber permanent wavist, cosmetologist, hair stylist, cosmetologist crossover or nail
15	technician shall present satisfactory evidence that he or she:
16	(1) Is at least eighteen years of age;
17	(2) Is of good moral character;
18	(3) Has a high school diploma, a GED, or has passed the "ability to benefit test" approved
19	by the United States Department of Education;
20	(4) Has graduated from a licensed school which has been approved by the West Virginia

5	(b) A license to practice issued by the board prior to July 1, $\frac{2009}{2015}$, shall for all purposes
6	be considered a professional license issued under this article: Provided, That a person holding a
7	license issued prior to July 1, 2009 2015, must renew the license pursuant to the provisions of this
8	article. After July 1, 2015, the Board shall issue both barber and cosmetologist renewal licenses in
9	the case of a barber crossover or cosmetologist crossover and shall issue a barber license renewal in
10	the case of barber permanent wavist.
11	§30-27-8a. Barber apprentice.
12	(a) The board may establish an apprenticeship program to become a barber. A person wishing
13	to become a barber through an apprenticeship shall apply with the board and receive a permit. A
14	barber apprentice shall work at all times under the direct supervision of a licensed barber and any
15	permit issued by the board to work as a barber apprentice does not allow a person to practice
16	individually as a barber.
17	(b) An applicant for a barber apprenticeship shall present satisfactory evidence that he or she:
18	(1) Is at least eighteen years of age;
19	(2) Is of good moral character;
20	(3) Has a high school diploma, a GED, or has passed the "ability to benefit test" approved

9	examination for licensure; Provided, That at the end of two years of supervised training, a barber
10	apprentice may take the examination for licensure without the recommendation of the sponsor.

5 §30-27-8c. Shampoo Assistant and Hair Braiding; exemptions from licensure.

- 6 (a) Notwithstanding any provision of this code, a person may practice hair braiding without
 7 obtaining a license or any other authorization from a professional board of this state and is not
 8 subject to educational or training requirements. A person practicing hair braiding may work at or
 9 be employed by a salon or other place of business or may practice hair braiding individually.
- (b) Notwithstanding any provision of this code, a shampoo assistant is not required to obtain
 a permit or any other authorization from a professional board of this state and is not subject to
 education or training requirements. A shampoo assistant may work at or be employed by a salon or
 other place of business or may practice individually as a shampoo assistant.
- 14 (c) Notwithstanding any provision of this code, the board has no authority to propose 15 legislative rules to implement the provisions of this section or to exercise any jurisdiction or 16 authority over the practice of or any shampoo assistant or acts of hair braiding or the qualifications
- 17 for a person to practice hair braiding.

18 §30-27-10. Professional license and certificate renewal requirements.

- (a) A professional licensee and certificate holder shall annually or biennially on or before
 January 1, renew his or her professional license or certificate by completing a form prescribed by the
 board, paying the renewal fee and submitting any other information required by the board.
- (b) The board shall charge a fee for each renewal of a license or certificate, and a late fee forany renewal not paid by the due date.
- (c) The board shall require as a condition of renewal of a professional license or certificate
 that each licensee or certificate holder complete continuing education: *Provided*, That a <u>licensed</u>
 barber who has been licensed for twenty years or more is exempt from the continuing education

1	requirement of this subsection, Provided, however, That beginning January 1, 2016, licensed barbers
2	shall take a sanitation course through a program approved by the board each year for the first five
3	years after becoming licensed and once every five years thereafter for fifteen years; Provided,
4	further, That cosmetologists and hair stylists must take four hours of continuing education training
5	annually for the first fifteen years after becoming licensed; And provided further, That the Board
6	shall approve for credit for continuing education any education course providing instruction in any
7	curriculum, subject matter or discipline included in the education required for licensure that is
8	submitted to the board or offered by:
9	(1) A licensed school or instructor;
10	(2) A manufacturer or distributor of barbering or cosmetology products;
11	(3) A barber or cosmetology trade organization; or
12	(4) Any course offered at an accredited private or public university, college or community
13	college in this state.
14	(d) The board may deny an application for renewal for any reason which would justify the
15	denial of an original application for a license or certificate.
16	§30-27-11. Work permit.
17	(a) The board may issue a work permit to practice to an applicant who meets the following
18	conditions:
19	(1) Has graduated from a licensed school approved by the West Virginia Council for
20	Community and Technical College Education or has completed education requirements in another
21	state and meets the licensure provisions of the board;
22	(2) Is waiting to take the examination;
23	(3) Has employment in the field in which he or she applied to take the examination and is
24	working under the general supervision of a professional licensee;
25	(4) Has paid the work permit fee;

1	(6) Is a citizen of the United States or is eligible for employment in the United States; and
2	(7) Meets all the other requirements specified by the board.
3	(b) A work permit expires at the end of the month after issuance following the next
4	examination in the specific field. A work permit may be renewed once.
5	(c) While in effect, a work permitee is subject to the restrictions and requirements imposed
6	by this article.
7	§30-27-13. Display of professional license and permits.
8	(a) The board shall prescribe the form for a professional license and work and student
9	permits, including a photograph, and may issue a duplicate license or permit, upon payment of a fee.
10	(b) Every professional licensee and work permitee shall display his or her license or permit
11	in a conspicuous place at his or her work station.
12	(c) Every student shall have available his or her student permit and be able to produce it upon
13	request.
14	(d) (c) Every professional licensee, work permitee or student-must present such license,
15	permit or registration to an investigator/inspector or a board member upon request.
16	§30-27-16. Certification requirements to be an instructor in a school.
17	(a) The board may issue a certificate to be an instructor in a school to an applicant who meets
18	the following requirements:
19	(1) Meets the educational requirements established by the board;
20	(2) Has completed the required instructor's training;
21	(3) Has passed the instructor examination;
22	(4) Has paid the appropriate fees;
23	(5) Presents a certificate of health from a licensed physician;
24	(6) Is a citizen of the United States or is eligible for employment in the United States; and
25	(7) Has fulfilled any other requirement specified by the board.
26	(a) The Board shall issue a certificate to be an instructor in a school for barbering,

1	cosmetology, hairstyling, nail technician or aesthetics if a person:
2	(1) Completes an application prescribed by the Board;
3	(2) Holds a current West Virginia license in the field in which the person seeks to teach or
4	equivalent from another state as determined by the Board;
5	(3) Completes a one year instructor training course in a school that is licensed by the West
6	Virginia Council for Community and Technical College Education;
7	(4) Passes the instructor training final examination; and
8	(5) Passes a national written examination in instructor training.
9	(b) All instructor certifications must be renewed annually or biennially on or before January
10	1, and pay a renewal fee.
11	(c) A certification to be an instructor issued by the board prior to January 1, 2009, the
12	effective date of this section shall for all purposes be considered a certification issued under this
13	article: Provided, That a person holding a certification issued prior to January 1, 2009, the effective
14	date of this section must renew the certification pursuant to the provisions of this article.
15	(d) An instructor with an expired certificate must comply with the following to renew his or
16	her certificate:
17	(1) Notify the board that he or she wants to be placed on inactive status; or
18	(2) Pay all lapsed renewal fees;
19	(3) Present a new certificate of health; and
20	(4) Meet the qualifications for certification set out in this article.
21	(e) A certified instructor is not required to have an active professional license, unless the
22	instructor is in fact practicing outside the scope of his or her employment as an instructor.
