- On page two, subsection 3.2, by striking out the proposed word "will" that is underscored
- 19 and reinstating the word "shall"; and by making such similar strikes of the underscored word "will"
- and reinstate the word "shall" throughout the rule;
- On page thirteen, subdivision 7.2.b.3, after the word "appropriate" and the comma by
- 22 inserting the word "or";

- On page fourteen, subdivision 7.6.a., after the word "procure" by striking out the words "goods or services" and inserting in lieu thereof the words "specific commodities for immediate delivery";
