10	A BILL to amend and reenact §18-2-25 of the Code of West Virginia, 1931, as amended, relating	
11	to the West Virginia Secondary School Activities Commission; and requiring rules relating	
12	to interscholastic athletic football events include the requirement that neck braces be worn	
13	by all football players.	
14	Be it enacted by the Legislature of West Virginia:	
15	That §18-2-25 of the Code of West Virginia, 1931, as amended, be amended and reenacted	
16	to read as follows:	
17	ARTICLE 2. STATE BOARD OF EDUCATION.	
18	§18-2-25. Authority of county boards to regulate athletic and other extracurricular activities	
19	of secondary schools; delegation of authority to West Virginia Secondary School	
20	Activities Commission; authority of commission; approval of rules by state	
21	board; incorporation; funds; participation by private and parochial schools.	
22	The county boards of education are hereby granted and shall exercise the control, supervision	

and regulation of all interscholastic athletic events, and other extracurricular activities of the students
in public secondary schools, and of said the schools of their respective counties. The county board
of education may delegate such control, supervision and regulation of interscholastic athletic events
and band activities to the "West Virginia Secondary School Activities Commission," which is hereby
established.

The West Virginia Secondary School Activities Commission shall be composed of the 6 principals, or their representatives, of those secondary schools whose county boards of education 7 have certified in writing to the State Superintendent of Schools that they have elected to delegate 8 the control, supervision and regulation of their interscholastic athletic events and band activities 9 10 of the students in the public secondary schools in their respective counties to said commission. The West Virginia Secondary School Activities Commission, is hereby empowered to exercise the 11 12 control, supervision and regulation of interscholastic athletic events and band activities of secondary schools, delegated to it pursuant to this section. The rules and regulations of the West 13 Virginia Secondary School Activities Commission shall contain a provision for a proper review 14 15 procedure and review board and be promulgated in accordance with the provisions of chapter twenty-nine-a of this code, but shall, in all instances be subject to the prior approval of the state 16 board. The West Virginia Secondary School Activities Commission, may, with the consent of the 17 State Board of Education, incorporate under the name of "West Virginia Secondary School 18 Activities Commission, Inc.," as a nonprofit, nonstock corporation under the provisions of chapter 19 thirty-one of this code. The commission shall provide in any rule pertaining to interscholastic 20 21 athletic football events that all players are required to wear neck braces, in addition to the head gear 22 and other protective equipment ordinarily worn in those events. County boards of education are

hereby authorized to expend moneys for and pay dues to the West Virginia Secondary School
Activities Commission, and all moneys paid to such the commission, as well as moneys derived
from any contest or other event sponsored by said the commission, shall be quasi-public funds as
the same are defined in article five, chapter eighteen, and such the funds of the commission shall be
subject to an annual audit by the State Tax Commissioner.

6 The West Virginia Secondary School Activities Commission shall promulgate reasonable 7 rules and regulations providing for the control, supervision and regulation of the interscholastic 8 athletic events and other extracurricular activities of such the private and parochial secondary 9 schools as elect to delegate to such the commission such control, supervision and regulation, upon 10 the same terms and conditions, subject to the same regulations and requirements and upon the 11 payment of the same fees and charges as those provided for public secondary schools. Any such 12 private or parochial secondary school shall receive any monetary or other benefits in the same 13 manner and in the same proportion as any public secondary school.

NOTE: The purpose of this bill is to require the West Virginia Secondary School Activities Commission to adopt rules to provide for use of neck braces by all football players in interscholastic athletic football events.
