B. 2370 3 4 (By Delegates Pasdon, Duke, Rowan, Wagner, Upson, Ambler, 5 and Espinosa) 6 7 [Introduced January 26, 2015; referred to the 8 Committee on Education.] 9 10 11 A BILL to amend and reenact §18-2-26 of the Code of West Virginia, 1931, as amended, relating 12 to increasing the powers of regional councils for governance of regional education service 13 agencies; providing for revision of state board rule; requiring selection of executive director 14 from nominations with certain limitations; requiring consultation with councils on 15 development of job description, qualifications and procedures; requiring provisions for 16 annual performance evaluations with portion of rating determined by council; expanding role 17 of council; stating ability of agencies to cooperate, share or combine services with each other; 18 updating references to computer programs and systems and removing outdated provisions; 19 removing prescriptive provisions for computer installation, maintenance and repair; and 20 removing provisions relating to repealed section on professional development. 21 Be it enacted by the Legislature of West Virginia: 22 That §18-2-26 of the Code of West Virginia, 1931, as amended, be amended and reenacted 23 to read as follows:

1 ARTICLE 2. STATE BOARD OF EDUCATION.

- 2 §18-2-26. Establishment of multicounty regional educational service agencies; purpose;
- authority of state board; governance; annual performance standards.
- 4 (a) *Legislative intent.* -- The intent of the Legislature in providing for establishment of 5 regional education service agencies, hereinafter referred to in this section as agency or agencies, is 6 to provide for high quality, cost effective education programs and services to students, schools and 7 school systems.
- Since the first enactment of this section in 1972, the focus of public education has shifted from a reliance on input models to determine if education programs and services are providing to students a thorough and efficient education to a performance based accountability model which relies on the following:
- 12 (1) Development and implementation of standards which set forth the things that students 13 should know and be able to do as the result of a thorough and efficient education including 14 measurable criteria to evaluate student performance and progress;
- 15 (2) Development and implementation of assessments to measure student performance and 16 progress toward meeting the standards;
- 17 (3) Development and implementation of a system for holding schools and school systems 18 accountable for student performance and progress toward obtaining a high quality education which 19 is delivered in an efficient manner; and
- 20 (4) Development and implementation of a method for building the capacity and improving 21 the efficiency of schools and school systems to improve student performance and progress.
- 22 (b) *Purpose*. -- In establishing the agencies the Legislature envisions certain areas of service

- 1 in which the agencies can best assist the state board in implementing the standards based
- 2 accountability model pursuant to subsection (a) of this section and, thereby, in providing high quality
- 3 education programs. These areas of service include the following:
- 4 (1) Providing technical assistance to low performing schools and school systems;
- 5 (2) Providing high quality, targeted staff development designed to enhance the performance 6 and progress of students in state public education;
- 7 (3) Facilitating coordination and cooperation among the county boards within their respective 8 regions in such areas as cooperative purchasing; sharing of specialized personnel, communications 9 and technology; curriculum development; and operation of specialized programs for exceptional 10 children;
- 11 (4) Installing, maintaining and/or repairing education related technology equipment and
 12 software with special attention to the state level basic skills and SUCCESS programs technology
 13 learning tools for public schools program;
- (5) Receiving and administering grants under the provisions of federal and/or state law; and
 (6) Developing and/or implementing any other programs or services as directed by law, or
 by the state board or the regional council.
- 17 (c) *State board rule.* -- The state board shall reexamine the powers and duties of the agencies
 18 in light of the changes in state level education policy that have occurred and shall establish
 19 multicounty regional education service agencies by rule, promulgated in accordance with the
 20 provisions of article three-b, chapter twenty-nine-a of this code.
- The rule shall contain all information necessary for the effective administration and operation of the agencies. In developing the rule, the state board may not delegate its Constitutional authority

- 1 for the general supervision of schools to the agencies, however, it may allow the agencies greater
- 2 latitude in the development and implementation of programs in the service areas outlined in
- 3 subsection (b) of this section with the exceptions of providing technical assistance to low performing
- 4 schools and school systems and providing high quality, targeted staff development designed to
- 5 enhance the performance and progress of students in state public education. These two areas
- 6 constitute the most important responsibilities for the agencies.
- 7 The rule establishing the agencies shall be promulgated before November 1, 2002 November
- $8 \frac{1,2015}{1,2015}$, and shall be consistent with the provisions of this section. It shall include, but is not limited
- 9 to, the following procedures:
- 10 (1) Providing for a uniform governance structure for the agencies containing at least these
- 11 elements:
- 12 (A) Selection by the state board of an executive director who shall be responsible for the
- 3 administration of his or her respective agency. The rule shall provide for the state board to consult
- 4 with the appropriate regional council during the selection process select the executive director only
- 15 upon the nomination of one or more candidates by the regional council of the agency. In case the
- 16 board refuses to select any of the candidates nominated, the regional council shall nominate others
- 17 and submit them to the board. All candidates nominated must meet the qualifications for the
- 18 position established by the state board. Nothing shall prohibit the timely employment of persons to
- 19 perform necessary duties;
- 20 (B) Development of a job description and qualifications for the position of executive director,
- 21 together with procedures for informing the public of position openings, and for taking and evaluating
- 22 applications, for making nominations for these positions, and for annually evaluating the

- 1 performance of persons employed as executive director. The state board shall consult with the
- 2 regional councils on the development of the job description, qualifications and procedures;
- 3 (C) Provisions for the annual performance evaluation of the executive director that provide
- 4 for one half of the evaluation rating to be determined by the regional council;
- 5 $\frac{C}{D}$ Provisions for the agencies to employ other staff, as necessary, with the approval of
- 6 the state board and upon the recommendation of the executive director: *Provided*, That prior to July
- 7 1, 2003, no person who is an employee of an agency on the effective date of this section may be
- 8 terminated or have his or her salary and benefit levels reduced as the sole result of the changes made
- 9 to this section or by state board rule;
- 10 (D) (E) Appointment by the county boards of a regional council in each agency area
- 1 consisting of representatives of county boards and county superintendents from within that area for
- 12 the purpose of advising, and assisting and informing the executive director in carrying out his or her
- 13 duties to achieve the purposes of this section and provide educational services to the county school
- 14 systems within the region. The state board may provide for membership on the regional council for
- 15 representatives from other agencies and institutions who have interest or expertise in the
- 16 development or implementation of regional education programs; and
- 17 (E) (F) Selection by the state superintendent of a representative from the state Department
- 18 of Education to serve on each regional council. These representatives shall meet with their
- 19 respective regional councils at least quarterly;
- 20 (2) Establishing statewide standards by the state board for service delivery by the agencies.
- 21 These standards may be revised annually and shall include, but are not limited to, programs and
- 22 services to fulfill the purposes set forth in subsection (b) of this section;

- 1 (3) Establishing procedures for developing and adopting an annual basic operating budget
- 2 for each agency and for other budgeting and accounting procedures as the state board may require;
- 3 (4) Establishing procedures clarifying that agencies may acquire and hold real property;
- 4 (5) Dividing the state into appropriate, contiguous geographical areas and designating an
- 5 agency to serve each area. The rule shall provide that each of the state's counties is contained within
- 6 a single service area and that all counties located within the boundaries of each agency, as
- 7 determined by the state board, shall be members of that agency; and
- 8 (6) Such other standards or procedures as the state board finds necessary or convenient.
- 9 (d) Regional services. -- In furtherance of the purposes provided for in this section, the state
- 10 board and the regional council of each agency shall continually explore possibilities for the delivery
- 1 of services on a regional basis which will facilitate equality in the education offerings among
- 12 counties in its service area, permit the delivery of high quality education programs at a lower per
- 13 student cost, strengthen the cost effectiveness of education funding resources, reduce administrative
- 4 and/or operational costs, including the consolidation of administrative, coordinating and other county
- 15 level functions into region level functions, and promote the efficient administration and operation
- 16 of the public school systems generally.
- 17 Technical, operational, programmatic or professional services are among the types of services
- 18 appropriate for delivery on a regional basis. Nothing in this section prohibits regional education
- 19 service agencies from cooperating, sharing or combining services or programs with each other, at
- 20 their discretion, to further the purposes of this section.
- 21 (e) Virtual education. -- The state board, in conjunction with the various agencies, shall
- 22 develop an effective model for the regional delivery of instruction in subjects where there exists low

- 1 student enrollment or a shortage of certified teachers or where the delivery method substantially
- 2 improves the quality of an instructional program. The model shall incorporate an interactive
- 3 electronic classroom approach to instruction. To the extent funds are appropriated or otherwise
- 4 available, county boards or regional education service agencies may adopt and utilize the model for
- 5 the delivery of the instruction.
- 6 (f) Computer information system. -- Each county board of education shall use the uniform
- 7 integrated regional computer statewide electronic information system recommended established by
- 8 the state board for data collection and reporting to the state Department of Education. County boards
- 9 of education shall bear the cost of and fully participate in the implementation of the system by using
- 10 one of the following methods:
- 11 (1) Acquiring necessary, compatible equipment to participate in the regional computer
- 12 information system; or
- 13 (2) Following receipt of a waiver from the state superintendent, operating a comparable
- 14 management information system at a lower cost which provides at least all uniform integrated
- 15 regional computer information system software modules and allows on-line, interactive access for
- 16 schools and the county board office onto the statewide communications network. All data formats
- 17 shall be the same as for the uniform integrated regional information system and will reside at the
- 18 regional computer.
- Any county granted a waiver shall receive periodic notification of any incompatibility or
- 20 deficiency in its system. No county shall expand any system either through the purchase of
- 21 additional software or hardware that does not advance the goals and implementation of the uniform
- 22 integrated regional computer information system as recommended by the state board.

- (g) Reports and evaluations. -- Each agency shall submit to the state superintendent on such date and in such form as specified in the rules adopted by the state board a report and evaluation of the technical assistance and other services provided and utilized by the schools within each respective region and their effectiveness. Additionally, any school may submit an evaluation of the services provided by the agency to the state superintendent at any time. This report shall include an evaluation of the agency program, suggestions on methods to improve utilization and suggestions on the development of new programs and the enhancement of existing programs. The reports and evaluations submitted pursuant to this subsection shall be submitted to the state board and shall be made available upon request to the standing committees on education of the West Virginia Senate and House of Delegates and to the secretary of education and the arts.
- 11 (h) *Funding sources*. -- An agency may receive and disburse funds from the state and federal governments, from member counties, or from gifts and grants.
- (i) *Employee expenses*. -- Notwithstanding any other provision of this code to the contrary, employees of agencies shall be reimbursed for travel, meals and lodging at the same rate as state employees under the travel management office of the Department of Administration.
- 16 A county board member may not be an employee of an agency.
- 17 (j) Meetings and compensation. --
- (1) Agencies shall hold at least one half of their regular meetings during hours other than
 those of a regular school day. The executive director of each agency shall attend at least one meeting
 of each of the member county boards of education each year to explain the agency's services, garner
 suggestions for program improvement and provide any other information as may be requested by the
 county board.

1	(2) Notwithstanding any other provision of this code to the contrary, county board memocrs
2	serving on regional councils may receive compensation at a rate not to exceed \$100 per meeting
3	attended, not to exceed fifteen meetings per year. County board members serving on regional
4	councils may be reimbursed for travel at the same rate as state employees under the rules of the travel
5	management office of the Department of Administration.
6	(k) Computer installation, maintenance and repair Agencies shall serve as the lead
7	agency for computer installation, maintenance and repair for the basic skills and SUCCESS
8	computer programs. Each agency shall submit a quarterly status report on turn around time for
9	computer installation, maintenance and repair to the state Superintendent of Schools who shall then
10	submit a report to the Legislative Oversight commission on education accountability. The status
11	report for turn around time for computer installation, maintenance and repair shall be based on the
12	following suggested time schedules:

20	Agencies also shall submit an audit report to the Legislative Oversight commission on
21	education accountability each year.
22	(1) Professional development Pursuant to the processes and provisions of section

- 1 twenty-three-a, article two, chapter eighteen of this code, each agency shall provide coordinated
- 2 professional development programs within its region to meet the professional development goals
- 3 established by the state board.

NOTE: The purpose of this bill is to expand the powers of the regional councils comprised of superintendents, county board members and others in the governance of regional education service agencies. The executive director must be selected from nominations of the regional council and the council determines one half of the director's annual performance evaluation. The role of the council also is expanded through required consultation on developing the job description and qualification for the director position and informing the director in carrying out his or her duties to achieve the purposes of the section and provide services to school systems within the region. Several references to computer programs and systems are updated and outdated and prescriptive provisions are removed.

Strike-throughs indicate existing language that would be removed, and underscoring indicates new language that would be added.
