NOTE**

A BILL to amend and reenact §11-16-6, §11-16-9 and §11-16-12 of the Code of West Virginia, 1931, as amended; and to amend said code by adding thereto a new section, designated §11-16-6a, all relating to brewer, resident brewer and brewpub licensing and operations; permitting licensed brewers and resident brewers to conduct a nonintoxicating beer sampling; permitting licensed brewers and resident brewers to conduct growler sales for off-premises consumption from their brewery premises located in the state; clarifying licensing and operational requirements for brewers, resident brewers and brewpubs; and removing brewpub bonding requirements.

Be it enacted by the Legislature of West Virginia:

That §11-16-6, §11-16-9 and §11-16-12 of the Code of West Virginia, 1931, as amended, be amended and reenacted; and that said code be amended by adding thereto a new section, designated §11-16-6a, all to read as follows:

ARTICLE 16. NONINTOXICATING BEER.

1 **§11-16-6. License in one capacity only; no connection between different licensees; when**
2 **brewer may act as distributor; credit and rebates proscribed; brewer, resident**
3 **brewer and brewpub requirements.**

4 (a) No person shall be licensed in more than one capacity under the terms of this article, and
5 there shall be no connection whatsoever between any retailer, distributor, resident brewer or brewer,
6 and no person shall be interested directly or indirectly through the ownership of corporate stock,
7 membership in a partnership, or in any other way in the business of a retailer, if such person is at the
8 same time interested in the business of a brewer, resident brewer or distributor. A resident brewer
9 may act as distributor in a limited capacity for his or her own product from such resident brewery,
10 place of manufacture or bottling, but a resident brewer is not permitted to act as a distributor as
11 defined in section three of this article: *Provided*, That nothing in this article may prevent a resident
12 brewer from using the services of licensed distributors as specified in this article. A resident brewer
13 or distributor may sell to a consumer for personal use and not for resale, draught beer in quantities
14 of one-eighth, one- fourth and one-half barrels in the original containers. A resident brewer owning
15 a brewpub may sell nonintoxicating beer or nonintoxicating craft beer produced by the brewpub in
16 a sealed growler, cans or bottles for personal consumption off of a licensed premise and not for
17 resale.

18 (b) It is unlawful for any brewer, resident brewer, manufacturer or distributor to assist any
19 retailer or for any retailer to accept assistance from any brewer, manufacturer or distributor any gifts
20 or loans or forbearance of money or property of any kind, nature or description, or other thing of
21 value or by the giving of any rebates or discounts of any kind whatsoever except as may be permitted
22 by rule, regulation, or order promulgated by the commissioner in accordance with this article.

1 Notwithstanding paragraphs (a) and (b) above, a brewpub may offer for retail sale
2 nonintoxicating beer or nonintoxicating craft beer so long as the sale of the nonintoxicating beer or
3 nonintoxicating craft beer is limited to the brewpub premises, except for up to ~~two~~ four growlers per
4 customer per day for personal consumption off of a licensed premises and not for resale, and further
5 a brewer or resident brewer who meets the requirements in section six-c of this article may offer for
6 retail sale up to four growlers of nonintoxicating beer or nonintoxicating craft beer per customer per
7 day for personal consumption off of a licensed premises and not for resale.

8 **§11-16-6a. Brewer and resident brewer license to manufacture, sell and provide**
9 **complimentary samples.**

10 (a) Sales of nonintoxicating beer. -- A licensed brewer or resident brewer with its principal
11 place of business and manufacture located in the State of West Virginia may offer only
12 nonintoxicating beer manufactured by the brewer or resident brewer at its principal place of business
13 and manufacture located in the State of West Virginia for retail sale to customers from the brewer
14 or resident brewer for consumption off the licensed premises only in the form of kegs, bottles, cans
15 or growlers: *Provided*, That a brewer or resident brewer with its principal place of business and
16 manufacture located in the State of West Virginia may offer complimentary samples no greater than
17 two ounces per patron per each nonintoxicating beer product brewed at the brewer or resident
18 brewer's principal place of business and manufacture located in the State of West Virginia, and in
19 any event, such sampling shall not exceed ten complimentary two ounce samples per any one patron
20 per day. Brewers or resident brewers who qualify for providing complimentary samples shall
21 provide complimentary food items for any patron consuming their nonintoxicating beer and shall
22 also verify using proper identification that each patron sampling nonintoxicating beer is twenty-one

1 years of age or over and that the patron is not visibly intoxicated. A brewer or resident brewer may
2 not sell, give or furnish nonintoxicating beer for consumption on the premises of the principal place
3 of business and manufacture located in the State of West Virginia except for the limited purpose of
4 complimentary samples permitted in this section.

5 (b) Retail sales. -- Every licensed brewer or resident brewer shall comply with the provisions
6 of this article as applicable to nonintoxicating beer retailers when conducting sales of
7 nonintoxicating beer and shall be subject to all applicable penalties in this article.

8 (c) Payment of taxes and fees. -- A licensed brewer or resident brewer operating under
9 subsection (a) shall pay all taxes and fees required of licensed nonintoxicating beer retailers, in
10 addition to any other taxes and fees required, and meet applicable licensing provisions as required
11 by this chapter and by rule of the commissioner.

12 (d) Advertising. -- A licensed brewer or resident brewer operating under subsection (a) may
13 advertise a particular brand or brands of nonintoxicating beer produced by it, and the price of the
14 nonintoxicating beer subject to state and federal requirements or restrictions. The advertisement
15 may not encourage intemperance.

16 (e) Limitations on licensees. -- No licensed resident brewer may produce more than
17 twenty-five thousand barrels per calendar year at the resident brewer's principal place of business
18 and manufacture located in the State of West Virginia. No more than one brewer or resident brewer
19 license may be issued to a single person or entity and no person may hold both a brewer and a
20 resident brewer license.

21 **§11-16-9. Amount of license tax; Class A and Class B retail dealers; purchase and sale of**
22 **nonintoxicating beer permitted; distributors; brewers; brewpubs.**

1 There is levied and imposed an annual license tax upon all dealers in and of nonintoxicating
2 beer as defined by this article, which license period begins on July 1, of each year and ends on June
3 30 of the following year, and, if granted for a less period, it shall be computed semiannually in
4 proportion to the remainder of the fiscal year as follows:

5 (1) Retail dealers shall be divided into two classes, Class A and Class B. In the case of a
6 Class A retail dealer the license fee is \$150 for each place of business; the license fee for social,
7 fraternal or private clubs not operating for profit, and having been in continuous operation for two
8 years or more immediately preceding the date of application, is \$150: *Provided*, That railroads
9 operating in this state may dispense nonintoxicating beer upon payment of an annual license tax of
10 \$10 for each dining, club or buffet car in which the beer is dispensed.

11 Class A licenses issued for railroad dining, club or buffet cars authorize the licensee to sell
12 nonintoxicating beer at retail for consumption only on the licensed premises where sold. All other
13 Class A licenses authorize the licensee to sell nonintoxicating beer at retail for consumption on or
14 off the licensed premises.

15 In the case of a Class B retailer, the fee for a Class B license authorizing the sale of both
16 chilled and unchilled beer is \$150 for each place of business. A Class B license authorizes the
17 licensee to sell nonintoxicating beer at retail in bottles, cans or other sealed containers only, and only
18 for consumption off the licensed premises. A Class B retailer may sell to a consumer, for personal
19 use and not for resale, draught beer in quantities of one-eighth, one-fourth and one-half barrels in the
20 original containers.

21 A Class B license may be issued only to the proprietor or owner of a grocery store. For the
22 purpose of this article the term "grocery store" means and includes any retail establishment

1 commonly known as a grocery store or delicatessen and caterer or party supply store, where food or
2 food products are sold for consumption off the premises, and means a separate and segregated
3 portion of any other retail store which is dedicated solely to the sale of food, food products and
4 supplies for the table for consumption off the premises. The commissioner may propose for
5 legislative approval legislative rules pursuant to chapter twenty-nine-a of this code necessary to carry
6 this provision into effect. Caterers or party supply stores are required to purchase the appropriate
7 licenses from the alcohol beverage control administration.

8 (2) ~~In the case of~~ For distributors, the license fee is \$1,000 for each place of business.

9 (3) ~~In the case of~~ For a resident brewer or a brewer with its principal place of business located
10 in this state and who produces: (i) 12,500 barrels or less of nonintoxicating beer or nonintoxicating
11 craft beer the license fee is \$1,500 for each place of manufacture; (ii) 12,501 barrels and up to 25,000
12 barrels of nonintoxicating beer or nonintoxicating craft beer the license fee is \$1,000 for each place
13 of manufacture; and (iii) more than 25,001 barrels of nonintoxicating beer or nonintoxicating craft
14 beer the license fee is \$1,500 for each place of manufacture. Brewers whose principal place of
15 business or manufacture is not located in this state shall pay a licensee fee of \$1,500 and are
16 exempted from the reporting requirements of subdivision (5) of this section.

17 (4) In the case of a brewpub, the license fee is ~~\$1,000~~ \$500 for each place of manufacture
18 where a brewer or resident brewer's brewpub is located.

19 (5) Upon filing an application or a renewal application and in order to determine a brewer
20 or resident brewer's license fee per subdivision (3) of this section, a brewer or resident brewer shall
21 provide the commissioner with an estimate of the number of nonintoxicating beer or nonintoxicating
22 craft beer barrels and gallons it will produce during the year based upon the production capacity of

1 the brewer's manufacturing facilities and prior year's production and sales volume of
2 nonintoxicating beer or nonintoxicating craft beer on a form provided by the commissioner.
3 Furthermore, every brewer or resident brewer shall file a final report on a form provided by the
4 commissioner as of June 30 of each year stating the actual volume of nonintoxicating beer or
5 nonintoxicating craft beer in barrels and gallons produced at its principal place of business and
6 manufacture during the prior year. In the instance where a brewer or resident brewer's actual
7 nonintoxicating beer or nonintoxicating craft beer production exceeded its estimated nonintoxicating
8 beer or nonintoxicating craft beer production amounts resulting in a higher license fee based on
9 subdivision (3) of this section, then a brewer or resident brewer shall remit the additional balance
10 owed for the license fee to the commissioner. Any brewer or resident brewer choosing not to file
11 or failing to file the reports required by this subdivision and who are not otherwise exempt from such
12 reporting requirement pursuant to subdivision (3) of this section shall pay a license fee of \$1,500 for
13 each place of manufacture.

14 **§11-16-12. Bond of brewer, distributor, and Class A retail dealer; action on bond of retail**
15 **dealer upon revocation of license; duty of prosecuting attorney.**

16 (a) In addition to furnishing the information required by this article, each brewer or
17 distributor applying for a license under this article shall furnish, as prerequisite to a license, a bond
18 with some solvent surety company as surety, to be approved by the commissioner, payable to the
19 State of West Virginia, conditioned for the payment of any and all additional taxes accruing during
20 the period of such license, and conditioned further for the faithful observance of the provisions of
21 this article, the rules, regulations and orders promulgated pursuant thereto and of any other laws of
22 the State of West Virginia generally relating to the sale, transportation, storage and distribution of

1 nonintoxicating beer, which said bonds shall be forfeited to the state upon the revocation of the
2 license of any such brewer or distributor. The amount of such bond, in the case of a resident brewer
3 ~~or brewpub~~, shall be not less than \$5,000, nor more than \$10,000, and in the case of a distributor,
4 not less than \$2,000, nor more than \$5,000 for each place of business licensed and conducted within
5 the state, the amount of such bond, between the minimum and maximum amounts, to be determined
6 in the discretion of the commissioner. There shall be no bond for a brewpub license as the license
7 privilege itself secures the payment of taxes and is subject to suspension and revocation for failure
8 to pay said taxes. In the case of brewers shipping nonintoxicating beer into the state, any brewer
9 must also furnish a bond in a penalty of not less than \$5,00 nor more than \$25,000 conditioned as
10 hereinabove in this subsection provided and any bond furnished pursuant hereto shall be forfeited
11 to the state in the full amount of said bond upon revocation of license of any such brewer or
12 distributor. Such money received by the state shall be credited to the state fund, general revenue.

13 (b) Each Class A retail dealer, in addition to furnishing the information required by this
14 article, shall furnish as prerequisite to obtaining a license, a bond with some solvent surety company
15 as surety, to be approved by the commissioner, payable to the State of West Virginia, in the amount
16 not less than \$500, nor more than \$1000, within the discretion of the commissioner. All such bonds
17 shall be conditioned for the faithful observance of the provisions of this article, the rules, regulations
18 and orders promulgated pursuant thereto and of any other laws of the State of West Virginia
19 generally relating to the distribution, sale and dispensing of nonintoxicating beer, and shall be
20 forfeited to the state in the full amount of said bond upon the revocation of the license of any such
21 retail dealer. Such money received by the state shall be credited to the state fund, general revenue.

22 (c) Upon the revocation of the license of any Class A retail dealer by the commissioner or by

1 any court of competent jurisdiction, the commissioner or the clerk of said court shall notify the
2 prosecuting attorney of the county wherein such retail dealer's place of business is located, or the
3 prosecuting attorney of the county wherein the licensee resides, of such revocation, and, upon receipt
4 of said notice, it shall be the duty of such prosecuting attorney forthwith to institute appropriate
5 proceedings for the collection of the full amount of said bond. Upon request of such prosecuting
6 attorney, the commissioner shall deliver the bond to him. Willful refusal without just cause therefor
7 by the prosecuting attorney to perform said duty hereby imposed shall subject him to removal from
8 office by the circuit court of the county for which said prosecuting attorney was elected upon proper
9 proceedings and proof in the manner provided by law.

NOTE: The purpose of this bill is to clarify licensing and operational requirements for brewers, resident brewers and brewpubs by: (1) permitting licensed brewers and resident brewers to conduct nonintoxicating beer sampling on their brewery premises within the State of West Virginia; (2) permitting a resident brewer to conduct growler sales for off-premises consumption from its brewery premises within the current resident brewer license for no additional expense, as is similarly permitted for distilleries, mini-distilleries, wineries and farm wineries (W. Va. Code §60-4-3); (3) having a sliding scale of licensure fees based on production volume and sales; (4) requiring production volume and sales reports to the commissioner; and (5) terminating the bond requirement for a brewpub license since the license may be suspended or revoked for failure to pay taxes.

In §11-16-6, §11-16-9, and §11-16-12, strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

Section 11-16-6a is new; therefore, it has been completely underscored.
