10	A BILL to amend and reenact §17A-3-14 of the Code of West Virginia, 1931, as amended, relating
11	to the authority of the Commissioner of Motor Vehicles to issue a special registration plate
12	for persons who are residents of this state and who have a family member diagnosed with
13	autism spectrum disorder who operates a motor vehicle in this state.
14	Be it enacted by the Legislature of West Virginia:
15	That §17A-3-14 of the Code of West Virginia, 1931, as amended, be amended and reenacted
16	to read as follows:
17	ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF
18	CERTIFICATES OF TITLE.
19	§17A-3-14. Registration plates generally; description of plates; issuance of special numbers
20	and plates; registration fees; special application fees; exemptions;
21	commissioner to promulgate forms; suspension and nonrenewal.
22	(a) The division upon registering a vehicle shall issue to the owner one registration plate for

1 a motorcycle, trailer, semitrailer or other motor vehicle.

- 2 (b) Registration plates issued by the division shall meet the following requirements:
- 3 (1) Every registration plate shall be of reflectorized material and have displayed upon it the
- 4 registration number assigned to the vehicle for which it is issued; the name of this state, which may
- 5 be abbreviated; and the year number for which it is issued or the date of expiration of the plate.
- 6 (2) Every registration plate and the required letters and numerals on the plate shall be of
- 7 sufficient size to be plainly readable from a distance of one hundred feet during daylight: *Provided*,
- 8 That the requirements of this subdivision shall not apply to the year number for which the plate is
- 9 issued or the date of expiration.
- 10 (3) Registration numbering for registration plates shall begin with number two.
- 11 (c) The division may not issue, permit to be issued or distribute any special registration plates
- 12 except as follows:
- 13 (1) The Governor shall be issued two registration plates, on one of which shall be imprinted
- 14 the numeral one and on the other the word one.
- 15 (2) State officials and judges may be issued special registration plates as follows:
- 16 (A) Upon appropriate application, the division shall issue to the Secretary of State, State
- 7 Superintendent of Schools, Auditor, Treasurer, Commissioner of Agriculture and the Attorney
- 18 General, the members of both houses of the Legislature, including the elected officials of both
- 19 houses of the Legislature, the justices of the Supreme Court of Appeals of West Virginia, the
- 20 representatives and senators of the state in the Congress of the United States, the judges of the West
- 21 Virginia circuit courts, active and retired on senior status, the judges of the United States district
- 22 courts for the State of West Virginia and the judges of the United States Court of Appeals for the

- 1 fourth circuit, if any of the judges are residents of West Virginia, a special registration plate for a
- 2 Class A motor vehicle and a special registration plate for a Class G motorcycle owned by the official
- 3 or his or her spouse: *Provided*, That the division may issue a Class A special registration plate for
- 4 each vehicle titled to the official and a Class G special registration plate for each motorcycle titled
- 5 to the official.
- 6 (B) Each plate issued pursuant to this subdivision shall bear any combination of letters and
- 7 numbers not to exceed an amount determined by the commissioner and a designation of the office.
- 8 Each plate shall supersede the regular numbered plate assigned to the official or his or her spouse
- 9 during the official's term of office and while the motor vehicle is owned by the official or his or her
- 10 spouse.
- 11 (C) The division shall charge an annual fee of \$15 for every registration plate issued pursuant
- 12 to this subdivision, which is in addition to all other fees required by this chapter.
- 13 (3) The division may issue members of the National Guard forces special registration plates
- 14 as follows:
- 15 (A) Upon receipt of an application on a form prescribed by the division and receipt of written
- 16 evidence from the chief executive officer of the Army National Guard or Air National Guard, as
- 7 appropriate, or the commanding officer of any United States Armed Forces reserve unit that the
- 18 applicant is a member thereof, the division shall issue to any member of the National Guard of this
- 19 state or a member of any reserve unit of the United States Armed Forces a special registration plate
- designed by the commissioner for any number of Class A motor vehicles owned by the member.
- 21 Upon presentation of written evidence of retirement status, retired members of this state's Army or
- 22 Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are

- 1 eligible to purchase the special registration plate issued pursuant to this subdivision.
- 2 (B) The division shall charge an initial application fee of \$10 for each special registration
- 3 plate issued pursuant to this subdivision, which is in addition to all other fees required by this
- 4 chapter. Except as otherwise provided herein, effective July 1, 2007, all fees currently held in the
- 5 special revolving fund used in the administration of this section and all fees collected by the division
- 6 shall be deposited in the State Road Fund.
- 7 (C) A surviving spouse may continue to use his or her deceased spouse's National Guard
- 8 forces license plate until the surviving spouse dies, remarries or does not renew the license plate.
- 9 (4) Specially arranged registration plates may be issued as follows:
- 10 (A) Upon appropriate application, any owner of a motor vehicle subject to Class A
- 1 registration, or a motorcycle subject to Class G registration, as defined by this article, may request
- 12 that the division issue a registration plate bearing specially arranged letters or numbers with the
- 13 maximum number of letters or numbers to be determined by the commissioner. The division shall
- 14 attempt to comply with the request wherever possible.
- 15 (B) The commissioner shall propose rules for legislative approval in accordance with the
- 16 provisions of chapter twenty-nine-a of this code regarding the orderly distribution of the plates:
- 17 Provided, That for purposes of this subdivision, the registration plates requested and issued shall
- 18 include all plates bearing the numbers two through two thousand.
- 19 (C) An annual fee of \$15 shall be charged for each special registration plate issued pursuant
- 20 to this subdivision, which is in addition to all other fees required by this chapter.
- 21 (5) The division may issue honorably discharged veterans special registration plates as
- 22 follows:

- 1 (A) Upon appropriate application, the division shall issue to any honorably discharged 2 veteran of any branch of the armed services of the United States a special registration plate for any
- e veteran of any branch of the armed services of the United States a special registration plate for any
- 3 number of vehicles titled in the name of the qualified applicant with an insignia designed by the
- 4 Commissioner of the Division of Motor Vehicles.
- 5 (B) The division shall charge a special initial application fee of \$10 in addition to all other
- 6 fees required by law. This special fee is to compensate the Division of Motor Vehicles for additional
- 7 costs and services required in the issuing of the special registration. All fees collected by the
- 8 division shall be deposited in the State Road Fund: *Provided*, That nothing in this section may be
- construed to exempt any veteran from any other provision of this chapter.
- 10 (C) A surviving spouse may continue to use his or her deceased spouse's honorably
- 1 discharged veterans license plate until the surviving spouse dies, remarries or does not renew the
- 12 license plate.
- 13 (6) The division may issue disabled veterans special registration plates as follows:
- (A) Upon appropriate application, the division shall issue to any disabled veteran who is
- 5 exempt from the payment of registration fees under the provisions of this chapter a registration plate
- 16 for a vehicle titled in the name of the qualified applicant which bears the letters "DV" in red and also
- 17 the regular identification numerals in red.
- (B) A surviving spouse may continue to use his or her deceased spouse's disabled veterans
- 19 license plate until the surviving spouse dies, remarries or does not renew the license plate.
- 20 (C) A qualified disabled veteran may obtain a second disabled veterans license plate as
- 21 described in this section for use on a passenger vehicle titled in the name of the qualified applicant.
- 22 The division shall charge a one-time fee of \$10 to be deposited into the State Road Fund, in addition

- 1 to all other fees required by this chapter, for the second plate.
- 2 (7) The division may issue recipients of the distinguished Purple Heart medal special 3 registration plates as follows:
- (A) Upon appropriate application, there shall be issued to any armed service person holding the distinguished Purple Heart medal for persons wounded in combat a registration plate for a vehicle titled in the name of the qualified applicant bearing letters or numbers. The registration plate shall be designed by the Commissioner of Motor Vehicles and shall denote that those individuals who are granted this special registration plate are recipients of the Purple Heart. All letterings shall be in purple where practical.
- 10 (B) Registration plates issued pursuant to this subdivision are exempt from all registration 11 fees otherwise required by the provisions of this chapter.
- 12 (C) A surviving spouse may continue to use his or her deceased spouse's Purple Heart medal 13 license plate until the surviving spouse dies, remarries or does not renew the license plate.
- (D) A recipient of the Purple Heart medal may obtain a second Purple Heart medal license plate as described in this section for use on a passenger vehicle titled in the name of the qualified applicant. The division shall charge a one-time fee of \$10 to be deposited into the State Road Fund, in addition to all other fees required by this chapter, for the second plate.
- 18 (8) The division may issue survivors of the attack on Pearl Harbor special registration plates 19 as follows:
- 20 (A) Upon appropriate application, the owner of a motor vehicle who was enlisted in any 21 branch of the armed services that participated in and survived the attack on Pearl Harbor on 22 December 7, 1941, the division shall issue a special registration plate for a vehicle titled in the name

- 1 of the qualified applicant. The registration plate shall be designed by the Commissioner of Motor2 Vehicles.
- 3 (B) Registration plates issued pursuant to this subdivision are exempt from the payment of 4 all registration fees otherwise required by the provisions of this chapter.
- 5 (C) A surviving spouse may continue to use his or her deceased spouse's survivors of the 6 attack on Pearl Harbor license plate until the surviving spouse dies, remarries or does not renew the 7 license plate.
- 8 (D) A survivor of the attack on Pearl Harbor may obtain a second survivors of the attack on Pearl Harbor license plate as described in this section for use on a passenger vehicle titled in the 0 name of the qualified applicant. The division shall charge a one-time fee of \$10 to be deposited into 1 the State Road Fund, in addition to all other fees required by this chapter, for the second plate.
- (9) The division may issue special registration plates to nonprofit charitable and educational
 organizations authorized under prior enactment of this subdivision as follows:
- (A) Approved nonprofit charitable and educational organizations previously authorized under
 the prior enactment of this subdivision may accept and collect applications for special registration
 plates from owners of Class A motor vehicles together with a special annual fee of \$15, which is in
 addition to all other fees required by this chapter. The applications and fees shall be submitted to
 the Division of Motor Vehicles with the request that the division issue a registration plate bearing
 a combination of letters or numbers with the organizations' logo or emblem, with the maximum
 number of letters or numbers to be determined by the commissioner.
- 21 (B) The commissioner shall propose rules for legislative approval in accordance with the 22 provisions of article three, chapter twenty-nine-a of this code regarding the procedures for and

1 approval of special registration plates issued pursuant to this subdivision.

- 2 (C) The commissioner shall set an appropriate fee to defray the administrative costs 3 associated with designing and manufacturing special registration plates for a nonprofit charitable or 4 educational organization. The nonprofit charitable or educational organization shall collect this fee 5 and forward it to the division for deposit in the State Road Fund. The nonprofit charitable or
- 7 (10) The division may issue specified emergency or volunteer registration plates as follows:

educational organization may also collect a fee for marketing the special registration plates.

- (A) Any owner of a motor vehicle who is a resident of the State of West Virginia and who is a certified paramedic or emergency medical technician, a member of a paid fire department, a member of the state Fire Commission, the State Fire Marshal, the State Fire Marshal's assistants, the State Fire Administrator and voluntary rescue squad members may apply for a special license plate for any number of Class A vehicles titled in the name of the qualified applicant which bears the insignia of the profession, group or commission. Any insignia shall be designed by the commissioner. License plates issued pursuant to this subdivision shall bear the requested insignia in addition to the registration number issued to the applicant pursuant to the provisions of this article.
- (B) Each application submitted pursuant to this subdivision shall be accompanied by an affidavit signed by the fire chief or department head of the applicant stating that the applicant is justified in having a registration with the requested insignia; proof of compliance with all laws of this state regarding registration and licensure of motor vehicles; and payment of all required fees.
- 20 (C) Each application submitted pursuant to this subdivision shall be accompanied by payment 21 of a special initial application fee of \$10, which is in addition to any other registration or license fee 22 required by this chapter. All special fees shall be collected by the division and deposited into the

1 state Road Fund.

- 2 (11) The division may issue specified certified firefighter registration plates as follows:
- 3 (A) Any owner of a motor vehicle who is a resident of the State of West Virginia and who 4 is a certified firefighter may apply for a special license plate which bears the insignia of the
- 5 profession, for any number of Class A vehicles titled in the name of the qualified applicant. Any
- 6 insignia shall be designed by the commissioner. License plates issued pursuant to this subdivision
- 7 shall bear the requested insignia pursuant to the provisions of this article. Upon presentation of
- 8 written evidence of certification as a certified firefighter, certified firefighters are eligible to purchase
- 9 the special registration plate issued pursuant to this subdivision.
- 10 (B) Each application submitted pursuant to this subdivision shall be accompanied by an
 - 1 affidavit stating that the applicant is justified in having a registration with the requested insignia;
- 12 proof of compliance with all laws of this state regarding registration and licensure of motor vehicles;
- 13 and payment of all required fees. The firefighter certification department, section or division of the
- 14 West Virginia University fire service extension shall notify the commissioner in writing immediately
- 15 when a firefighter loses his or her certification. If a firefighter loses his or her certification, the
- 16 commissioner may not issue him or her a license plate under this subsection.
- 17 (C) Each application submitted pursuant to this subdivision shall be accompanied by payment
- 18 of a special initial application fee of \$10, which is in addition to any other registration or license fee
- 19 required by this chapter. All special fees shall be collected by the division and deposited into the
- 20 State Road Fund.
- 21 (12) The division may issue special scenic registration plates as follows:
- 22 (A) Upon appropriate application, the commissioner shall issue a special registration plate

- 1 displaying a scenic design of West Virginia which displays the words "Wild Wonderful" as a slogan.
- 2 (B) The division shall charge a special one-time initial application fee of \$10 in addition to
- 3 all other fees required by this chapter. All initial application fees collected by the division shall be
- 4 deposited into the State Road Fund.
- 5 (13) The division may issue honorably discharged Marine Corps league members special 6 registration plates as follows:
- 7 (A) Upon appropriate application, the division shall issue to any honorably discharged
- 8 Marine Corps league member a special registration plate for any number of vehicles titled in the
- 9 name of the qualified applicant with an insignia designed by the Commissioner of the Division of
- 10 Motor Vehicles.
- 11 (B) The division may charge a special one-time initial application fee of \$10 in addition to
- 12 all other fees required by this chapter. This special fee is to compensate the Division of Motor
- 13 Vehicles for additional costs and services required in the issuing of the special registration and shall
- 14 be collected by the division and deposited in the State Road Fund: *Provided*, That nothing in this
- 15 section may be construed to exempt any veteran from any other provision of this chapter.
- 16 (C) A surviving spouse may continue to use his or her deceased spouse's honorably
- 17 discharged Marine Corps League license plate until the surviving spouse dies, remarries or does not
- 18 renew the license plate.
- 19 (14) The division may issue military organization registration plates as follows:
- 20 (A) The division may issue a special registration plate for the members of any military
- 21 organization chartered by the United States Congress upon receipt of a guarantee from the
- 22 organization of a minimum of one hundred applicants. The insignia on the plate shall be designed

- 1 by the commissioner.
- 2 (B) Upon appropriate application, the division may issue members of the chartered
- 3 organization in good standing, as determined by the governing body of the chartered organization,
- 4 a special registration plate for any number of vehicles titled in the name of the qualified applicant.
- 5 (C) The division shall charge a special one-time initial application fee of \$10 for each special
- 6 license plate in addition to all other fees required by this chapter. All initial application fees
- 7 collected by the division shall be deposited into the State Road Fund: *Provided*, That nothing in this
- 8 section may be construed to exempt any veteran from any other provision of this chapter.
- 9 (D) A surviving spouse may continue to use his or her deceased spouse's military
- 10 organization registration plate until the surviving spouse dies, remarries or does not renew the special
- 11 military organization registration plate.
- 12 (15) The division may issue special nongame wildlife registration plates and special wildlife
- 13 registration plates as follows:
- 14 (A) Upon appropriate application, the division shall issue a special registration plate
- 15 displaying a species of West Virginia wildlife which shall display a species of wildlife native to West
- 16 Virginia as prescribed and designated by the commissioner and the Director of the Division of
- 17 Natural Resources.
- 18 (B) The division shall charge an annual fee of \$15 for each special nongame wildlife
- 19 registration plate and each special wildlife registration plate in addition to all other fees required by
- 20 this chapter. All annual fees collected for nongame wildlife registration plates and wildlife
- 21 registration plates shall be deposited in a special revenue account designated the Nongame Wildlife
- 22 Fund and credited to the Division of Natural Resources.

- 1 (C) The division shall charge a special one-time initial application fee of \$10 in addition to 2 all other fees required by this chapter. All initial application fees collected by the division shall be
- 3 deposited in the State Road Fund.
- 4 (16) The division may issue members of the Silver Haired Legislature special registration 5 plates as follows:
- 6 (A) Upon appropriate application, the division shall issue to any person who is a duly 7 qualified member of the Silver Haired Legislature a specialized registration plate which bears 8 recognition of the applicant as a member of the Silver Haired Legislature.
- 9 (B) A qualified member of the Silver Haired Legislature may obtain one registration plate 10 described in this subdivision for use on a passenger vehicle titled in the name of the qualified 11 applicant. The division shall charge an annual fee of \$15, in addition to all other fees required by 12 this chapter, for the plate. All annual fees collected by the division shall be deposited in the State 13 Road Fund.
- 14 (17) Upon appropriate application, the commissioner shall issue to a classic motor vehicle 15 or classic motorcycle as defined in section three-a, article ten of this chapter, a special registration 16 plate designed by the commissioner. An annual fee of \$15, in addition to all other fees required by 17 this chapter, shall be charged for each classic registration plate.
- (18) Honorably discharged veterans may be issued special registration plates for motorcycles
 subject to Class G registration as follows:
- 20 (A) Upon appropriate application, there shall be issued to any honorably discharged veteran 21 of any branch of the armed services of the United States a special registration plate for any number 22 of motorcycles subject to Class G registration titled in the name of the qualified applicant with an

- 1 insignia designed by the Commissioner of the Division of Motor Vehicles.
- 2 (B) A special initial application fee of \$10 shall be charged in addition to all other fees
- 3 required by law. This special fee is to be collected by the division and deposited in the State Road
- 4 Fund: Provided, That nothing in this section may be construed to exempt any veteran from any other
- 5 provision of this chapter.
- 6 (C) A surviving spouse may continue to use his or her deceased spouse's honorably
- 7 discharged veterans license plate until the surviving spouse dies, remarries or does not renew the
- 8 license plate.
- 9 (19) Racing theme special registration plates:
- 10 (A) The division may issue a series of special registration plates displaying National
- 11 Association for Stock Car Auto Racing themes.
- 12 (B) An annual fee of \$25 shall be charged for each special racing theme registration plate in
- 13 addition to all other fees required by this chapter. All annual fees collected for each special racing
- 14 theme registration plate shall be deposited into the State Road Fund.
- 15 (C) A special application fee of \$10 shall be charged at the time of initial application as well
- 16 as upon application for any duplicate or replacement registration plate, in addition to all other fees
- 17 required by this chapter. All application fees shall be deposited into the State Road Fund.
- 18 (20) The division may issue recipients of the Navy Cross, Distinguished Service Cross,
- 19 Distinguished Flying Cross, Air Force Cross, Bronze Star, Silver Star or Air Medal special
- 20 registration plates as follows:
- 21 (A) Upon appropriate application, the division shall issue to any recipient of the Navy Cross,
- 22 Distinguished Service Cross, Distinguished Flying Cross, Air Force Cross, Silver Star, Bronze Star

- 1 or Air Medal, a registration plate for any number of vehicles titled in the name of the qualified
- 2 applicant bearing letters or numbers. A separate registration plate shall be designed by the
- 3 Commissioner of Motor Vehicles for each award that denotes that those individuals who are granted
- 4 this special registration plate are recipients of the Navy Cross, Distinguished Service Cross,
- 5 Distinguished Flying Cross, Air Force Cross, Silver Star or Bronze Star, or Air Medal as applicable.
- 6 (B) The division shall charge a special initial application fee of \$10 in addition to all other
- 7 fees required by law. This special fee shall be collected by the division and deposited in the State
- 8 Road Fund: *Provided*, That nothing in this section exempts the applicant for a special registration
- 9 plate under this subdivision from any other provision of this chapter.
- 10 (C) A surviving spouse may continue to use his or her deceased spouse's Navy Cross,
- 11 Distinguished Service Cross, Distinguished Flying Cross, Air Force Cross, Silver Star, Bronze Star
- 12 or Air Medal special registration plate until the surviving spouse dies, remarries or does not renew
- 13 the special registration plate.
- 14 (21) The division may issue honorably discharged veterans special registration plates as
- 15 follows:
- 16 (A) Upon appropriate application, the division shall issue to any honorably discharged
- 17 veteran of any branch of the armed services of the United States with verifiable service during World
- 18 War II, the Korean War, the Vietnam War, the Persian Gulf War or the War Against Terrorism a
- 19 special registration plate for any number of vehicles titled in the name of the qualified applicant with
- an insignia designed by the commissioner denoting service in the applicable conflict.
- 21 (B) The division shall charge a special one-time initial application fee of \$10 in addition to
- 22 all other fees required by law. This special fee shall be collected by the division and deposited in

- 1 the State Road Fund: Provided, That nothing contained in this section may be construed to exempt
- 2 any veteran from any other provision of this chapter.
- 3 (C) A surviving spouse may continue to use his or her deceased spouse's honorably
- 4 discharged veterans registration plate until the surviving spouse dies, remarries or does not renew
- 5 the special registration plate.
- 6 (22) The division may issue special volunteer firefighter registration plates as follows:
- 7 (A) Any owner of a motor vehicle who is a resident of West Virginia and who is a volunteer
- 8 firefighter may apply for a special license plate for any Class A vehicle titled in the name of the
- 9 qualified applicant which bears the insignia of the profession in white letters on a red background.
- 10 The insignia shall be designed by the commissioner and shall contain a fireman's helmet insignia
- 11 on the left side of the license plate.
- 12 (B) Each application submitted pursuant to this subdivision shall be accompanied by an
 - affidavit signed by the applicant's fire chief, stating that the applicant is a volunteer firefighter and
- 14 justified in having a registration plate with the requested insignia. The applicant must comply with
- 15 all other laws of this state regarding registration and licensure of motor vehicles and must pay all
- 16 required fees.
- 17 (C) Each application submitted pursuant to this subdivision shall be accompanied by payment
- 18 of a special one-time initial application fee of \$10, which is in addition to any other registration or
- 19 license fee required by this chapter. All application fees shall be deposited into the State Road Fund.
- 20 (23) The division may issue special registration plates which reflect patriotic themes,
- 21 including the display of any United States symbol, icon, phrase or expression which evokes patriotic
- 22 pride or recognition.

- 1 (A) Upon appropriate application, the division shall issue to an applicant a registration plate
- 2 of the applicant's choice, displaying a patriotic theme as provided in this subdivision, for a vehicle
- 3 titled in the name of the applicant. A series of registration plates displaying patriotic themes shall
- 4 be designed by the Commissioner of Motor Vehicles for distribution to applicants.
- 5 (B) The division shall charge a special one-time initial application fee of \$10 in addition to
- 6 all other fees required by law. This special fee shall be collected by the division and deposited in
- 7 the State Road Fund.
- 8 (24) Special license plates bearing the American flag and the logo "9/11/01".
- 9 (A) Upon appropriate application, the division shall issue special registration plates which 10 shall display the American flag and the logo "9/11/01".
- 11 (B) An annual fee of \$15 shall be charged for each plate in addition to all other fees required 12 by this chapter.
- 13 (C) A special application fee of \$10 shall be charged at the time of initial application as well 14 as upon application for any duplicate or replacement registration plate, in addition to all other fees 15 required by this chapter. All application fees shall be deposited into the State Road Fund.
- 16 (25) The division may issue a special registration plate celebrating the centennial of the 4-H 17 youth development movement and honoring the Future Farmers of America organization as follows:
- (A) Upon appropriate application, the division may issue a special registration plate depicting
 the symbol of the 4-H organization which represents the head, heart, hands and health as well as the
 symbol of the Future Farmers of America organization which represents a cross section of an ear of
- 21 corn for any number of vehicles titled in the name of the qualified applicant.
- 22 (B) The division shall charge a special initial application fee of \$10 in addition to all other

- 1 fees required by law. This special fee shall be collected by the division and deposited in the State
- 2 Road Fund.
- 3 (C) The division shall charge an annual fee of \$15 for each special 4-H Future Farmers of
- 4 America registration plate in addition to all other fees required by this chapter.
- 5 (26) The division may issue special registration plates to educators in the state's elementary

- 22 for class A and class G motor vehicles to members of an organization for which a special registration

- 1 plate has not been issued pursuant to any other subdivision in this subsection prior to January 1,
- 2 2010, in accordance with the provisions of this subdivision.
- 3 (A) An organization desiring to create a special registration plate must comply with the
- 4 following requirements to be eligible to apply for the creation and issuance of a special registration
- 5 plate:
- 6 (i) The organization must be a nonprofit organization organized and existing under Section
- 7 501(c)(3) of Title 26 of the Internal Revenue Code and based, headquartered or have a chapter in
- 8 West Virginia;
- 9 (ii) The organization may be organized for, but may not be restricted to, social, civic, higher
- 10 education or entertainment purposes;
- 11 (iii) The organization may not be a political party and may not have been created or exist
- 12 primarily to promote a specific political or social belief, as determined by the commissioner in his
- 13 or her sole discretion;
- (iv) The organization may not have as its primary purpose the promotion of any specific faith,
- 15 religion, religious belief or antireligion;
- (v) The name of the organization may not be the name of a special product or brand name,
- 17 and may not be construed, as determined by the commissioner, as promoting a product or brand
- 18 name; and
- (vi) The organization's lettering, logo, image or message to be placed on the registration
- 20 plate, if created, may not be obscene, offensive or objectionable as determined by the commissioner
- 21 in his or her sole discretion.
- 22 (B) Beginning July 1, 2010, an organization requesting the creation and issuance of a special

- 1 registration plate may make application with the division. The application shall include sufficient
- 2 information, as determined by the commissioner, to determine whether the special registration plate
- 3 requested and the organization making the application meet all of the requirements set forth in this
- 4 subdivision (60) (61). The application shall also include a proposed design, including lettering, logo,
- 5 image or message to be placed on the registration plate. The commissioner shall notify the
- 6 organization of the commissioner's approval or disapproval of the application.
- 7 (C) (i) The commissioner may not begin the design or production of any license plates
- 8 authorized and approved pursuant to this subdivision (60) (61), subsection (c) of this section until
- 9 the organization which applied for the special registration plate has collected and submitted
- 10 collectively to the division applications completed by at least two hundred fifty persons and
- 11 collectively deposited with the division all fees necessary to cover the first year's basic registration,
- 12 one-time design and manufacturing costs and to cover the first year additional annual fee for all of
- 13 the applications submitted.
- 14 (ii) If the organization fails to submit the required number of applications and fees within six
- 15 months of the effective date of the approval of the application for the plate by the commissioner, the
- 16 plate will not be produced until a new application is submitted and is approved by the commissioner:
- 17 Provided, That an organization that is unsuccessful in obtaining the minimum number of
- 18 applications may not make a new application for a special plate until at least two years have passed
- 19 since the approval of the previous application of the organization.
- 20 (D) The division shall charge a special initial application fee of \$25 for each special license
- 21 plate in addition to all other fees required by law. This special fee shall be collected by the division
- 22 and deposited in the State Road Fund.

- 1 (E) The division shall charge an annual fee of \$15 for each special registration plate in 2 addition to all other fees required by this chapter.
- 3 (F) Upon appropriate application, the division may issue a special registration plate designed 4 by the commissioner in consultation with the organization for any number of vehicles titled in the 5 name of a qualified registration plate applicant. Persons desiring the special registration plate shall 6 offer sufficient proof of membership in the organization.
- 7 (G) The commissioner shall discontinue the issuance or renewal of the registration of any 8 special plate issued pursuant to this subdivision (60) (61) if:
- 9 (i) The number of valid registrations for the specialty plate falls below two hundred fifty 10 plates for at least twelve consecutive months; or
- 11 (ii) The organization no longer exists or no longer meets the requirements of this 12 subdivision.
- (d) The minimum number of applications required prior to design and production of a special
 license plate shall be as follows:
- (1) The commissioner may not begin the design or production of any license plates for which eligibility is based on membership or affiliation with a particular private organization until at least one hundred persons complete an application and deposit with the organization a check to cover the first year's basic registration, one-time design and manufacturing costs and to cover the first year additional annual fee. If the organization fails to submit the required number of applications with attached checks within six months of the effective date of the original authorizing legislation, the plate will not be produced and will require legislative reauthorization: *Provided*, That an organization or group that is unsuccessful in obtaining the minimum number of applications may not

- 1 request reconsideration of a special plate until at least two years have passed since the effective date
- 2 of the original authorization: *Provided, however*, That the provisions of this subdivision (1) are not
- 3 applicable to the issuance of plates authorized pursuant to subdivision (60) (61), subsection (c) of
- 4 this section.
- 5 (2) The commissioner may not begin the design or production of any license plates
- 6 authorized by this section for which membership or affiliation with a particular organization is not
- 7 required until at least two hundred fifty registrants complete an application and deposit a fee with
- 8 the division to cover the first year's basic registration fee, one-time design and manufacturing fee
- 9 and additional annual fee if applicable. If the commissioner fails to receive the required number of
- 10 applications within six months of the effective date of the original authorizing legislation, the plate
- 11 will not be produced and will require legislative reauthorization: *Provided*, That if the minimum
- 12 number of applications is not satisfied within the six months of the effective date of the original
- 13 authorizing legislation, a person may not request reconsideration of a special plate until at least two
- 14 years have passed since the effective date of the original authorization.
- (e) (1) Nothing in this section requires a charge for a free prisoner of war license plate or a
- 16 free recipient of the Congressional Medal of Honor license plate for a vehicle titled in the name of
- 17 the qualified applicant as authorized by other provisions of this code.
- 18 (2) A surviving spouse may continue to use his or her deceased spouse's prisoner of war
- 19 license plate or Congressional Medal of Honor license plate until the surviving spouse dies,
- 20 remarries or does not renew the license plate.
- 21 (3) Qualified former prisoners of war and recipients of the Congressional Medal of Honor
- 22 may obtain a second special registration plate for use on a passenger vehicle titled in the name of the

- 1 qualified applicant. The division shall charge a one-time fee of \$10 to be deposited into the State
- 2 Road Fund, in addition to all other fees required by this chapter, for the second special plate.
- 3 (f) The division may issue special ten-year registration plates as follows:
- (1) The commissioner may issue or renew for a period of no more than ten years any registration plate exempted from registration fees pursuant to any provision of this code or any restricted use antique motor vehicle license plate authorized by section three-a, article ten of this chapter: *Provided,* That the provisions of this subsection do not apply to any person who has had a special registration suspended for failure to maintain motor vehicle liability insurance as required by section three, article two-a, chapter seventeen-d of this code or failure to pay personal property taxes as required by section three-a of this article.
- 12 (2) An initial nonrefundable fee shall be charged for each special registration plate issued 12 pursuant to this subsection, which is the total amount of fees required by section fifteen, article ten 13 of this chapter, section three, article three of this chapter or section three-a, article ten of this chapter 14 for the period requested.
- 15 (g) The provisions of this section may not be construed to exempt any registrant from 16 maintaining motor vehicle liability insurance as required by section three, article two-a, chapter 17 seventeen-d of this code or from paying personal property taxes on any motor vehicle as required by 18 section three-a of this article.
- 19 (h) The commissioner may, in his or her discretion, issue a registration plate of reflectorized 20 material suitable for permanent use on motor vehicles, trailers and semitrailers, together with 21 appropriate devices to be attached to the registration to indicate the year for which the vehicles have 22 been properly registered or the date of expiration of the registration. The design and expiration of

1 the plates shall be determined by the commissioner. The commissioner shall, whenever possible and

2 cost effective, implement the latest technology in the design, production and issuance of registration

3 plates, indices of registration renewal and vehicle ownership documents, including, but not limited

4 to, offering Internet renewal of vehicle registration and the use of bar codes for instant identification

5 of vehicles by scanning equipment to promote the efficient and effective coordination and

6 communication of data for improving highway safety, aiding law enforcement and enhancing

7 revenue collection.

8 (i) Any license plate issued or renewed pursuant to this chapter which is paid for by a check

9 that is returned for nonsufficient funds is void without further notice to the applicant. The applicant

10 may not reinstate the registration until the returned check is paid by the applicant in cash, money

11 order or certified check and all applicable fees assessed as a result thereof have been paid.

NOTE: The purpose of this bill is to authorize the Commissioner of Motor Vehicles to issue a special registration plate for persons who are residents of this state and who have a family member diagnosed with autism spectrum disorder who operates a motor vehicle in this state.
