Effective July 1, 2015, as an additional supplement to other retirement allowances provided,

each annuitant who retired before July 1, 1995, shall, upon written application, in addition to such

approved annuities an increased amount, payable monthly, which is the product of his or her present

retirement allowance multiplied by five percent; effective July 1, 2016, upon application, an

increased amount, payable monthly, which is the product of his or her present retirement allowance

multiplied by five percent; and, effective July 1, 2017, upon application, an increased amount,

payable monthly, which is the product of his or her present retirement allowance multiplied by five

percent.

NOTE: The purpose of this bill is to give retired state personnel and retired teachers a five percent a year increase in retirement benefits for the next three consecutive years.

These sections are new; therefore, it has been completely underscored.
