6 §48-16-102. Definitions.

- 7 As used in this article:
- 8 (1) "Child" means an individual, whether over or under the age of majority, who is or is
- 9 alleged to be owed a duty of support by the individual's parent or who is or is alleged to be the
- 10 beneficiary of a support order directed to the parent.
- 11 (2) "Child support order" means a support order for a child, including a child who has
- 12 attained the age of majority under the law of the issuing state or foreign country.
- 13 (3) "Convention" means the Convention on the International Recovery of Child Support and
- 14 Other Forms of Family Maintenance, concluded at The Hague on November 23, 2007."
- 15 (3) (4) "Duty of support" means an obligation imposed or imposable by law to provide
- 16 support for a child, spouse or former spouse, including an unsatisfied obligation to provide support.
- 17 (5) "Foreign country" means a country, including a political subdivision thereof, other than
- 18 the United States, that authorizes the issuance of support orders and:
- 19 (A) Which has been declared under the law of the United States to be a foreign reciprocating
- 20 country;
- 21 (B) Which has established a reciprocal arrangement for child support with this state;
- 22 (C) Which has enacted a law or established procedures for the issuance and enforcement of

- 1 support orders which are substantially similar to the procedures under this article; or
- 2 (D) In which the convention is in force with respect to the United States.
- 3 (6) "Foreign support order" means a support order of a foreign tribunal.

- 13 (1) The individual is personally served with notice within this state;
- 14 (2) The individual submits to the jurisdiction of this state by consent <u>in a record</u>, by entering
- 15 a general appearance, or by filing a responsive document having the effect of waiving any contest
- 16 to personal jurisdiction;
- 17 (3) The individual resided with the child in this state;
- 18 (4) The individual resided in this state and provided prenatal expenses or support for the 19 child;

10 §48-16-203. Initiating and responding tribunal of state.

Under this article, a tribunal of this state may serve as an initiating tribunal to forward proceedings to <u>a tribunal of</u> another state, and as a responding tribunal for proceedings initiated in another state <u>or a foreign country.</u>

14 §48-16-204. Simultaneous proceedings.

- (a) A tribunal of this state may exercise jurisdiction to establish a support order if the petition
 or comparable pleading is filed after a petition or comparable pleading is filed in another state or a
 foreign country only if:
- (1) The petition or comparable pleading in this state is filed before the expiration of the time allowed in the other state or the foreign country for filing a responsive pleading challenging the exercise of jurisdiction by the other state or the foreign country:
- 21 (2) The contesting party timely challenges the exercise of jurisdiction in the other state or 22 foreign country; and

- 1 (3) If relevant, this state is the home state of the child.
- 2 (b) A tribunal of this state may not exercise jurisdiction to establish a support order if the

- 5 (1) The petition or comparable pleading in the other state <u>or foreign country</u> is filed before

10 §48-16-205. Continuing, exclusive jurisdiction to modify child support order.

- 11 (a) A tribunal of this state that has issued a <u>child</u> support order consistent with the law of this
- 12 state has and shall exercise continuing, exclusive jurisdiction to modify its child support order if the
- 13 order is the controlling order and:
- 14 (1) At the time of the filing of a request for modification this state is the residence of the
- 15 obligor, the individual obligee or the child for whose benefit the support order is issued; or
- 16 (2) Even if this state is not the residence of the obligor, the individual obligee, or the child
- 17 for whose benefit the support order is issued, the parties consent in a record or in open court that the
- 18 tribunal of this state may continue to exercise jurisdiction to modify its order.
- 19 (b) A tribunal of this state that has issued a child support order consistent with the law of this
- 20 state may not exercise continuing, exclusive jurisdiction to modify the order if:
- 21 (1) All of the parties who are individuals file consent in a record with the tribunal of this state
- 22 that a tribunal of another state that has jurisdiction over at least one of the parties who is an

13 §48-16-206. Continuing jurisdiction to enforce child support order.

- 14 (a) A tribunal of this state that has issued a child support order consistent with the law of this
- 15 state may serve as an initiating tribunal to request a tribunal of another state to enforce:
- 16 (1) The order if the order is the controlling order and has not been modified by a tribunal of
- 17 another state that assumed jurisdiction pursuant to the uniform interstate family support act; or
- 18 (2) A money judgment for arrears of support and interest on the order accrued before a
- 19 determination that an order of a tribunal of another state is the controlling order.
- 20 (b) A tribunal of this state having continuing jurisdiction over a support order may act as a
- 21 responding tribunal to enforce the order.
- 22 §48-16-207. Determination of controlling child support order.

- 1 (a) If a proceeding is brought under this article and only one tribunal has issued a child 2 support order, the order of that tribunal is controlling controls and must be so recognized.
- 3 (b) If a proceeding is brought under this article, and two or more child support orders have
 4 been issued by tribunals of this state, or another state or a foreign country with regard to the same
 5 obligor and same child, a tribunal of this state having personal jurisdiction over both the obligor and
 6 individual obligee shall apply the following rules and by order shall determine which order controls
 7 and must be recognized.
- 8 (1) If only one of the tribunals would have continuing, exclusive jurisdiction under this 9 article, the order of that tribunal is controlling controls and must be so recognized.
- 10 (2) If more than one of the tribunals would have continuing, exclusive jurisdiction under this 11 article:
- 12 (A) An order issued by a tribunal in the current home state of the child but controls; or
- 13 (B) If an order has not been issued in the current home state of the child, the order most 14 recently issued controls.
- (3) If none of the tribunals would have continuing, exclusive jurisdiction under this article,the tribunal of this state shall issue a child support order which controls.
- (c) If two or more child support orders have been issued for the same obligor and same child,
 upon request of a party who is an individual or that is a support enforcement agency, a tribunal of
 this state having personal jurisdiction over both the obligor and the obligee who is an individual shall
 determine which order controls under subsection (b) of this section. The request may be filed with
 a registration for enforcement or registration for modification pursuant to article 6 [§48-6-101 et
 seq.] part VI or [§48-16-501 et seq.] may be filed as a separate proceeding.

- 1 (d) A request to determine which is the controlling order must be accompanied by a copy of
- every child support order in effect and the applicable record of payments. The requesting party shall

- In responding to registrations or petitions for enforcement of two or more child support orders in effect at the same time with regard to the same obligor and different individual obligees, at least one of which was issued by a tribunal of another state or a foreign country, a tribunal of this state shall enforce those orders in the same manner as if the orders had been issued by a tribunal of this state.
- **8 §48-16-209.** Credit for payments.
- A tribunal of this state shall credit amounts collected for a particular period pursuant to any child support order against the amounts owed for the same period under any other child support order for support of the same child issued by a tribunal of this state, or a nother state, or a foreign country.

 2 §48-16-210. Application of article to nonresident subject to personal jurisdiction.
- A tribunal of this state exercising personal jurisdiction over a nonresident in a proceeding under this article, under other law of this state relating to a support order, or recognizing a <u>foreign</u> support order of a <u>foreign country or political subdivision on the basis of comity</u> may receive evidence from <u>another outside this</u> state pursuant to section 316 [§48-16-316], communication with a tribunal or <u>another outside this</u> state pursuant to section 317 [§48-16-317], and obtain discovery through a tribunal <u>of another outside this</u> state pursuant to section 318 [§48-16-318]. - 22 §48-16-211. Continuing, exclusive jurisdiction to modify spousal support order.

- 1 (a) A tribunal of this state issuing a spousal support order consistent with the law of this state
- 2 has continuing, exclusive jurisdiction to modify the spousal support order throughout the existence
- 3 of the support obligation.
- 4 (b) A tribunal of this state may not modify a spousal support order issued by a tribunal of
- 5 another state <u>or a foreign country</u> having continuing, exclusive jurisdiction over that order under the
- 6 law of that state or foreign country.
- 7 (c) A tribunal of this state that has continuing, exclusive jurisdiction over a spousal support

- 20 §48-16-304. Duties of initiating tribunal.
- 21 (a) Upon the filing of a petition authorized by this article, an initiating tribunal of this state
- 22 shall forward the petition and its accompanying documents:

- 1 (1) To the responding tribunal or appropriate support enforcement agency in the responding 2 state; or
- (2) If the identity of the responding tribunal is unknown, to the state information agency of
 the responding state with a request that they be forwarded to the appropriate tribunal and that receipt
 be acknowledged.
- 6 (b) If requested by the responding tribunal, a tribunal of this state shall issue a certificate or

- (f) This article does not create or negate a relationship of attorney and client or other fiduciary relationship between a support enforcement agency or the attorney for the agency and the individual being assisted by the agency.

- 2 This article applies to proceedings begun on or after the effective date of the amendments to
- 3 this article enacted during the 2015 regular session of the West Virginia Legislature, to establish a
- 4 support order or determine parentage of a child or to register, recognize, enforce, or modify a prior
- 5 support order, determination, or agreement, whenever issued or entered.

6 §48-16-903. Severability.

- 7 The provisions of this article originally enacted during the regular session of the Legislature
- 8 in the year one thousand nine hundred ninety-seven were effective on the first day of January, one

NOTE: The bill amends the Uniform Interstate Family Support Act (UIFSA) to modify the current version of UIFSA's international provisions to comport with the obligations of the United States under the 2007 Hague Convention on Maintenance. Federal legislation enacted in 2014 requires all states to enact the 2008 UIFSA Amendments as a condition of continuing to receive federal funds for state child support programs. Failure to enact these amendments during the 2015 legislative session may result in a state's loss of important federal funding.
