10	A BILL to amend and reenact the Code of West Virginia, 1931, as amended, by adding thereto a new	
11	article, designated §9-4F-1, §9-4F-2, §9-4F-3 and §9-4F-4, all relating to the creation of	
12	managed care programs for the aged, blind, disabled and long term services and support for	
13	Medicaid populations.	
14	Be it enacted by the Legislature of West Virginia:	
15	That the Code of West Virginia, 1931, as amended, be amended and reenacted by adding	
16	thereto a new article, designated §9-4F-1, §9-4F-2, §9-4F-3 and §9-4F-4, all to read as follows:	
17	ARTICLE 4F. AGED, BLIND, DISABLED AND LONG TERM SERVICES AND	
18	SUPPORT MANAGED CARE ACT.	
19	§9-4F-1. Legislative Purpose.	
20	It is the purpose of the Legislature in enacting this section to implement coordinated,	
21	capitated long-term care programs for those Medicaid beneficiaries who are: (1) Aged, blind or	
22	disabled or; (2) chronically ill or have disabilities including those who need health and long-term	

- 1 care services and supports, such as home care or adult day care. These programs will reduce the cost
- 2 to the state of administering Medicaid, insert certainty into Medicaid budgeting, and allow eligible
- 3 Medicaid beneficiaries to have an organized system of care as well as the ability to stay in their
- 4 homes and communities as long as possible, and delay the transition to institutional care. These
- 5 plans coordinate, arrange and pay for Medicaid physical and behavioral health and Long Term
- 6 Services and provide choice and flexibility in obtaining needed services from one organized system
- 7 at a lower cost than under Medicaid fee-for-service.

8 §9-4F-2. Definitions.

- 9 <u>(a) "Eligible Medicaid beneficiaries" means the following:</u>
- 10 (1) Frail elders (over the age of sixty) who are receiving 1915(c) Medicaid waiver services;
- 11 (2) Adults with physical disabilities (ages eighteen through sixty-four) who are receiving
- 12 Medicaid home and community based waiver services;
- (3) Children (ages three through seventeen) with physical disabilities who are receiving
- 14 Medicaid home and community based waiver services;

- 2 (c) "Aged, blind and disabled" means that population defined in 42 U.S.C. §1382, et seq.
- 3 §9-4F-3. Long Term Services and Support Program.
- 4 (a) The secretary shall establish a capitated Medicaid long-term services and supports
- 5 coordinated care program. The secretary shall make payments for long-term care, including home
- 6 and community-based services, using a managed care model.
- 7 (b) The secretary shall submit, if necessary, applications to the United States Department of
- 8 Health and Human Services for waivers of federal Medicaid requirements that would otherwise be
- 9 violated in the implementation of the program, and shall consolidate existing home and community
- 10 based waivers where appropriate. The secretary shall ensure that all participants are members of a
