Senate Bill No. 122

(By Senators Snyder, Facemire and Romano)

[Introduced January 14, 2015; referred to the Committee on Military; and then to the Committee on Government Organization.]

A BILL to amend and reenact §5A-3-37 of the Code of West Virginia, 1931, as amended; and to amend and reenact §6-13-1 of said code, all relating to disabled veteran's preference eligibility in hiring for state civil service jobs; resident vendor bidding on state contracts; and redefining "disabled veteran" to meet federal definition.

Be it enacted by the Legislature of West Virginia:

That §5A-3-37 of the Code of West Virginia, 1931, as amended, be amended and reenacted; and that §6-13-1 of said code be amended and reenacted, all to read as follows:

CHAPTER 5A. DEPARTMENT OF ADMINISTRATION.

ARTICLE 3. PURCHASING DIVISION.

§5A-3-37. Preference for resident vendors; preference for vendors employing state residents; preference for veteran residents; preference for disabled veteran residents; exceptions.

(a) Effective beginning July 1, 1992, In any instance that a purchase of commodities or
 printing by the director or by a state department is required under the provisions of this article to be

1	made upon competitive bids, the successful bid shall be determined as provided in this section.
2	(b) The Secretary of the Department of Revenue Administration shall promulgate any
3	propose rules for legislative approval pursuant to the provisions of article three, chapter twenty-nine-
4	<u>a of this code</u> necessary to:
5	(1) (1) Determine that vendors have met the residence residency requirements described in
6	this section;
7	$\frac{(ii)}{(2)}$ Establish the procedure for vendors to certify the residency requirements at the time
8	of submitting their bids;
9	(iii) (3) Establish a procedure to audit bids which make a claim for preference permitted by
10	this section and to reject noncomplying bids; and
11	(iv) otherwise (4) Accomplish the objectives of this section.
12	(c) In prescribing the rules, the secretary shall use a strict construction of the residence
13	residency requirements set forth in this section.
14	(d) For purposes of this section, a successful bid shall be determined and accepted as follows:
15	(1) From an individual resident vendor who has resided in West Virginia continuously for
16	the four years immediately preceding the date on which the bid is submitted or from a partnership,
17	association, corporation resident vendor, or from a corporation nonresident vendor which has an
18	affiliate or subsidiary which employs a minimum of one hundred state residents and which has
19	maintained its headquarters or principal place of business within West Virginia continuously for four
20	years immediately preceding the date on which the bid is submitted, if the vendor's bid does not
21	exceed the lowest qualified bid from a nonresident vendor by more than two and one-half percent
22	of the latter bid, and if the vendor has made written claim for the preference at the time the bid was

1 submitted: Provided, That for purposes of this subdivision, any partnership, association or 2 corporation resident vendor of this state which does not meet the requirements of this subdivision solely because of the continuous four-year residence residency requirement shall be considered to 3 meet the requirement if at least eighty percent of the ownership interest of the resident vendor is held 4 by another individual, partnership, association or corporation resident vendor who otherwise meets 5 6 the requirements of this subdivision, including the continuous four-year residency requirement: 7 Provided, however, That the Secretary of the Department of Revenue Administration shall 8 promulgate rules relating to attribution of ownership among several resident vendors for purposes 9 of determining the eighty percent ownership requirement; or 10 (2) From a resident vendor if, for purposes of producing or distributing the commodities or completing the project which is the subject of the vendor's bid and continuously over the entire term 11 of the project, on average at least seventy-five percent of the vendor's employees are residents of 12 13 West Virginia who have resided in the state continuously for the two immediately preceding years, 14 and the vendor's bid does not exceed the lowest qualified bid from a nonresident vendor by more

15 than two and one-half percent of the latter bid, and if the vendor has certified the residency 16 requirements of this subdivision and made written claim for the preference, at the time the bid was 17 submitted; or

(3) From a nonresident vendor which employs a minimum of one hundred state residents or a nonresident vendor which has an affiliate or subsidiary which maintains its headquarters or principal place of business within West Virginia and which employs a minimum of one hundred state residents if, for purposes of producing or distributing the commodities or completing the project which is the subject of the vendor's bid and continuously over the entire term of the project, on

average at least seventy-five percent of the vendor's employees or the vendor's affiliate's or subsidiary's employees are residents of West Virginia who have resided in the state continuously for the two immediately preceding years and the vendor's bid does not exceed the lowest qualified bid from a nonresident vendor by more than two and one-half percent of the latter bid, and if the vendor has certified the residency requirements of this subdivision and made written claim for the preference at the time the bid was submitted; or

(4) From a vendor who meets either the requirements of both subdivisions (1) and (2) of this
subsection, or subdivisions (1) and (3) of this subsection, if the bid does not exceed the lowest
qualified bid from a nonresident vendor by more than five percent of the latter bid, and if the vendor
has certified the residency requirements above and made written claim for the preference at the time
the bid was submitted; or

(5) From an individual resident vendor who is a veteran of the United States armed forces, the reserve or the National Guard and has resided in West Virginia continuously for the four years immediately preceding the date on which the bid is submitted, if the vendor's bid does not exceed the lowest qualified bid from a nonresident vendor by more than three and one-half percent of the latter bid, and if the vendor has made written claim for the preference at the time the bid was submitted; or

18 (6) From an individual resident vendor who is a disabled veteran, as defined in subsection 19 (e) of this section, and has resided in West Virginia continuously for the four years immediately 20 preceding the date on which the bid is submitted, if the vendor's bid does not exceed the lowest 21 qualified bid from a nonresident vendor by more than four and one-half percent of the latter bid, and 22 if the vendor has made written claim for the preference at the time the bid was submitted; or

1	(6) (7) From a resident vendor who is a veteran of the United States armed forces, the reserve
2	or the National Guard if, for purposes of producing or distributing the commodities or completing
3	the project which is the subject of the vendor's bid and continuously over the entire term of the
4	project, on average at least seventy-five percent of the vendor's employees are residents of West
5	Virginia who have resided in the state continuously for the two immediately preceding years and the
6	vendor's bid does not exceed the lowest qualified bid from a nonresident vendor by more than three
7	and one-half percent of the latter bid, and if the vendor has certified the residency requirements of
8	this subdivision and made written claim for the preference, at the time the bid was submitted; or
9	(8) From a resident vendor who is a disabled veteran, as defined in subsection (e) of this
10	section, if, for purposes of producing or distributing the commodities or completing the project
11	which is the subject of the vendor's bid and continuously over the entire term of the project, on
12	average at least seventy-five percent of the vendor's employees are residents of West Virginia who
13	have resided in the state continuously for the two immediately preceding years and the vendor's bid
14	does not exceed the lowest qualified bid from a nonresident vendor by more than four and one-half
15	percent of the latter bid, and if the vendor has certified the residency requirements of this subdivision
16	and made written claim for the preference, at the time the bid was submitted; or
17	(7) (9) Notwithstanding any provisions of subdivision (1), (2), (3), (4), (5), or (6), (7) or (8)
18	of this subsection to the contrary, if any nonresident vendor that is bidding on the purchase of
19	commodities or printing by the director or by a state department is also certified as a small, women
20	or minority-owned business pursuant to section fifty-nine of this article, the nonresident vendor shall
21	be provided the same preference made available to any resident vendor under the provisions of this

22 subsection.

1	(e) For purposes of this section, "disabled veteran" means an individual who has served on
2	active duty in the armed forces, has been separated therefrom under honorable conditions, and has
3	established the present existence of a service-connected disability or is receiving compensation,
4	disability retirement benefits, or pension because of a public statute administered by the Department
5	of Veterans Affairs or a military department.
6	(b) (f) If the Secretary of the Department of Revenue Administration determines under any
7	audit procedure that a vendor who received a preference under this section fails to continue to meet
8	the requirements for the preference at any time during the term of the project for which the
9	preference was received, the secretary may:
10	(1) Reject the vendor's bid; or
11	(2) Assess a penalty against the vendor of not more than five percent of the vendor's bid on
12	the project.
13	(c) (g) Political subdivisions of the state including county boards of education may grant the
14

5	(e) (i) If any provision or clause of this section or application thereof to any person or
6	circumstance is held invalid, the invalidity shall not affect other provisions or applications of this
7	section which can be given effect without the invalid provision or application, and to this end the
8	provisions of this section are severable.
9	(f) (j) This section may be cited as the Jobs for West Virginians Act of 1990.

5	(c) For the purpose purposes of this article, a person is defined as a "veteran" if he or she
6	fulfills the requirements of one of the following subsections subdivisions:
7	(a) (1) Served on active duty anytime between December 7, 1941, and July 1, 1955.
8	However, any person who was a reservist called to active duty between February 1, 1955, and
9	October 14, 1976, must meet condition (b) stated below subdivision (2) of this subsection;
10	(b) (2) Served on active duty anytime between July 2, 1955, and October 14, 1976, or a
11	reservist called to active duty between February 1, 1955, and October 14, 1976, and who served for
12	more than one hundred eighty days;
13	(c) (3) Entered on active duty between October 15, 1976, and September 7, 1980, or a
14	reservist who entered on active duty between October 15, 1976, and October 13, 1982, and received
15	a campaign badge or expeditionary medal; or is a disabled veteran; or
16	(d) (4) Enlisted in the armed forces after September 7, 1980, or entered active duty other than
17	by enlistment on or after October 14, 1982, and (1) completed twenty-four months of continuous
18	active duty or the full period called or ordered to active duty, or was discharged under 10 U. S. C.
19	§1171, or for hardship under 10 U. S. C. §1173, and received or was entitled to receive a campaign
20	badge or expeditionary medal. or (2) Is a disabled veteran.
21	(d) To receive veteran preference, separation from active duty must have been under
22	honorable conditions. This includes honorable and general discharges. A clemency discharge does

not meet the requirements of the Veteran Preference Act. Active duty for training in the military
 reserve and National Guard programs is not considered active duty for purposes of veteran
 preference.

4 (e) These awards shall be made for the benefit and preference in appointment of all veterans

5 who have heretofore or who shall hereafter take examinations, but shall not operate to the detriment

6 of any person heretofore appointed to a position in a department or agency.

(NOTE: The purpose of this bill is to adopt the federal definition for disabled veterans' preference eligibility in hiring for state civil service jobs and resident vendor bidding on state contracts.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.)
