WEST VIRGINIA REGIONAL JAIL AND CORRECTIONAL FACILITY 17 **AUTHORITY.** 18 §31-20-27. Employees of Regional Jail Authority; priority of hiring; civil service exemption. 19 (a) Notwithstanding any provision of this Code to the contrary, the Authority, when hiring 20 employees to complete the approved staffing plan of a regional jail shall do so at a salary and with benefits consistent with the approved plan of compensation of the Division of Personnel, created 22 under section five [§29-6-5], article six, chapter twenty-nine of this Code. All persons employed

- 1 under this subsection shall be placed in the civil service system as covered employees. On and after
- 2 the first day of January, two thousand eight, July 1, 2015, the Executive Director of the Regional Jail
- 3 and Correctional Facility Authority and all employees of the Regional Jail and Correctional Facility
- 4 Authority within the Office of the Executive Director and all regional jail administrators are exempt
- 5 from coverage under the classified service.
- 6 (b) Persons employed under the provisions of this subsection shall be employed at a salary
- and with benefits consistent with the approved plan of compensation of the Division of Personnel,
- 8 created under section five [§29-6-5], article six, chapter twenty-nine of this Code. All persons
- 9 employed under this subsection shall also be covered by the policies and procedures of the West
- 10 Virginia Public Employees Grievance Board created under section one [§6C-3-1], article three,
- 11 chapter six-c of this Code of the governing board of the Regional Jail and Correctional Facility
- 12 Authority, created under section three, article twenty, chapter thirty-one of this code.
- (c) Not withstanding the provisions of section ten [§29-6-10], article six, chapter twenty-nine
- 4 of this Code, and any rule promulgated thereunder, On, and after July 1, 2007, any person applying
- 5 for employment with the Regional Jail and Correctional Facility Authority shall be hired based on
- 6 passage of the correctional officer examination without regard to his or her position on the
- 17 correctional officer register: and shall be placed in the civil service system as covered employees:
- 18 Provided, That no such person shall be hired before an otherwise qualified person on a preference
- 19 register.

NOTE: The purpose of this bill is to exempt Regional Jail and Correctional Authority

Employees from the classified service and authorize the Authority to set salaries.
