1	AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2	balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3	2016, to the Department of Health and Human Resources, Consolidated Medical Service
4	Fund, fund 8723, fiscal year 2016, organization 0506, and the Department of Health and
5	Human Resources, Human Rights Commission, fund 8725, fiscal year 2016, organization
6	0510, and the Department of Health and Human Resources, Division of Human Services,
7	fund 8722, fiscal year 2016, organization 0511, by supplementing and amending the
8	appropriations for the fiscal year ending June 30, 2016.
9	Whereas, The Governor has established the availability of federal funds for expenditure
10	in the fiscal year ending June 30, 2016 which is hereby appropriated by the terms of this
