[Passed March 7, 2016; in effect from passage.]

1 AN ACT supplementing, amending, and increasing items of the existing appropriations from the
2 State Road Fund to the Department of Transportation, Division of Highways, fund 9017,
3 fiscal year 2016, organization 0803, for the fiscal year ending June 30, 2016.

4 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
5 dated January 13, 2016, which included a statement of the State Road Fund setting forth therein
6 the cash balances and investments as of July 1, 2015, and further included the estimate of
7 revenues for the fiscal year 2016, less regular appropriations for the fiscal year 2016; and

8 Whereas, It appears from the statement of the State Road Fund there now remains an
9 unappropriated balance in the State Treasury which is available for appropriation during the fiscal
10 year ending June 30, 2016; *therefore*

Be it enacted by the Legislature of West Virginia:

1 That the items of the total appropriations for the fiscal year ending June 30, 2016, to fund
2 9017, fiscal year 2016, organization 0803, be supplemented and amended by increasing existing
3 items of appropriation as follows:
