1 A BILL to amend and reenact §33-26-2, §33-26-3, §33-26-4, §33-26-5, §33-26-8, §33-26-9, §33-
2 26-10, §33-26-11, §33-26-12, §33-26-13, §33-26-14 and §33-26-18 of the Code of West
3 Virginia, 1931, as amended, all relating to West Virginia Insurance Guaranty Association
4 Act; modifying scope and construction of act; adding and amending definitions; clarifying
5 and adding powers, duties and rights of association; modifying provisions concerning
6 effect of paid claims, exhaustion of coverage, prevention of insolvencies and stay of
7 proceedings; changing due date of annual financial report; limiting covered claims;
8 expanding association's right to recover and be reimbursed; providing for confidentiality
9 of financial information; and exempting certain reports and recommendations from
10 Freedom of Information Act.

Be it enacted by the Legislature of West Virginia:

1 That §33-26-2, §33-26-3, §33-26-4, §33-26-5, §33-26-8, §33-26-9, §33-26-10, §33-26-11,
2 §33-26-12, §33-26-13, §33-26-14 and §33-26-18 of the Code of West Virginia, 1931, as amended,
3 be amended and reenacted, all to read as follows:

ARTICLE 26. WEST VIRGINIA GUARANTY ASSOCIATION ACT.

§33-26-2. Purpose.

1 The purpose of this article is to provide a mechanism for the payment of covered claims
2 under certain insurance policies to avoid excessive delay in payment and, to ~~avoid~~ the extent
3 provided in this article, minimize financial loss to claimants or policyholders because of the
4 insolvency of an insurer ~~to assist in the detection and prevention of insurer insolvencies~~ and to
5 ~~provide~~ permit an association to assess the cost of ~~such~~ this protection among insurers.

§33-26-3. Scope.

1 This article applies to all kinds of direct insurance ~~except life, title, surety, disability, credit,~~
2 ~~mortgage guaranty and ocean marine insurance.~~ but shall not be applicable to the following:

1 (1) Life, annuity, health or disability insurance;

2 (2) Mortgage guaranty, financial guaranty or other forms of insurance offering protection
3 against investment risks;

4 (3) Fidelity or surety bonds, or any other bonding obligations;

5 (4) Credit insurance, vendors' single interest insurance or collateral protection insurance
6 or any similar insurance protecting the interests of a creditor arising out of a creditor-debtor
7 transaction;

8 (5) Insurance of warranties or service contracts including insurance that provides for the
9 repair, replacement or service of goods or property, indemnification for repair, replacement or
10 service for the operational or structural failure of the goods or property due to a defect in materials,
11 workmanship or normal wear and tear, or provides reimbursement for the liability incurred by the
12 issuer of agreements or service contracts that provide such benefits;

13 (6) Title insurance;

14 (7) Ocean marine insurance;

15 (8) Any transaction or combination of transactions between a person, including affiliates
16 of such person, and an insurer, including affiliates of the insurer, which involves the transfer of
17 investment or credit risk unaccompanied by transfer of insurance risk; or

18 (9) Any insurance provided by or guaranteed by a government entity or agency.

§33-26-4. Construction.

1 This article shall be ~~liberally~~ construed to effect the purpose under section two of this article
2 which shall constitute an aid and guide to interpretation.

§33-26-5. Definitions.

1 As used in this article:

2 (1) "Account" means any one of the three accounts created by section six of this article.

3 (2) "Affiliate" means a person who directly or indirectly, through one or more
4 intermediaries, controls, is controlled by or is under common control with another person on

5 December 31 of the year immediately preceding the date the insurer becomes an insolvent
6 insurer.

7 (3) "Affiliate of the insolvent insurer" means a person who directly or indirectly, through
8 one or more intermediaries, controls, is controlled by or is under common control with an insolvent
9 insurer on December 31 of the year prior to the date the insurer becomes an insolvent insurer.

10 ~~(2)~~ (4) "Association" means the West Virginia Insurance Guaranty Association created
11 under section six of this article.

12 (5) "Association similar to the association" means any guaranty association, security fund
13 or other insolvency mechanism that affords protection similar to that of the association. The term
14 shall also include any property and casualty insolvency mechanism that obtains assessments or
15 other contributions from insurers on a preinsolvency basis.

16 (6) "Claimant" means any insured making a first party claim or any person instituting a
17 liability claim, provided that no person who is an affiliate of the insolvent insurer may be a claimant.

18 ~~(3)~~ (7) "Commissioner" means the Insurance Commissioner of West Virginia.

19 (8) "Control" means the possession, direct or indirect, of the power to direct or cause the
20 direction of the management and policies of a person, whether through the ownership of voting
21 securities, by contract other than a commercial contract for goods or nonmanagement services,
22 or otherwise, unless the power is the result of an official position with or corporate office held by
23 the person. Control shall be presumed to exist if a person, directly or indirectly, owns, controls,
24 holds with the power to vote, or holds proxies representing, ten percent or more of the voting
25 securities of any other person. This presumption may be rebutted by a showing that control does
26 not exist in fact.

27 ~~(4) "Covered claim" means an unpaid claim, including one for unearned premiums other~~
28 ~~than retrospective premiums or other premiums subject to adjustment after the date of liquidation,~~
29 ~~which arises out of and is within the coverage of an insurance policy to which this article applies~~
30 ~~and which policy is in force at the time of the occurrence giving rise to the unpaid claims if the~~

31 ~~insurer issuing the policy becomes an insolvent insurer after the effective date of this article and~~
32 ~~the claimant or insured is a resident of this state at the time of the insured occurrence, or the~~
33 ~~property from which the claim arises is permanently located in this state. "Covered claim" does~~
34 ~~not include: (i) Any amount in excess of the applicable limits of coverage provided by an insurance~~
35 ~~policy to which this article applies; nor (ii) any amount due any reinsurer, insurer, insurance pool,~~
36 ~~or underwriting association, as subrogation recoveries or otherwise from an insolvent insurer or~~
37 ~~the insured of an insolvent insurer to the extent of coverage under the insured's policy.~~

38 (9) (A) "Covered claim" means an unpaid claim, including one for unearned premiums,
39 submitted by a claimant, which arises out of and is within the coverage and is subject to the
40 applicable limits of an insurance policy to which this article applies issued by an insurer, if such
41 insurer becomes an insolvent insurer after the effective date of this article and:

42 (i) The claimant or insured is a resident of this state at the time of the insured event:
43 Provided, That for entities other than an individual, the residence of a claimant, insured or
44 policyholder is the state in which its principal place of business is located at the time of the insured
45 event; or

46 (ii) The claim is a first party claim for damage to property with a permanent location in this
47 state.

48 (B) "Covered claim" shall not include:

49 (i) Any amount awarded as punitive or exemplary damages;

50 (ii) Any amount sought as a return of premium under any retrospective rating plan;

51 (iii) Any amount due any reinsurer, insurer, insurance pool, underwriting association,
52 health maintenance organization, hospital plan corporation, professional health service
53 corporation or self-insurer as subrogation recoveries, reinsurance recoveries, contribution,
54 indemnification or otherwise. No such claim for any amount due any reinsurer, insurer, insurance
55 pool, underwriting association, health maintenance organization, hospital plan corporation or self-
56 insurer may be asserted against a person insured under a policy issued by an insolvent insurer

57 other than to the extent such claim exceeds the association obligation limitations set forth in
58 section eight of this article;

59 (iv) Any first party claim by an insured whose net worth exceeds \$25 million on December
60 31 of the year next preceding the date the insurer becomes an insolvent insurer: *Provided*, That
61 an insured's net worth on such date shall be deemed to include the aggregate net worth of the
62 insured and all of its subsidiaries and affiliates as calculated on a consolidated basis: *Provided*,
63 *however*, That this exclusion shall not apply to any claim for benefits under a workers'
64 compensation insurance policy required by chapter twenty-three of this code;

65 (v) Any third party claim relating to a policy of an insured whose net worth exceeds \$25
66 million on December 31 of the year next preceding the date the insurer becomes an insolvent
67 insurer: *Provided*, That an insured's net worth on such date shall be deemed to include the
68 aggregate net worth of the insured and all of its subsidiaries and affiliates as calculated on a
69 consolidated basis: *Provided, however*, That this exclusion shall not apply to:

70 (I) Third party claims against the insured where the insured has applied for or consented
71 to the appointment of a receiver, trustee or liquidator for all or a substantial part of its assets, filed
72 a voluntary petition in bankruptcy, filed a petition or an answer seeking a reorganization or
73 arrangement with creditors or to take advantage of any insolvency law, or if an order, judgment
74 or decree is entered by a court of competent jurisdiction, on the application of a creditor,
75 adjudicating the insured bankrupt or insolvent or approving a petition seeking reorganization of
76 the insured or of all or substantial part of its assets; or

77 (II) Any claim for benefits under a workers' compensation insurance policy required by
78 chapter twenty-three of this code;

79 (vi) Any claim that would otherwise be a covered claim but is an obligation to, or on behalf
80 of a, person who has a net worth greater than that allowed by the insurance guaranty association
81 law of the state of residence of the claimant at the time specified by such law and which
82 association has denied coverage to that claimant on that basis: *Provided*, That this exclusion shall

83 not apply to any claim for benefits under a workers' compensation insurance policy required by
84 chapter twenty-three of this code;

85 (vii) Any first party claims by an insured which is an affiliate of the insolvent insurer;

86 (viii) Any fee or other amount relating to goods or services sought by, or on behalf of, any
87 attorney or other provider of goods or services retained by the insolvent insurer or an insured prior
88 to the date it was determined to be insolvent;

89 (ix) Any fee or other amount sought by, or on behalf of, any attorney or other provider of
90 goods or services retained by any insured or claimant in connection with the assertion or
91 prosecution of any claim, covered or otherwise, against the association; or

92 (x) Any claims for interest.

93 ~~(5) "Insolvent insurer" means an insurer:~~

94 ~~(A) Licensed to transact insurance in this state either at the time the policy was issued or~~
95 ~~when the insured event occurred; and~~

96 ~~(B) Against whom an order of liquidation with a finding of insolvency has been entered by~~
97 ~~a court of competent jurisdiction in the insurer's state of domicile or of this state.~~

98 (10) "Insolvent insurer" means an insurer licensed to transact insurance in this state, either
99 at the time the policy was issued or when the insured event occurred, and against whom a final
100 order of liquidation has been entered with a finding of insolvency by a court of competent
101 jurisdiction in the insurer's state of domicile.

102 ~~(6)(11) "Member insurer" means any person who: (A) ~~Writes~~ writes any kind of insurance~~
103 ~~to which this article applies under section three of this article, including farmers' mutual fire~~
104 ~~insurance companies and the exchange of reciprocal or interinsurance contracts; and (B) ~~is~~ is~~
105 ~~licensed to transact insurance in this state. An insurer shall cease to be a member insurer~~
106 ~~effective on the day following the termination or expiration of its license to transact the kinds of~~
107 ~~insurance to which this article applies, however the insurer shall remain liable as a member insurer~~
108 ~~for any and all obligations, including obligations for assessments levied prior to the termination or~~

109 expiration of the insurer's license and assessments levied after the termination or expiration,
110 which relate to any insurer which became an insolvent insurer prior to the termination or expiration
111 of the insurer's license.

112 (7) (12) "Net direct written premiums" means direct gross premiums written in this state on
113 insurance policies to which this article applies, less return premiums on the policies and dividends
114 paid or credited to policyholders on such direct business. "Net direct written premiums" does not
115 include premiums on contracts between insurers or reinsurers.

116 (8) (13) "Person" ~~includes an individual, company, insurer, association, organization,~~
117 ~~society, reciprocal, partnership, syndicate, business trust, corporation or any other legal entity~~
118 means any individual or legal entity, including governmental entities.

119 (9) (14) "Receiver" means receiver, liquidator, rehabilitator or conservator as the context
120 may require.

121 (15) "Self-insurer" means a person that covers its liability through a qualified individual or
122 group self-insurance program or any other formal program created for the specific purpose of
123 covering liabilities typically covered by insurance.

§33-26-8. Powers and duties of the association.

1 (4) (a) The association shall:
2 (a) ~~Is obligated to the extent of the covered claims existing prior to the determination of~~
3 ~~insolvency, and for those claims arising within thirty days after the determination of insolvency,~~
4 ~~but the obligation only includes that amount of each covered claim which is in excess of one~~
5 ~~hundred dollars and is less than three hundred thousand dollars: Provided, That neither of these~~
6 ~~monetary limits applies to obligations arising out of covered workers' compensation claims. In no~~
7 ~~event is the association obligated to a policyholder or claimant in an amount in excess of the~~
8 ~~obligations of the insolvent insurer under the policy from which the claim arises. Notwithstanding~~
9 ~~any other provision of this article, a covered claim does not include any claim filed with the~~
10 ~~guaranty fund after the final date set by the court for the filing of claims against the liquidator or~~

11 ~~receiver of an insolvent insurer. A default judgment or stipulated judgment against the insolvent~~
12 ~~insurer, or against the insured of an insolvent insurer, is not binding against the association.~~

13 ~~(b) Is the insurer to the extent of its obligation on the covered claims and to such extent~~
14 ~~has all rights, duties, defenses and obligations of the insolvent insurer as if the insurer had not~~
15 ~~become insolvent.~~

16 (1) Be obligated to pay covered claims existing prior to the final order of liquidation, that
17 arise within thirty days after the final order of liquidation or before the policy expiration date if such
18 expiration date is less than thirty days after the final order of liquidation, or that arise before the
19 insured replaces the policy or causes its cancellation, if the insured does so within thirty days of
20 the final order of liquidation. This obligation shall be satisfied by paying to the claimant an amount
21 as follows:

22 (A) The full amount of a covered claim for benefits under a workers' compensation
23 insurance policy: *Provided*, that any covered claim for deliberate intention, including any action
24 pursuant to section two, article four, chapter twenty-three of this code, shall not exceed \$300,000
25 per claim.

26 (B) An amount not exceeding \$10,000 per policy for a covered claim for the return of
27 unearned premium.

28 (C) An amount not exceeding \$300,000 per claim for all other covered claims: *Provided*,
29 That for purposes of this limitation, all claims of any kind whatsoever arising out of, or related to,
30 bodily injury or death to any one person shall constitute a single claim, regardless of the number
31 of claims made, or the number of claimants.

32 In no event shall the association be obligated to pay a claimant an amount in excess of
33 the obligation of the insolvent insurer under the policy or coverage from which the claim arises.
34 Notwithstanding any other provisions of this article, a covered claim shall not include a claim filed
35 with the association after the earlier of: (i) Twenty-five months after the date of the final order of

36 liquidation; or (ii) the final date set by the court for the filing of claims against the liquidator or
37 receiver of an insolvent insurer.

38 Any obligation of the association to defend an insured on a covered claim shall cease
39 upon the association's: (i) Payment, either by settlement releasing the insured or on a judgment,
40 of an amount equal to the lesser of the association's covered claim obligation limit or the
41 applicable policy limit; or (ii) tender of such amount.

42 (2) Be deemed the insurer only to the extent of its obligation on the covered claims and to
43 such extent, subject to the limitations provided in this article, shall have all rights, duties and
44 obligations of the insolvent insurer as if the insurer had not become insolvent, including, but not
45 limited to, the right to pursue and retain salvage and subrogation recoverable on paid covered
46 claim obligations. The association shall not be deemed the insolvent insurer for any purpose
47 relating to the issue of whether the association is amenable to the personal jurisdiction of the
48 courts of any state.

49 ~~(c) Shall allocate~~ (3) Allocate claims paid and expenses incurred among the three
50 accounts separately, and assess member insurers separately for each account amounts
51 necessary to pay the obligations of the association under subdivision ~~(a)~~(1) of this subsection
52 subsequent to an insolvency, the expenses of handling covered claims subsequent to an
53 insolvency, the cost of ~~examinations under~~ preparing any reports specified in section thirteen of
54 this article and other expenses authorized by this article. The assessments of each member
55 insurer shall be in the proportion that the net direct written premiums of the member insurer for
56 the ~~preceding~~ calendar year prior to the assessment on the kinds of insurance in the account
57 bears to the net direct written premiums of all member insurers for the ~~preceding~~ calendar year
58 prior to the assessment on the kinds of insurance in the account: *Provided*, That farmers mutual
59 insurance companies that do not issue workers' compensation insurance policies may not be
60 assessed to pay for the obligations of the association payable from the workers' compensation
61 insurance account. Each member insurer shall be notified of the assessment not later than thirty

62 days before it is due. No member insurer may be assessed in any one year on any account an
63 amount greater than two percent of that member insurer's net direct written premiums for the
64 ~~preceding~~ calendar year preceding the assessment on the kinds of insurance in the account. If
65 the maximum assessment, together with the other assets of the association in any account, does
66 not provide in any one year in any account an amount sufficient to make all necessary payments
67 from that account, the funds available shall be prorated and the unpaid portion shall be paid as
68 soon after that as funds become available. The association shall pay claims in any order that it
69 deems reasonable, including the payment of claims as they are received from the claimant or in
70 groups or categories of claims. The association may exempt or defer, in whole or in part, the
71 assessment of any member insurer, if the assessment would cause the member insurer's financial
72 statement to reflect the amounts of capital or surplus less than the minimum amounts required for
73 a certificate of authority by any jurisdiction in which the member insurer is authorized to transact
74 insurance: Provided, That during the period of deferment, no dividends shall be paid to
75 shareholders or policyholders. Deferred assessments shall be paid when the payment will not
76 reduce capital or surplus below required minimums. The payments shall be refunded to those
77 companies receiving larger assessments by virtue of such deferment, or at the election of any
78 such company, credited against future assessments. ~~Each member insurer may set off against~~
79 ~~any assessment, authorized payments made on covered claims and expenses incurred in the~~
80 ~~payment of such claims by the member insurer if they are chargeable to the account for which~~
81 ~~the assessment is made.~~

82 ~~(d) Shall investigate~~ (4) Investigate claims brought against the association and adjust,
83 compromise, settle, and pay covered claims to the extent of the association's obligation and deny
84 all other claims. ~~and may review settlements, releases and judgments to which the insolvent~~
85 ~~insurer or its insureds were parties to determine the extent to which the settlements, releases and~~
86 ~~judgments may be properly contested~~ The association shall have the right to appoint and to direct
87 legal counsel retained under liability insurance policies for the defense of covered claims.

88 ~~(e) Shall notify persons as the commissioner directs under subsection (2), section ten of~~
89 ~~this article.~~

90 (5) Notify claimants in this state as deemed necessary by the commissioner and upon the
91 commissioner's request, to the extent records are available to the association.

92 (6) (A) Have the right to review and contest as set forth in this subsection settlements,
93 releases, compromises, waivers and judgments to which the insolvent insurer or its insureds were
94 parties prior to the entry of the final order of liquidation. In an action to enforce settlements,
95 releases and judgments to which the insolvent insurer or its insureds were parties prior to the
96 entry of the final order of liquidation, the association shall have the right to assert the following
97 defenses, in addition to the defenses available to the insurer:

98 (i) The association is not bound by a settlement, release, compromise or waiver executed
99 by an insured or the insurer, or any judgment entered against an insured or the insurer by consent
100 or through a failure to exhaust all appeals, if the settlement, release, compromise, waiver or
101 judgment was:

102 (I) Executed or entered within one hundred twenty days prior to the entry of a final order
103 of liquidation and the insured or the insurer did not use reasonable care in entering into the
104 settlement, release, compromise, waiver or judgment, or did not pursue all reasonable appeals of
105 an adverse judgment; or

106 (II) Executed by or taken against an insured or the insurer based on default, fraud,
107 collusion or the insurer's failure to defend.

108 (ii) If a court of competent jurisdiction finds that the association is not bound by a
109 settlement, release, compromise, waiver or judgment for the reasons described in subparagraph
110 (i), paragraph (A), subdivision (6) of this subsection, the settlement, release, compromise, waiver
111 or judgment shall be set aside and the association shall be permitted to defend any covered claim
112 on the merits. The settlement, release, compromise, waiver or judgment may not be considered

113 as evidence of liability or damages in connection with any claim brought against the association
114 or any other party under this article.

115 (iii) The association shall have the right to assert any statutory defenses or other defenses
116 or rights of offset against any settlement, release, compromise or waiver executed by an insured
117 or the insurer, or any judgment taken against the insured or the insurer.

118 (B) As to any covered claims arising from a judgment under any decision, verdict or finding
119 based on the default of the insolvent insurer or its failure to defend, the association, either on its
120 own behalf or on behalf of an insured may apply to have the judgment, order, decision, verdict or
121 finding set aside by the same court or administrator that entered the judgment, order, decision,
122 verdict or finding and shall be permitted to defend the claim on the merits.

123 ~~(f) Shall handle~~ (7) Handle claims through its employees or through one or more insurers
124 or other persons designated as servicing facilities. Designation of a servicing facility is subject to
125 the approval of the commissioner, but the designation may be declined by a member insurer.

126 ~~(g) Shall reimburse~~ (8) Reimburse each servicing facility for obligations of the association
127 paid by the facility and for expenses incurred by the facility while handling claims on behalf of the
128 association and shall pay the other expenses of the association authorized by this article.

129 (9) Establish procedures for requesting financial information from insureds and claimants
130 on a confidential basis for purposes of applying sections of this article concerning the net worth
131 of first and third-party claimants, subject to such information being shared with any other
132 association similar to the association and the liquidator for the insolvent company on the same
133 confidential basis. If the insured or claimant refuses to provide the requested financial information
134 and an Auditor's certification of the same where requested and available, the association may
135 deem the net worth of the insured or claimant to be in excess of \$25 million at the relevant time.

136 ~~(2)~~ (b) The association may:

137 ~~(a)~~ (1) Employ or retain persons that are necessary to handle claims and perform other
138 duties of the association.

139 ~~(b)~~ (2) Borrow funds necessary to effect the purposes of this article in accord with the plan
140 of operation.

141 ~~(e)~~ (3) Sue or be sued, and the power to sue includes the power and right to intervene as
142 a party as a matter of right before any court in this state that has jurisdiction over an insolvent
143 insurer as defined by this article.

144 ~~(d)~~ (4) Negotiate and become a party to contracts that are necessary to carry out the
145 purpose of this article.

146 ~~(e)~~ (5) Perform other acts that are necessary or proper to effectuate the purpose of this
147 article.

148 ~~(f)~~ (6) Refund to the member insurers in proportion to the contribution of each member
149 insurer to an account that amount by which the assets of the account exceed the liabilities, if, at
150 the end of any calendar year, the board of directors finds that the assets of the association in any
151 account exceed the liabilities of that account as estimated by the board of directors for the coming
152 year.

§33-26-9. Plan of operation.

1 ~~(4)~~ (a) The association shall:

2 ~~(a)~~ (1) Submit to the commissioner a plan of operation and any amendments thereto
3 necessary or suitable to assure the fair, reasonable and equitable administration of the
4 association. The plan of operation and any amendments thereto shall become effective upon
5 approval in writing by the commissioner.

6 ~~(b)~~ (2) If the association fails to submit a suitable plan of operation within ninety days
7 following the effective date of this article or if at any time thereafter the association fails to submit
8 suitable amendments to the plan, the commissioner shall, after notice and hearing, adopt and
9 promulgate such reasonable rules as are necessary or advisable to effectuate the provisions of
10 this article. Such rules shall continue in force until modified by the commissioner or superseded

11 by a plan submitted by the association and approved by the commissioner. All such rules shall be
12 promulgated in accordance with the provisions of chapter twenty-nine-a of this code.

13 ~~(2)~~ (b) All member insurers shall comply with the plan of operation.

14 ~~(3)~~ (c) The plan of operation shall:

15 ~~(a)~~ (1) Establish the procedures whereby all the powers and duties of the association
16 under section eight of this article will be performed.

17 ~~(b)~~ (2) Establish procedures for handling assets of the association.

18 ~~(c)~~ (3) Establish the amount and method of reimbursing members of the board of directors
19 under section seven of this article.

20 ~~(d)~~ (4) Establish procedures by which claims may be filed with the association and establish
21 acceptable forms of proof of covered claims. ~~Notice of claims to the receiver of the insolvent~~
22 ~~insurer shall be deemed notice to the association or its agent and a list of such claims shall be~~
23 ~~periodically submitted to the association or similar organization in another state by the receiver~~

24 ~~(e)~~ (5) Establish regular places and times for meetings of the board of directors.

25 ~~(f)~~ (6) Establish procedures for records to be kept of all financial transactions of the
26 association, its agents and the board of directors.

9 exhaust all coverage provided by any such policy. Any amount payable on a covered claim under
10 this article shall be reduced by the full applicable limits stated in such other insurance policy and

35 on the history and causes of the insolvency, based on the information available to the association

§33-26-14. Examination of association; financial report.

1 The association shall be subject to examination and regulation by the commissioner. The

§33-26-18. Stay of proceedings; reopening of default judgments.

1 (a) All proceedings in which the insolvent insurer is a party or obligated to defend a party

4 court from the date ~~the proof of claim provided for in section eighteen, article ten of this chapter~~
5 ~~is filed with the receiver~~ the insolvency is determined to permit proper defense by the association
6 of all pending causes of action.

7 (b) The liquidator, receiver or statutory successor of an insolvent insurer covered by this
8 article shall permit access by the association, or its authorized representative, to such of the
9 insolvent insurer's records that are necessary for the association in carrying out its functions under
10 this article with regard to covered claims. In addition, the liquidator, receiver or statutory successor
11 shall provide the association or its representative with copies of such records upon the request
12 by the association and at the expense of the association.

13 (c) As to any covered claims arising from a judgment under any order, decision, verdict or
14 finding based on the default of the insolvent insurer or its wrongful failure to defend an insured,
15 the association either on its own behalf or on behalf of such insured may apply to have such
16 judgment, order, decision, verdict or finding set aside by the same court or administrator that
17 made such judgment, order, decision, verdict or finding and shall be permitted to defend against
18 such claim on the merits.
