1 AN ACT making a supplementary appropriation from the balance of moneys remaining as an  
2 unappropriated balance from the State Fund, State Excess Lottery Revenue Fund, to the  
3 Department of Health and Human Resources, Division of Human Services, fund 5365,  
4 fiscal year 2016, organization 0511, by supplementing and amending the appropriations  
5 for the fiscal year ending June 30, 2016.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on  
7 January 13, 2016, which included a Statement of the State Excess Lottery Revenue Fund setting  
8 forth therein the unappropriated cash balance as of July 1, 2015, and further included the estimate  
9 of revenues for the fiscal year 2016, less regular appropriations for fiscal year 2016; and

10 Whereas, It appears from the Governor's Statement of the State Excess Lottery Revenue  
11 Fund there now remains an unappropriated balance in the State Treasury which is available for  
12 appropriation during the fiscal year ending June 30, 2016; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2016, to fund 5365, fiscal  
2 year 2016, organization 0511, be supplemented and amended by increasing an existing item of  
3 appropriation as follows:


