1 AN ACT supplementing and amending by decreasing an appropriation and making a
2 supplementary appropriation from the balance of moneys remaining as an unappropriated
3 balance from the State Fund, State Excess Lottery Revenue Fund, to the Department of
4 Revenue, Lottery Commission – Distributions to Statutory Funds and Purposes, fund
5 7213, fiscal year 2016, organization 0705, by supplementing and amending the
6 appropriations for the fiscal year ending June 30, 2016.

7 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
8 January 13, 2016, which included a Statement of the State Excess Lottery Revenue Fund setting
9 forth therein the unappropriated cash balance as of July 1, 2015, and further included the estimate
10 of revenues for the fiscal year 2016, less regular appropriations for fiscal year 2016; and

11 Whereas, It appears from the Governor’s Statement of the State Excess Lottery Revenue
12 Fund, and this legislation, there now remains an unappropriated balance in the State Treasury
13 which is available for appropriation during the fiscal year ending June 30, 2016; *therefore,*
Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2016, to fund 7213, fiscal
2 year 2016, organization 0705, be supplemented and amended by decreasing an existing item of
3 appropriation as follows:
