A BILL to amend and reenact §15-2-3 and §15-2-5 of the Code of West Virginia, 1931, as
amended, all relating to maintaining a minimum of eight hundred state troopers by July 1,
2018; and increasing the salary increase received at the end of two years of service with
the West Virginia State Police from \$500 to \$580.

Be it enacted by the Legislature of West Virginia:

That §15-2-3 and §15-2-5 of the Code of West Virginia, 1931, as amended, be amended
and reenacted, all to read as follows:

ARTICLE 2. WEST VIRGINIA STATE POLICE.

§15-2-3. State Police structure; how established; training; special revenue account.

1 (a) The superintendent shall create, appoint and equip the State Police which shall consist 2 of the number of troops, districts and detachments required for the proper administration of the 3 State Police, Each troop, district or detachment shall be composed of the number of officers and 4 members the superintendent determines are necessary to meet operational needs and are 5 required for the efficient operation of the State Police. The superintendent shall establish the 6 general organizational structure of the State Police by interpretive rule in accordance with the 7 provisions of article three, chapter twenty-nine-a of this code. The superintendent shall provide 8 adequate facilities for the training of all members of the State Police and shall prescribe basic 9 training requirements for newly enlisted members. He or she shall also provide advanced or inservice training, from time to time, for all members of the State Police. The superintendent shall 10 11 hold entry-level training classes for other law-enforcement officers in the state without cost to 12 those officers, except actual expenses for food, lodging and school supplies. The superintendent 13 may hold advanced levels of training classes for other law-enforcement officers in the state for a 14 reasonable daily fee per student not to exceed \$100.

(b) Notwithstanding any other provision of this code to the contrary, the superintendent
 shall implement a program to increase the number of state troopers in the state to attain and
 maintain a minimum number of eight hundred state troopers by July 1, 2018.

18 (b) (c) There is hereby created in the State Treasury a special revenue account, which 19 shall be an interest bearing account, to be known as the Academy Training and Professional 20 Development Fund. The special revenue account shall consist of training fees, any appropriations 21 that may be made by the Legislature, income from the investment of moneys held in the special 22 revenue account and all other sums available for deposit to the special revenue account from any 23 source, public or private. No expenditures, for purposes of this section, are authorized from 24 collections except in accordance with the provisions of article three, chapter twelve of this code 25 and upon fulfillment of the provisions set forth in article two, chapter eleven-b of this code. Any 26 balance remaining in the special revenue account at the end of any state fiscal year does not 27 revert to the General Revenue Fund but remains in the special revenue account and shall be 28 used solely in a manner consistent with this article. The superintendent is authorized to expend 29 funds from the account to offset operational and training costs; for building maintenance and 30 repair; for purchases and for equipment repair or replacement for the West Virginia State Police 31 Academy; and to defray necessary expenses incidental to those and other activities associated 32 with law-enforcement training.

33 (c) (d) There is hereby created in the State Treasury a special revenue account, which is 34 an interest bearing account, to be known as the State Police 100th Anniversary Fund. The special 35 revenue account shall consist of merchandise sales, any appropriations that may be made by the 36 Legislature, income from the investment of moneys held in the special revenue account and all 37 other sums available for deposit to the special revenue account from any source, public or private. 38 No expenditures for purposes of this section are authorized from collections except in accordance 39 with the provisions of article three, chapter twelve of this code and upon fulfillment of the 40 provisions set forth in article two, chapter eleven-b of this code. Any balance remaining in the 41 special revenue account at the end of any state fiscal year does not revert to the General Revenue 42 Fund but remains in the special revenue account and shall be used solely in a manner consistent with this article. The superintendent is authorized to expend funds from the account to offset costs 43 for the 100th anniversary celebration; for purchasing 100th anniversary commemorative 44

merchandise, equipment and vehicles; and to defray necessary expenses incidental to those and
other activities associated with the 100th anniversary of the West Virginia State Police. This fund
expires on December 31, 2019 and remaining funds shall be transferred to the Academy Training
and Professional Development Fund.

49 (d) (e) The superintendent may hold training classes for certification to access and use
 50 the West Virginia Automated Police Network (WEAPON) for a reasonable daily fee per student
 51 not to exceed \$100.

52 (e) (f) There is hereby created in the State Treasury a special revenue account, which is 53 an interest bearing account, to be known as the West Virginia State Police Criminal Justice 54 Information Services Fund. The special revenue account shall consist of: Fees collected for training and certification for access to the West Virginia Automated Police Network (WEAPON) 55 56 system; any appropriations that may be made by the Legislature; income from the investment of 57 moneys held in the special revenue account; and all other sums available for deposit to the special 58 revenue account from any source, public or private. Any balance remaining in the special revenue 59 account at the end of any state fiscal year does not revert to the General Revenue Fund but 60 remains in the special revenue account and may be used solely in a manner consistent with this 61 article. The superintendent is authorized to expend funds from the account for the following 62 purposes: To offset operational and training costs; for building maintenance and repair; for 63 purchases and for equipment repair; personal services; software; other associated maintenance 64 costs; and to defray necessary expenses incidental to those and other activities associated with 65 the communications section of the West Virginia State Police.

§15-2-5. Career progression system; salaries; exclusion from wages and hour law, with supplemental payment; bond; leave time for members called to duty in guard or reserves.

(a) The superintendent shall establish within the West Virginia State Police a system to
 provide for: The promotion of members to the supervisory ranks of sergeant, first sergeant,
 second lieutenant and first lieutenant; the classification of nonsupervisory members within the

field operations force to the ranks of trooper, senior trooper, trooper first class or corporal; the
classification of members assigned to the forensic laboratory as criminalist I-VIII; and the
temporary reclassification of members assigned to administrative duties as administrative support
specialist I-VIII.

8 (b) The superintendent may propose legislative rules for promulgation in accordance with 9 article three, chapter twenty-nine-a of this code for the purpose of ensuring consistency, 10 predictability and independent review of any system developed under the provisions of this 11 section.

(c) The superintendent shall provide to each member a written manual governing any
system established under the provisions of this section and specific procedures shall be identified
for the evaluation and testing of members for promotion or reclassification and the subsequent
placement of any members on a promotional eligibility or reclassification recommendation list.

53	Each member of the West Virginia State Police whose salary is fixed and specified in this
54	annual salary schedule is entitled to the length of service increases set forth in subsection (e) of
55	this section and supplemental pay as provided in subsection (g) of this section.

(e) Each member of the West Virginia State Police whose salary is fixed and specified 56 57 pursuant to this section shall receive, and is entitled to, an increase in salary over that set forth in 58 subsection (d) of this section for grade in rank, based on length of service, including that service 59 served before and after the effective date of this section with the West Virginia State Police as 60 follows: Beginning on January 1, 2015, and continuing thereafter, at the end of two years of 61 service with the West Virginia State Police, the member shall receive a salary increase of \$500 62 \$580 to be effective during his or her next year of service and a like increase at yearly intervals 63 thereafter, with the increases to be cumulative.

(f) In applying the salary schedules set forth in this section where salary increases are
provided for length of service, members of the West Virginia State Police in service at the time
the schedules become effective shall be given credit for prior service and shall be paid the salaries
the same length of service entitles them to receive under the provisions of this section.

(g) The Legislature finds and declares that because of the unique duties of members of the West Virginia State Police, it is not appropriate to apply the provisions of state wage and hour laws to them. Accordingly, members of the West Virginia State Police are excluded from the provisions of state wage and hour law. This express exclusion shall not be construed as any indication that the members were or were not covered by the wage and hour law prior to this exclusion.

In lieu of any overtime pay they might otherwise have received under the wage and hour law, and in addition to their salaries and increases for length of service, members who have completed basic training and who are exempt from federal Fair Labor Standards Act guidelines may receive supplemental pay as provided in this section.

The authority of the superintendent to propose a legislative rule or amendment thereto for promulgation in accordance with article three, chapter twenty-nine-a of this code to establish the number of hours per month which constitute the standard work month for the members of the West Virginia State Police is hereby continued. The rule shall further establish, on a graduated

hourly basis, the criteria for receipt of a portion or all of supplemental payment when hours are
worked in excess of the standard work month. The superintendent shall certify monthly to the
West Virginia State Police's payroll officer the names of those members who have worked in
excess of the standard work month and the amount of their entitlement to supplemental payment.
The supplemental payment may not exceed \$400 monthly. The superintendent and civilian
employees of the West Virginia State Police are not eligible for any supplemental payments.

(h) Each member of the West Virginia State Police, except the superintendent and civilian
employees, shall execute, before entering upon the discharge of his or her duties, a bond with
security in the sum of \$5,000 payable to the State of West Virginia, conditioned upon the faithful
performance of his or her duties, and the bond shall be approved as to form by the Attorney
General and as to sufficiency by the Governor.

93 (i) In consideration for compensation paid by the West Virginia State Police to its members 94 during those members' participation in the West Virginia State Police Cadet Training Program 95 pursuant to section eight, article twenty-nine, chapter thirty of this code, the West Virginia State 96 Police may require of its members by written agreement entered into with each of them in advance 97 of such participation in the program that, if a member should voluntarily discontinue employment 98 any time within one year immediately following completion of the training program, he or she shall 99 be obligated to pay to the West Virginia State Police a pro rata portion of such compensation 100 equal to that part of such year which the member has chosen not to remain in the employ of the 101 West Virginia State Police.

(j) Any member of the West Virginia State Police who is called to perform active duty
 training or inactive duty training in the National Guard or any reserve component of the Armed
 Forces of the United States annually shall be granted, upon request, leave time not to exceed
 thirty calendar days for the purpose of performing the active duty training or inactive duty training
 and the time granted may not be deducted from any leave accumulated as a member of the West
 Virginia State Police.

NOTE: The purpose of this bill is to establish a minimum number of troopers to provide basic law- enforcement services. The bill further provides that the salary increase at the end of two years of service for members of the West Virginia State Police will increase from \$500 to \$580.
