3 Rural Health within the Center for Rural Health Development, Inc.; creating a steering 4 committee; and establishing structure and responsibilities. Be it enacted by the Legislature of West Virginia: 1 That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new 2 article, designated §16-52-1, §16-52-2 and §16-52-3, all to read as follows: ARTICLE 52. OFFICE OF RURAL HEALTH POLICY. §16-52-1. Legislative findings. 1 The Legislature finds: 2 (1) The majority of West Virginia citizens live in rural West Virginia; 3 (2) A viable rural health care delivery system is an integral part of the economic infrastructure, like water, sewer, roads, schools and broadband, needed in rural communities to 4 5 attract and retain businesses and jobs; 6 (3) A healthy workforce is also needed to attract jobs and business development 7 throughout West Virginia; 8 (4) Rural West Virginia typically experiences higher rates of poverty, an older population, 9 a higher number of people who do not complete high school, and a more challenged health care 10 system; 11 (5) These findings indicate that rural West Virginia has some unique factors that are 12 important to policymakers as they make decisions that impact health and health care in rural West 13 Virginia; and 14 (6) The health and economic well-being of West Virginia and its citizens requires the development of a comprehensive rural health plan focused on the quality of care, economic 15 16 viability of health care delivery systems, access to health and dental care services, and workforce 17 development with the goal of strengthening rural health systems and improving the health of the

§16-52-2. Establishment of the Office of Rural Health Policy.

- 1 (a) The Office of Rural Health Policy is created and shall be managed and operated in the 2 private sector within the Center for Rural Health Development, Inc., a 501(c)(3) organization 3 whose primary purpose is to strengthen West Virginia's rural health care delivery systems and 4 improve the health of our citizens. 5 (1) The Center for Rural Health Development, Inc. is able to annually provide \$3.00 in 6 matching funds using private funds to every \$1.00 of federal funds provided through the Federal 7 Office of Rural Health Policy's funding to establish a state office of rural health policy in each 8 state. The funds are to be used to carry out the goals of the Office of Rural Health Policy as 9 stated in this article. The \$3.00 in matching funds is not required of other federal funding managed 10 by the Office of Rural Health Policy. 11 (b) The Office of Rural Health Policy shall: 12 (1) Provide advice on rural health issues to the Department of Health and Human 13 Resources, the Governor, the Legislature and other state government agencies; 14 (2) Administer grant programs designed to build health care capacity, improve access to 15 care, promote the use of tele-health technologies, develop rural health leaders, and improve 16 health of West Virginians; including, but not limited to, the Medicare Rural Hospital Flexibility 17 Grant, Small Rural Hospital Improvement Program Grant and other grants offered through the Federal Office of Rural Health Policy or other federal agencies; 18 19 (3) Coordinate provider and allied health recruitment and retention efforts in West Virginia; 20 (4) Partner with statewide quality improvement initiatives; 21 (5) Engage stakeholders, especially the Department of Health and Human Resources, to 22 develop and implement the rural health plan to provide policymakers, funders and stakeholder 23 organizations with a common vision and steps to improve rural health in West Virginia; (6) Coordinate and provide technical assistance to strengthen the rural health 24

25 infrastructure in West Virginia; 26 (7) Engage stakeholders, including those in other sectors, to develop and implement 27 evidence-based strategies to build healthy communities throughout rural communities in West 28 Virginia; 29 (8) Establish relationships with federal policymakers and agencies, and rural health organizations and agencies in the United States to serve as an advocate for West Virginia; 30 31 (9) Employ staff and develop policies as necessary to perform the duties of the Office of 32 Rural Health Policy; and 33 (10) Prepare a budget using available resources from the Federal Office of Rural Health Policy, funds from other available resources and any other public and private sources to carry out 34 35 these stated duties. §16-52-3. Creation of a steering committee. 1 (a) The board of the Center for Rural Health Development, Inc., designated as the Office 2 of Rural Health Policy, shall establish a steering committee responsible for advising the 3 development of the rural health plan and implementation of all activities established in this article. 4 (b) The members of the steering committee shall reflect balanced geographical 5 representation and diverse backgrounds. 6 (c) The steering committee shall consist of between nine and fifteen voting members, 7 including: 8 (1) One representative chosen by the West Virginia Rural Health Association; 9 (2) One representative chosen by the West Virginia Hospital Association; 10 (3) One representative chosen by each of West Virginia's two United States Senators; 11 (4) One representative of the Department of Health and Human Resources chosen by the 12 secretary; 13 (5) One representative chosen by the board of the Center for Rural Health Development,

15	(6) The remaining members selected by the above designated steering committee
16	members to bring expertise, skills and experience to the steering committee's deliberations.
17	(d) All steering committee members serve for three-year terms, except that a member
18	appointed to fill a vacancy occurring prior to the expiration of the term for which a predecessor
19	was appointed serves the remainder of the unexpired term. A member may not serve more than
20	two consecutive three-year terms.
21	(e) Any vacancy occurring in the membership of the steering committee shall be filled in
22	the same manner as the initial membership provided in subsection (c) of this section. A vacancy
23	does not affect the ability of the remaining members to carry out the duties of the steering
24	committee.
25	(f) The Office of Rural Health Policy may reimburse members of the steering committee
26	for reasonable and necessary expenses incurred in the performance of their duties, including
27	attending steering committee meetings.
	NOTE: The purpose of this bill is to establish the Office of Rural Health Policy.
