1 AN ACT supplementing and amending by adding, increasing, and decreasing the appropriations
2 of public moneys out of the Treasury in the State Fund, General Revenue, to the
3 Department of Health and Human Resources – Division of Human Services, fund 0403,
4 fiscal year 2018, organization 0511, and to the Department of Health and Human
5 Resources, Division of Health – Central Office, fund 0407, fiscal year 2018, organization
6 0506, by supplementing, amending, adding, increasing, and decreasing the
7 appropriations for the fiscal year ending June 30, 2018.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated January 10, 2018, which included a statement of the State Fund, General Revenue, setting
3 forth therein the cash balance as of July 1, 2017, and further included the estimate of revenues
4 for the fiscal year 2018, less net appropriation balances forwarded and regular appropriations for
5 the fiscal year 2018; and

6 Whereas, There are available cash balances in the Medical Services Program Fund that
7 can be utilized in order to decrease the appropriations from the State Fund, General Revenue;
8 and

9 Whereas, It appears from the Executive Budget Document, statement of the State Fund,
10 General Revenue, and this legislation, there will remain an unappropriated balance in the State
11 Treasury which is available for appropriation during the fiscal year ending June 30, 2018;
12 therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2018, to fund 0403, fiscal
2 year 2018, organization 0511, be supplemented and amended by decreasing an existing item of
3 appropriation as follows:
