1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
 2 designated §5B-2I-1, §5B-2I-2, §5B-2I-3, §5B-2I-4, §5B-2I-5, §5B-2I-6 and §5B-2I-7, all
 3 relating to authorizing local units of government to adopt local energy efficiency
 4 partnership programs and to create districts to promote the use of energy efficiency
 5 improvements by owners of certain real property; providing for financing of programs
 6 through voluntary property assessments, commercial lending and other means;
 7 authorizing local unit of government to issue bonds, notes and other evidences of
 8 indebtedness and to pay the cost of energy efficiency improvements from the proceeds
 9 thereof; providing for the repayment of bonds, notes and other evidences of indebtedness;
 10 authorizing certain fees; prescribing powers and duties of certain governmental officers
 11 and entities; and providing remedies.

Be it enacted by the Legislature of West Virginia:

1 That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new
 2 article, designated §5B-2I-1, §5B-2I-2, §5B-2I-3, §5B-2I-4, §5B-2I-5, §5B-2I-6 and §5B-2I-7, all to
 3 read as follows:

ARTICLE 2I. LOCAL ENERGY EFFICIENCY PARTNERSHIP ACT.

§5B-2I-1. Short title.

1 This article shall be known and may be cited as the "Local Energy Efficiency Partnership
 2 Act".

§5B-2I-2. Definitions.

1 As used in this article:

2 (1) "District" means a district created under a local energy efficiency partnership program
 3 by a local unit of government that lies within the local unit of government's jurisdictional
 4 boundaries. A local unit of government may create more than one district under the program, and
 5 districts may be separate, overlapping or coterminous.

6 (2) "Energy efficiency improvement" means equipment, devices, or materials intended to

7 decrease energy consumption, including, but not limited to:

8 (A) Insulation in walls, roofs, floors, foundations or heating and cooling distribution
9 systems;

10 (B) Storm windows and doors; multi-glazed windows and doors; heat-absorbing or heat-
11 reflective glazed and coated window and door systems; and additional glazing, reductions in glass
12 area, and other window and door system modifications that reduce energy consumption;

13 (C) Automated energy control systems;

14 (D) Heating, ventilating or air-conditioning and distribution system modifications or
15 replacements;

16 (E) Caulking, weather-stripping and air sealing;

17 (F) Replacement or modification of lighting fixtures to reduce the energy use of the lighting
18 system;

19 (G) Energy recovery systems;

20 (H) Daylighting systems;

21 (I) Installation or upgrade of electrical wiring or outlets to charge a motor vehicle that is
22 fully or partially powered by electricity;

23 (J) Measures to reduce the usage of water or increases the efficiency of water usage;

24 (K) Any other installation or modification of equipment, devices, or materials approved as
25 a utility cost-savings measure by the governing body.

26 (3) "Energy project" means the installation or modification of an energy efficiency
27 improvement.

28 (4) "Governing body" means the county commission of a county, or the council or other
29 similar elected legislative body of a municipality.

30 (5) "Local unit of government" means a county or municipality.

31 (6) "Person" means an individual, firm, partnership, association, corporation,
32 unincorporated joint venture, or trust, organized, permitted, or existing under the laws of this state

33 or any other state, including a federal corporation, or a combination thereof. However, person
34 does not include a local unit of government.

35 (7) "Property" means privately owned commercial or industrial real property located within
36 the local unit of government.

37 (8) "Local energy efficiency partnership program" or "program" means a program as
38 described in section three of this article.

39 (9) "Record owner" means the person or persons possessed of the most recent fee title
40 or land contract vendee's interest in property as shown by the records of the clerk of the county
41 commission.

§5B-2I-3. Establishment of local energy efficiency partnership program.

1 (a) Pursuant to the procedures set forth in this section, a local unit of government may
2 establish a local energy efficiency partnership program and may, from time to time, create a
3 district or districts under the program.

4 (b) Under a program, the local unit of government may enter into a contract with the record
5 owner of property within a district to finance or refinance one or more energy projects on the
6 property. The contract may provide for the repayment of the cost of an energy project through
7 assessments upon the property benefitted. The financing or refinancing may include the cost of
8 materials and labor necessary for installation, permit fees, inspection fees, application and
9 administrative fees, bank fees, and all other fees that may be incurred by the record owner
10 pursuant to the installation on a specific or pro rata basis, as determined by the local unit of
11 government.

12 (c) To establish a local energy efficiency partnership program, the governing body of a
13 local unit of government shall take the following actions in the following order:

14 (1) Adopt a resolution of intent that includes all of the following:

15 (A) A finding that the financing of energy projects is a valid public purpose;

16 (B) A statement of intent to provide funds for energy projects, which may be repaid by

17 assessments on the property benefitted, with the agreement of the record owners;

18 (C) A description of the proposed arrangements for financing the program;

19 (D) The types of energy projects that may be financed;

20 (E) Reference to a report on the proposed program as described in section four of this
21 article, and a location where the report is available pursuant to section four of this article; and

22 (F) The time and place for a public hearing on the proposed program;

23 (2) Hold a public hearing at which the public may comment on the proposed program,
24 including the report required by section four of this article;

25 (3) Adopt a resolution establishing the program and setting forth its terms and conditions,
26 including all of the following:

27 (A) Matters required by section four of this article to be included in the report; for this
28 purpose, the resolution may incorporate the report or an amended version thereof by reference;
29 and

30 (B) A description of which aspects of the program may be amended without a new public
31 hearing and which aspects may be amended only after a new public hearing is held.

32 (d) A local energy efficiency partnership program may be amended by resolution of the
33 governing body. Adoption of the resolution shall be preceded by a public hearing if required
34 pursuant to subdivision (3), subsection (c) of this section.

§5B-2I-4. Report requirements on proposed local energy efficiency partnership program.

1 (a) The report on the proposed program required under section three of this article shall
2 include all of the following:

3 (1) A form of contract between the local unit of government and record owner governing
4 the terms and conditions of financing and assessment under the program;

5 (2) Identification of an official authorized to enter into a program contract on behalf of the
6 local unit of government;

7 (3) A maximum aggregate annual dollar amount for all financing to be provided by the

8 local unit of government under the program;

9 (4) An application process and eligibility requirements for financing energy projects under
10 the program;

11 (5) A method for determining interest rates on assessment installments, repayment
12 periods, and the maximum amount of an assessment.

13 (6) Explanation of how assessments will be made and collected consistent with section
14 five of this article;

15 (7) A plan for raising capital to finance improvements under the program. The plan may
16 include any of the following:

17 (A) The sale of bonds or notes, subject to appropriate laws and rules;

18 (B) Amounts to be advanced by the local unit of government through funds available to it
19 from any other source; or

20 (C) Owner-arranged financing from a commercial lender; under owner-arranged financing,
21 the local unit of government may impose an assessment pursuant to section five of this article
22 and forward payments to the commercial lender or the record owner may pay the commercial
23 lender directly;

24 (8) Information regarding all of the following, to the extent known, or procedures to
25 determine the following in the future:

26 (A) Any reserve fund or funds to be used as security for bonds or notes described in
27 subdivision (7) of this section;

28 (B) Any application, administration, or other program fees to be charged to record owners
29 participating in the program that will be used to finance costs incurred by the local unit of
30 government as a result of the program;

31 (9) A requirement that the term of an assessment not exceed the useful life of the energy
32 project paid for by the assessment;

33 (10) A requirement for an appropriate ratio of the amount of the assessment to the

34 assessed value of the property;

35 (11) A requirement that the record owner of property subject to a mortgage obtain written
36 consent from the mortgage holder before participating in the program;

37 (12) Provisions for marketing and participant education;

38 (13) Provisions for adequate debt service reserve fund;

39 (14) Quality assurance and antifraud measures;

40 (15) A requirement that a baseline energy audit be conducted before an energy project is
41 undertaken, to establish future energy savings. After the energy project is completed, the local
42 unit of government shall obtain verification that the energy efficiency improvement was properly
43 installed and is operating as intended;

44 (16) For an energy project financed with more than \$250,000 in assessments, both of the
45 following:

46 (A) A requirement for ongoing measurements that establish the savings realized by the
47 record owner from the energy project; and

48 (B) A requirement that, in the contract for installation of the energy project, the contractor
49 guarantee to the record owner that the energy project will achieve a savings-to-investment ratio
50 greater than one and agree to pay the record owner, on an annual basis, any shortfall in savings
51 below this level.

52 (b) The local unit of government shall make the report available for review on the local unit
53 of government's website or at the office of the clerk or the official authorized to enter contracts on
54 behalf of the local unit of government under the local energy efficiency partnership program.

§5B-2I-5. Assessment imposed under a local energy efficiency partnership program.

1 (a) A local unit of government may impose an assessment under a local energy efficiency
2 partnership program only pursuant to a written contract with the record owner of the property to
3 be assessed.

4 (b) Before entering into a contract with a record owner under a program, the local unit of

5 government shall verify all of the following:

6 (1) That there are no delinquent taxes, special assessments, or water or sewer charges
7 on the property; and

8 (2) That there are no delinquent assessments on the property under a local energy
9 efficiency partnership program.

10 (c) An assessment imposed under a local energy efficiency partnership program, including
11 any interest on the assessment and any penalty, is a lien against the property on which the
12 assessment is imposed until the assessment, including any interest or penalty, is paid in full. The
13 lien runs with the property and has the same priority and status as other property tax and
14 assessment liens. The local unit of government has all rights in the case of delinquency in the
15 payment of an assessment as it does with respect to delinquent property taxes. When the
16 assessment, including any interest and penalty, is paid, the lien shall be removed from the
17 property.

18 (d) Installments of assessments due under a program shall be included in each property
19 tax bill and shall be collected at the same time and in the same manner as property taxes collected
20 according to article one, chapter eleven-a of this code. Alternatively, installments may be billed
21 and collected as provided in a special assessment ordinance of general applicability adopted by
22 the local unit of government pursuant to state law or local charter.

§5B-2I-6. Issuance of bonds.

1 (a) A local unit of government may issue bonds or notes to finance energy projects under
2 a local energy efficiency partnership program.

3 (b) Bonds or notes issued under subsection (a) of this section may not be general
4 obligations of the local unit of government, but shall be secured by one or more of the following
5 as provided by the governing body in the resolution or ordinance approving the bonds or notes:

6 (1) Payments of assessments on benefitted property within the district or districts
7 specified;

8 (2) Reserves established by the local unit of government from grants, bond or note
9 proceeds, or other lawfully available funds;

10 (3) Municipal bond insurance, lines or letters of credit, public or private guaranties, standby
11 bond purchase agreements, collateral assignments, mortgages, and any other available means
12 of providing credit support or liquidity;

13 (4) Tax increment revenues that may be lawfully available for such purposes; or

14 (5) Any other amounts lawfully available for such purposes.

15 (c) A pledge of assessments, funds, or contractual rights made by a governing body in
16 connection with the issuance of bonds or notes by a local unit of government under this article
17 constitutes a statutory lien on the assessments, funds, or contractual rights so pledged in favor of
18 the person or persons to whom the pledge is given, without further action by the governing body.
19 The statutory lien is valid and binding against all other persons, with or without notice.

20 (d) Bonds or notes of one series issued under this article may be secured on a parity with
21 bonds or notes of another series issued by the local unit of government pursuant to the terms of
22 a master indenture or master resolution entered into or adopted by the governing body of the local
23 unit of government.

24 (e) Bonds or notes issued under this article, and interest payable on such bonds and notes,
25 are exempt from all taxation by this state and its political subdivisions.

26 (f) Bonds or notes issued under this article further essential public and governmental
27 purposes, including, but not limited to, reduced energy costs, reduced greenhouse gas emissions,
28 economic stimulation and development, improved property valuation, and increased employment.

§5B-2I-7. Joint implementation of programs.

1 (a) A local unit of government may join with any other local unit of government, or with any
2 person, or with any number or combination thereof, by contract or otherwise as may be permitted
3 by law, for the implementation of a local energy efficiency partnership program, in whole or in
4 part.

- 5 (b) If a local energy efficiency partnership program is implemented jointly by two or more
6 local units of government pursuant to subsection (a) of this section, a single public hearing held
7 jointly by the cooperating local units of government is sufficient to satisfy the requirements of
8 subdivision (2), subsection (c), section three of this article.

NOTE: The purpose of this bill is to authorize local units of government to adopt local energy efficiency partnership programs and to create districts to promote the use of energy efficiency improvements by owners of certain real property; to provide for the financing of such programs through voluntary property assessments, commercial lending, and other means; to authorize a local unit of government to issue bonds, notes, and other evidences of indebtedness and to pay the cost of energy efficiency improvements from the proceeds thereof; to provide for the repayment of bonds, notes, and other evidences of indebtedness; to authorize certain fees; to prescribe the powers and duties of certain governmental officers and entities; and to provide remedies.
