1 A BILL to amend and reenact §18A-4-2 of the Code of West Virginia, 1931, as amended, relating
 2 to increasing the salaries of public school teachers over a five-year period.

Be it enacted by the Legislature of West Virginia:

ARTICLE 4. SALARIES, WAGES AND OTHER BENEFITS.

§18A-4-2. State minimum salaries for teachers.

1 (a) It is the goal of the Legislature to increase the state minimum salary for teachers with
 2 zero years of experience and an A. B. degree, including the equity supplement, to at least
 3 \$43,000 by fiscal year 2019.

4 (b) Beginning July 1, 2014, and continuing thereafter, each teacher shall receive the
 5 amount prescribed in the state Minimum Salary Schedule as set forth in this section, specific
 6 additional amounts prescribed in this section or article, and any county supplement in effect in a
 7 county pursuant to §18A-4-5a of this code during the contract year.
