AN ACT to amend and reenact §64-2-1 of the Code of West Virginia, 1931, as amended, relating to authorizing the Department of Administration to promulgate a legislative rule relating to parking; and authorizing the Department of Administration to promulgate a legislative rule relating to state-owned vehicles.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. AUTHORIZATION FOR DEPARTMENT OF ADMINISTRATION TO PROMULGATE LEGISLATIVE RULES.

§64-2-1. Department of Administration.

- 1 (a) The legislative rule filed in the State Register on July 25, 2017, authorized under the 2 authority of §5A-10-3a of this code, relating to the Department of Administration (parking, 148 3 CSR 6), is authorized.
 - (b) The legislative rule filed in the State Register on July 26, 2017, authorized under the authority of §5A-3-48 of this code, modified by the Department of Administration to meet the objections of the Legislative Rule-Making Review Committee and refiled in the State Register on December 11, 2017, relating to the Department of Administration (state-owned vehicles, 148 CSR 3), is authorized with the amendments set forth below:
 - On page 5, subsection 7.4, after the word "as", by inserting the words "well as";
- On page 5, subdivision 7.4.b, by striking out the words "or replacement" and inserting in lieu thereof the words "to or replacement of a state-owned vehicle";
