1 A BILL supplementing, amending, decreasing, and increasing items of the existing appropriations  
 2 from the State Road Fund to the Department of Transportation - Division of Highways,  
 3 fund 9017, fiscal year 2019, organization 0803, for the fiscal year ending June 30, 2019.

4 Whereas, The Governor submitted to the Legislature the Executive Budget Document,  
 5 dated January 9, 2019, which included a statement of the State Road Fund setting forth therein  
 6 the cash balances and investments as of July 1, 2018, and further included the estimate of  
 7 revenues for the fiscal year 2019, less regular appropriations for the fiscal year 2019; and

8 Whereas, It appears from the Statement of the State Road Fund there now remains an  
 9 unappropriated balance in the State Treasury which is available for appropriation during the fiscal  
 10 year ending June 30, 2019; therefore

11 *Be it enacted by the Legislature of West Virginia:*

12 That the total appropriation for the fiscal year ending June 30, 2019, to fund 9017, fiscal  
 13 year 2019, organization 0803, be supplemented and amended by decreasing existing items of  
 14 appropriation as follows:
