[Passed June 24, 2019; in effect from passage.]

1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2020, to
3 the Department of Revenue, Office of the Secretary, Home Rule Board Operations Fund,
4 fund 7010, fiscal year 2020, organization 0701 by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2020.

6 WHEREAS, The Governor has established that there now remains an unappropriated
7 balance in the Department of Revenue, Office of the Secretary, Home Rule Board Operations
8 Fund, fund 7010, fiscal year 2020, organization 0701, that is available for expenditure during the
9 fiscal year ending June 30, 2020; therefore

Be it enacted by the Legislature of West Virginia:

1 That chapter 31, Acts of the Legislature, Regular Session, 2019, known as the budget bill,
2 be supplemented and amended by adding to Title II, section three thereof, the following:

3 **TITLE II – APPROPRIATIONS.**

4 **Sec. 3. Appropriations from other funds.**
