1 AN ACT supplementing and amending by decreasing an existing appropriation and adding a new
2 appropriation of federal funds out of the Treasury to the Department of Veterans'
3 Assistance, fund 8858, fiscal year 2020, organization 0613, by supplementing, amending,
4 decreasing, and adding an appropriation for the fiscal year ending June 30, 2020.

5 Whereas, The Governor has established the availability of federal funds for expenditure
