1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury  
2 from the balance of moneys remaining as an unappropriated surplus balance in the State  
3 Fund, General Revenue, to the Department of Health and Human Resources, Division of  
4 Human Services, fund 0403, fiscal year 2019, organization 0511, by supplementing and  
5 amending the appropriations for the fiscal year ending June 30, 2019.

6 Whereas, The Governor submitted to the Legislature the Executive Budget Document,  
7 dated January 9, 2019, which included a statement of the State Fund, General Revenue, setting  
8 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of  
9 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular  
10 appropriations for the fiscal year 2019; and

11 Whereas, The Governor submitted to the Legislature an Executive Message dated March  
12 5, 2019, which included a revised estimate of revenues for the State Fund, General Revenue, for  
13 the fiscal year 2019; and

14 Whereas, The Governor submitted to the Legislature an Executive Message dated May  
15 20, 2019, which included a revised estimate of revenues for the State Fund, General Revenue,  
16 and a statement of the State Fund, General Revenue, for the fiscal year 2019; and

17 Whereas, It appears from the statement of the State Fund, General Revenue, and  
18 Executive Messages, there remains an unappropriated surplus balance in the State Treasury  
19 which is available for appropriation during the fiscal year ending June 30, 2019; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 0403, fiscal  
2 year 2019, organization 0511, be supplemented and amended by increasing an existing item of  
3 appropriation as follows:



18 provider staff compensation.






