Senate Bill 257

to the Committee on Finance]

1 A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,
2 for the fiscal year ending June 30, 2019, in the amount of \$1,120,000 from the Department
3 of Revenue, Insurance Commissioner – Insurance Commissioner Fund, fund 7152, fiscal
4 year 2019, organization 0704, and making a supplementary appropriation out of the
5 Treasury from the balance of moneys remaining unappropriated for the fiscal year ending
6 June 30, 2019, to the Department of Health and Human Resources, Division of Health –
7 Consolidated Medical Services Fund, fund 0525, fiscal year 2019, organization 0506, by
8 supplementing and amending the appropriations for the fiscal year ending June 30, 2019.

9 Whereas, The Legislature finds that the account balance in the Department of Revenue,
10 Insurance Commissioner – Insurance Commission Fund, fund 7152, fiscal year 2019,
11 organization 0704, exceeds that which is necessary for the purposes for which the accounts were
12 established; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,
2 2019, in the Department of Revenue Insurance Commissioner - Insurance Commission Fund,
3 Fund 7152, Fiscal Year 2019, Organization 0704, be decreased by expiring the amount of
4 \$1,120,000, to the unappropriated surplus balance of the State Fund, General Revenue, to be
5 available for appropriation during the fiscal year ending June 30, 2019.

6 And, That the total appropriation for the fiscal year ending June 30, 2019, to Fund 0525,
7 Fiscal Year 2019, Organization 0506, be supplemented and amended by increasing an existing
8 item of appropriation and by adding a new item of appropriation as follows:
