1 A BILL making a supplementary appropriation of federal funds out of the Treasury from the
 2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
 3 2019, to the Department of Health and Human Resources, Division of Health – Community
 4 Mental Health Services, fund 8794, fiscal year 2019, organization 0506, to the Department
 5 of Health and Human Resources, Division of Human Services – Energy Assistance, fund
 6 8755, fiscal year 2019, organization 0511, and to the Department of Health and Human
 7 Resources, Division of Human Services – Child Care and Development, fund 8817, fiscal
 8 year 2019, organization 0511, by supplementing and amending the appropriations for the
 9 fiscal year ending June 30, 2019.

10 Whereas, The Governor has established the availability of federal funds for expenditure
 11 in the fiscal year ending June 30, 2019, which is hereby appropriated by the terms of this
 12 supplementary appropriation bill; therefore
