1 A BILL finding and declaring certain claims against the state and its agencies to be moral
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

Be it enacted by the Legislature of West Virginia:

**§1. Finding and declaring certain claims against the Department of Administration;
Department of Administration, Office of Technology; Enterprise Resource Planning
Board; Department of Environmental Protection; Department of Health and Human
Resources; Department of Health and Human Resources, Bureau for Behavioral
Health and Health Facilities; Department of Health and Human Resources, Bureau
for Public Health; Department of Health and Human Resources, Office of Chief
Medical Examiner; Department of Health and Human Resources, Office of
Laboratory Services; Department of Military Affairs & Public Safety, Division of
Corrections and Rehabilitation; Department of Military Affairs & Public Safety,
Division of Corrections and Rehabilitation, Regional Jail Authority; Department of
Military Affairs & Public Safety, Regional Jail and Correctional Facility Authority;
Secretary of State; Department of Transportation, Division of Highways;
Department of Transportation, Division of Motor Vehicles; and Department of
Veterans Assistance to be moral obligations of the state and directing payment
thereof.**

1 The Legislature has considered the findings of fact and recommendations reported to it
2 by the Legislative Claims Commission concerning various claims against the state and agencies
3 thereof and in respect to each of the following claims, the Legislature adopts those findings of fact
4 as its own and in respect of the claims herein, the Legislature has independently made findings
5 of fact and determinations of award and hereby declares it to be the moral obligation of the state
6 to pay each such claim in the amount specified below and directs the Auditor to issue warrants
7 for the payment thereof out of any fund appropriated and available for the purpose.

8 The Legislature finds that the above moral obligations and the appropriations made in
9 satisfaction thereof shall be the full compensation for all claimants and that prior to the payments
10 to any claimant provided in this bill, the Legislative Claims Commission shall receive a release
11 from said claimant releasing any and all claims for moral obligations arising from the matters
12 considered by the Legislature in the finding of the moral obligations and the making of the
13 appropriations for said claimant. The Legislative Claims Commission shall deliver all releases
14 obtained from claimants to the department against which the claim was allowed.

NOTE: The purpose of this bill is to declare certain claims against the state to be moral

obligations of the state and to authorize payments therefor from the following funds:

GENERAL REVENUE FUND: \$773,043.66

SPECIAL REVENUE FUNDS: \$6,769.71
