1 A BILL to amend and reenact §17A-3-23 of the Code of West Virginia, 1931, as amended, relating
2 to altering the color scheme for county vehicle registration plates; altering the color
3 scheme for city or municipality vehicle registration plates; providing that all county vehicle
4 registration plates, title certificates, and registration certificates shall expire on December
5 31, 2019; providing for exemptions for certain county Class A license plates; requiring all
6 counties to obtain a new title certificate, registration certificate, and registration plate for
7 all county vehicles prior to January 1, 2020; requiring renewal every two years; providing
8 that all city and municipal registration plates, title certificates, and registration certificates
9 shall expire on December 31, 2019; providing for exemptions for certain city and municipal
10 Class A license plates; requiring all cities or municipalities to obtain a new title certificate,
11 registration certificate, and registration plate for all city or municipality vehicles prior to
12 January 1, 2020; and requiring renewal every two years.

Be it enacted by the Legislature of West Virginia:

**ARTICLE 3. ORIGINAL AND RENWEAL OF REGISTRATION; ISSUANCE OF
CERTIFICATES OF TITLE.**

**§17A-3-23. Registration plates to state, county, municipal and other governmental
vehicles; use for undercover activities.**

1 (a) Any motor vehicle designed to carry passengers, owned or leased by the State of West
2 Virginia, or any of its departments, bureaus, commissions, or institutions, except vehicles used
3 by the Governor, Treasurer, not to exceed eight vehicles operated by investigators of the Office
4 of the Attorney General, three vehicles per elected office of the Board of Public Works not
5 otherwise specified, vehicles operated by the State Police, not to exceed five vehicles operated
6 by the office of the Secretary of Military Affairs and Public Safety, not to exceed five vehicles
7 operated by the Division of Homeland Security and Emergency Management, vehicles operated
8 by natural resources police officers of the Division of Natural Resources, not to exceed 10 vehicles

9 operated by the arson investigators of the Office of State Fire Marshal, not to exceed two vehicles
10 operated by the Division of Protective Services, not to exceed 16 vehicles operated by inspectors
11 of the Office of the Alcohol Beverage Control Commissioner, vehicles operated by the West
12 Virginia Wing of the Civil Air Patrol, and vehicles operated by probation officers employed under
13 the Supreme Court of Appeals may not be operated or driven by any person unless it has
14 displayed and attached to the front thereof, in the same manner as regular motor vehicle
15 registration plates are attached, a plate of the same size as the regular registration plate, with
16 white lettering on a green background bearing the words "West Virginia" in one line and the words
17 "State Car" in another line, and the lettering for the words "State Car" shall be of sufficient size to
18 be plainly readable from a distance of 100 feet during daylight: *Provided*, That beginning January
19 1, 2019, state vehicle license plates shall be gold with blue lettering.

20 The vehicle shall also have attached to the rear a plate bearing a number and any other
21 words and figures as the Commissioner of Motor Vehicles shall prescribe. The rear plate shall
22 also be green with the number in white: *Provided*, That beginning January 1, 2019, state vehicle
23 license plates shall be gold with blue lettering.

24 (b) Registration plates issued to vehicles owned by counties shall be white on red with the
25 word "County" on top of the plate and the words "West Virginia" on the bottom: *Provided, That*
26 beginning January 1, 2020 county vehicles registration plates shall be purple with white lettering.

27 (c) Registration plates issued to a city or municipality shall be white on blue with the word
28 "City" on top and the words "West Virginia" on the bottom: *Provided, That beginning January 1,*
29 2020 city or municipal vehicles registration plates shall be yellow with black lettering.

30 (d) Registration plates issued to a city or municipality law-enforcement department shall
31 include blue lettering on a white background with the words "West Virginia" on top of the plate
32 and shall be further designed by the commissioner to include a law-enforcement shield together
33 with other insignia or lettering sufficient to identify the motor vehicle as a municipal law-
34 enforcement department motor vehicle. The colors may not be reversed and shall be of

35 reflectorized material. The registration plates issued to counties, municipalities, and other
36 governmental agencies authorized to receive colored plates hereunder shall be affixed to both
37 the front and rear of the vehicles.

38 (e) (1) Registration plates issued to vehicles operated by county sheriffs shall be designed
39 by the commissioner in cooperation with the sheriffs' association with the word "Sheriff" on top of
40 the plate and the words "West Virginia" on the bottom. The plate shall contain a gold shield
41 representing the sheriff's star and a number assigned to that plate by the commissioner. Every
42 county sheriff shall provide the commissioner with a list of vehicles operated by the sheriff, unless
43 otherwise provided in this section, and a fee of \$10 for each vehicle submitted by July 1, 2002.

44 (2) Registration plates issued to vehicles operated by the West Virginia Wing of the Civil
45 Air Patrol shall be designed by the commissioner in cooperation with the Civil Air Patrol and
46 include the words "Civil Air Patrol" on the plate. The Civil Air Patrol shall provide the commissioner
47 with a list of vehicles operated by the Civil Air Patrol, unless otherwise provided in this section,
48 and a fee of \$10 for each new vehicle for which a Civil Air Patrol license plate is requested.

49 (f) The commissioner is authorized to designate the colors and design of any other
50 registration plates that are issued without charge to any other agency or nonstate government
51 entity entitled to registration plates at no charge in accordance with the motor vehicle
52 laws: *Provided*, That where the institutions of higher education opt to have their logo displayed on
53 the state license plate, such institution shall bear any additional costs of those added features:
54 *Provided, however*, That no public service districts or designated nongovernmental organizations
55 shall be issued a license plate designated for vehicles owned or leased by the State of West
56 Virginia, or any of its departments, bureaus, commissions, or institutions.

57 (g) Upon application, the commissioner is authorized to issue a maximum of five Class A
58 license plates per applicant to be used by county sheriffs and municipalities on law-enforcement
59 vehicles while engaged in undercover investigations.

60 (h) The commissioner is authorized to issue a maximum of five Class A license plates to
61 be used on vehicles assigned to the Division of Motor Vehicles investigators for commercial driver
62 examination fraud investigation and driver's license issuance fraud detection and fraud
63 prevention.

64 (i) The commissioner is authorized to issue an unlimited number of license plates per
65 applicant to authorized drug and violent crime task forces in the State of West Virginia when the
66 chairperson of the control group of a drug and violent crime task force signs a written affidavit
67 stating that the vehicle or vehicles for which the plates are being requested will be used only for
68 official undercover work conducted by a drug and violent crime task force.

69 (j) The commissioner is authorized to issue 20 Class A license plates to the Criminal
70 Investigation Division of the Department of Revenue for use by its investigators.

71 (k) The commissioner may issue a maximum of 10 Class A license plates to the Division
72 of Natural Resources for use by natural resources police officers. The commissioner shall
73 designate the color and design of the registration plates to be displayed on the front and the rear
74 of all other state-owned vehicles owned by the Division of Natural Resources and operated by
75 natural resources police officers.

76 (l) The commissioner is authorized to issue an unlimited number of Class A license plates
77 to the Commission on Special Investigations for state-owned vehicles used for official undercover
78 work conducted by the Commission on Special Investigations.

79 (m) The commissioner is authorized to issue a maximum of two Class A plates to the
80 Division of Protective Services for state-owned vehicles used by the Division of Protective
81 Services in fulfilling its mission.

82 (n) The commissioner is authorized to issue Class A registration plates for vehicles used
83 by the Medicaid Fraud Control Unit created by §9-7-7 of this code.

84 (o) The commissioner is authorized to issue Class A registration plates for vehicles used
85 by the West Virginia Insurance Fraud Unit created by §33-41-8 of this code.

86 (p) No other registration plate may be issued for, or attached to, any state-owned vehicle.

87 (q) The Commissioner of Motor Vehicles shall have a sufficient number of both front and
88 rear plates produced to attach to all state-owned or leased vehicles.

89 (r) The commissioner shall, after consultation with the Fleet Management Division
90 established pursuant to §5A-12-1 *et seq.* of this code and the Enterprise Resource Planning
91 Board established pursuant to §12-6D-1 *et seq.* of this code, develop and adopt a standardized
92 naming convention for the title, registration, and licensing of state vehicles, pursuant to §17A-3-
93 25 of this code. The naming convention adopted shall be consistent with the naming convention
94 adopted for the centralized accounting system as maintained by the Enterprise Resource
95 Planning Board for the purpose of creating and maintaining an accurate and up to date inventory
96 of the state vehicle fleet.

97 (s) It is the duty of each office, department, bureau, commission, or institution furnished
98 any vehicle to have plates as described herein affixed thereto prior to the operation of the vehicle
99 by any official or employee.

100 (t) The commissioner may issue special registration plates for motor vehicles titled in the
101 name of the Division of Public Transit or in the name of a public transit authority as defined in this
102 subsection and operated by a public transit authority or a public transit provider to transport
103 persons in the public interest. For purposes of this subsection, "public transit authority" means an
104 urban mass transportation authority created pursuant to §8-27-1 *et seq.* of this code or a nonprofit
105 entity exempt from federal and state income taxes under the Internal Revenue Code and whose
106 purpose is to provide mass transportation to the public at large. The special registration plate shall
107 be designed by the commissioner and shall display the words "public transit" or words or letters
108 of similar effect to indicate the public purpose of the use of the vehicle. The special registration
109 plate shall be issued without charge.

110 (u) Each green registration plate with white letters affixed to a state vehicle, and each
111 corresponding title and registration certificate for all state vehicles, other than those vehicles with

112 Class A registration plates as provided in this section, terminates at midnight on December 31,
113 2018. Each spending unit assigned a state vehicle that is required to display a state vehicle
114 license plate and registration shall obtain a new title, new registration card, and new state vehicle
115 license plate prior to January 1, 2019: *Provided*, That no state vehicle license plate shall be issued
116 unless the spending unit has provided an affirmative statement that the vehicle is a state asset
117 recorded in the central accounting system as maintained by the Enterprise Resource Planning
118 Board, and the same has been verified by the commissioner, as required by §17A-3-25 of this
119 code. When new registrations are issued pursuant to this article and for subsequent, non-Class
120 A registrations of state owned or leased vehicles, the state vehicle registration plate and certificate
121 shall be valid for a period of not more than 24 months and shall be required to be renewed every
122 two years.

123 (v) The commissioner is authorized to prepare and promulgate emergency rules, pursuant
124 to §29A-3-1 *et seq.* of this code in order to implement amendments to this section.

125 (w) Any person who violates the provisions of this section is guilty of a misdemeanor and,
126 upon conviction thereof, shall be fined not less than \$50 nor more than \$100. Magistrates have
127 concurrent jurisdiction with circuit courts for the enforcement of this section.

128 (x) Each red registration plate with white lettering affixed to a county vehicle, and each
129 corresponding title and registration certificate for all county vehicles, other than those vehicles
130 with Class A registration plates as provided in this section, terminates at midnight on December
131 31, 2019. Each county shall obtain a new title, new registration card, and new vehicle license
132 plate prior to January 1, 2020. When new registrations are issued pursuant to this article and for
133 subsequent, non-Class A registrations of county-owned or leased vehicles, the county vehicle
134 registration plate and certificate shall be valid for a period of not more than 24 months and shall
135 be required to be renewed every two years.

136 (y) Each blue registration plate with white letters affixed to a city or municipal vehicle, and
137 each corresponding title and registration certificate for all city or municipal vehicles, other than

138 those vehicles with Class A registration plates as provided in this section, terminates at midnight
139 on December 31, 2019. Each city or municipality shall obtain a new title, new registration card,
140 and new vehicle license plate prior to January 1, 2020. When new registrations are issued
141 pursuant to this article and for subsequent, non-Class A registrations of city or municipality-owned
142 or leased vehicles, the city or municipal vehicle registration plate and certificate shall be valid for
143 a period of not more than 24 months and shall be required to be renewed every two years.

NOTE: The purpose of this bill is to alter the color scheme for county vehicle registration plates; alter the color scheme for city or municipality vehicle registration plates; provide that all county vehicle registration plates, title certificates, and registration certificates shall expire on December 31, 2019; provide for exemptions for certain county Class A license plates; require all counties to obtain a new title certificate, registration certificate, and registration plate for all county vehicles prior to January 1, 2020; require renewal every two years; provide that all city and municipal registration plates, title certificates, and registration certificates shall expire on December 31, 2019; provide for exemptions for certain city and municipal Class A license plates; require all cities or municipalities to obtain a new title certificate, registration certificate, and registration plate for all city or municipality vehicles prior to January 1, 2020; and require renewal every two years.
