1 AN ACT supplementing and amending by adding a new appropriation of public moneys out of the
2 Treasury in the State Fund, General Revenue, to the Department of Revenue, State
3 Budget Office, Fund 0595, fiscal year 2019, organization 0703, by supplementing and
4 amending the appropriations for the fiscal year ending June 30, 2019.

1 Whereas, The Governor submitted to the Legislature the Executive Budget document,
2 dated January 9, 2019, which included a Statement of the State Fund, General Revenue, setting
3 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of
4 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular
5 appropriations for the fiscal year 2019; and

6 Whereas, It appears from the Executive Budget document, Statement of the State Fund,
7 General Revenue there remains an unappropriated balance in the State Treasury which is
8 available for appropriation during the fiscal year ending June 30, 2019; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2019, to Fund 0595, fiscal
2 year 2019, organization 0703, be supplemented and amended by adding a new item of
3 appropriation as follows:

TITLE II – APPROPRIATIONS.

Section 1. Appropriations from general revenue.

14 The above appropriation for PEIA Rainy Day Fee (Fund 0595, appropriation 01201) may
15 be allocated and transferred to various General Revenue Funds to be used for payment of the
16 PEIA Rainy Day Fee assessed by the Secretary of Revenue authorized in §5-16-27 of the code.
17 Receiving agencies shall transfer the allocated funds to the PEIA Rainy Day Fund prior to the
18 close of the fiscal year 2019. Any balance remaining in the appropriation after allocation shall be
19 transferred to the PEIA Rainy Day Fund prior to the close of the fiscal year 2019.
