# **CHAPTER 30. PROFESSIONS AND OCCUPATIONS.**

## ARTICLE 11. WEST VIRGINIA CONTRACTOR LICENSING ACT.

# §30-11-1. Short title.

1 This article shall be known and may be cited as the "West Virginia Contractor Licensing"

2 <u>Act".</u>

#### §30-11-2. Policy declared.

- 1 It is hereby declared to be the policy of the State of West Virginia that all persons desiring
- 2 to perform contracting work in this state be duly licensed to ensure capable and skilled
- 3 craftsmanship utilized in construction projects in this state, both public and private, fair bidding
- 4 practices between competing contractors through uniform compliance with the laws of this state,
- 5 and protection of the public from unfair, unsafe, and unscrupulous bidding and construction
- 6 <u>practices.</u>

#### §30-11-3. Definitions.

- 1 "Commissioner" means the Commissioner of the Division of Labor.
- 2 "Board" means the West Virginia Contractor Licensing Board.
- 3 <u>"Contractor" means a person who in any capacity for compensation, other than as an</u>
- 4 employee of another, undertakes, offers to undertake, purports to have the capacity to undertake
- 5 or submits a bid to construct, alter, repair, add to, subtract from, improve, move, wreck or demolish
- 6 any building, highway, road, railroad, structure or excavation associated with a project,
- 7 development or improvement, or to do any part thereof, including the erection of scaffolding or
- 8 other structures or works in connection therewith, where the cost of the undertaking is \$2,500 or
- 9 more.
- 10 <u>Contractor includes a construction manager who performs management and counseling</u>

11	services for a construction project for a professional fee.
12	Contractor does not include:
13	(1) One who merely furnishes materials or supplies without fabricating or consuming them
14	in the construction project;
15	(2) A person who personally performs construction work on the site of real property which
16	the person owns or leases whether for commercial or residential purposes;
17	(3) A person who is licensed or registered as a professional and who functions under the
18	control of any other licensing or regulatory board, whose primary business is real estate sales,
19	appraisal, development, management, and maintenance, who acting in his or her respective
20	professional capacity and any employee of such professional, acting in the course of his or her
21	employment, performs any work which may be considered to be performing contracting work;
22	(4) A pest control operator licensed under the provisions of §19-16A-7 of this code to
23	engage in the application of pesticides for hire, unless the operator also performs structural
24	repairs exceeding \$1,000 on property treated for insect pests; or
25	(5) A corporation, partnership or sole proprietorship whose primary purpose is to prepare
26	construction plans and specifications used by the contractors defined in this subsection and who
27	employs full time, a registered architect licensed to practice in this state or a registered
28	professional engineer licensed to practice in this state. Employees of such corporation,
29	partnership, or sole proprietorship shall also be exempt from the requirements of this article.
30	"Electrical contractor" means a person who engages in the business of contracting to
31	install, erect, repair, or alter electrical equipment for the generation, transmission, or utilization of
32	electrical energy.
33	"General building contractor" means a person whose principal business is in connection
34	with any structures built, being built, or to be built for the support, shelter, and enclosure of
35	persons, animals, chattels, or movable property of any kind, requiring in the construction the use
36	of more than two contractor classifications, or a person who supervises the whole or any part of

"General engineering contractor" means a person whose principal business is in connection with public or private works projects, including, but not limited to, one or more of the following: Irrigation, drainage and water supply projects; electrical generation projects; swimming pools; flood control; harbors; railroads; highways; tunnels; airports and airways; sewers and sewage disposal systems; bridges; inland waterways; pipelines for transmission of petroleum and other liquid or gaseous substances; refineries; chemical plants and other industrial plants requiring a specialized engineering knowledge and skill; piers and foundations; and structures or work incidental thereto.

"Heating, ventilating, and cooling contractor" means a person who engages in the business of contracting to install, erect, repair, service, or alter heating, ventilating, and air conditioning equipment or systems to heat, cool, or ventilate residential and commercial structures.

"License" means a license to engage in business in this state as a contractor in one of the classifications set out in this article.

"Multifamily contractor" means a person who is engaged in construction, repair, or improvement of a multifamily residential structure.

"Person" includes an individual, firm, sole proprietorship, partnership, corporation, association, or other entity engaged in the undertaking of construction projects or any combination thereof.

"Piping contractor" means a person whose principal business is the installation of process, power plant, air, oil, gasoline, chemical, or other kinds of piping; and boilers and pressure vessels using joining methods of thread, weld, solvent weld, or mechanical methods.

"Plumbing contractor" means a person whose principal business is the installation, maintenance, extension, and alteration of piping, plumbing fixtures, plumbing appliances and plumbing appurtenances, venting systems, and public or private water supply systems within or

63	adjacent to any building or structure; included in this definition is installation of gas piping, chilled
64	water piping in connection with refrigeration processes and comfort cooling, hot water piping in
65	connection with building heating, and piping for stand pipes.
66	"Residential contractor" means a person whose principal business is in connection with
67	construction, repair, or improvement of real property used as, or intended to be used for,
68	residential occupancy.
69	"Specialty contractor" means a person who engages in specialty contracting services
70	which do not substantially fall within the scope of any contractor classification as set out herein.
71	"Residential occupancy" means occupancy of a structure for residential purposes for
72	periods greater than 30 consecutive calendar days.
73	"Residential structure" means a building or structure used or intended to be used for
74	residential occupancy, together with related facilities appurtenant to the premises as an adjunct
75	of residential occupancy, which contains not more than three distinct floors which are above grade
76	in any structural unit regardless of whether the building or structure is designed and constructed
77	for one or more living units. Dormitories, hotels, motels, or other transient lodging units are not
78	residential structures.
79	"Subcontractor" means a person who performs a portion of a project undertaken by a
80	principal or general contractor or another subcontractor.
81	"Division" means the Division of Labor.
82	"Cease and desist order" means an order issued by the commissioner pursuant to the
83	provisions of this article.
84	The term "basic universal design" means the design of products and environments to be
85	useable by all people, to the greatest extent possible, without the need for adaptation or
86	specialization.

§30-11-4. West Virginia contractor licensing board created; members; appointment; terms; vacancies; qualifications; quorum.

(a) The West Virginia contractor licensing board is continued. The board shall consist of 10 members appointed by the Governor by and with the advice and consent of the Senate for terms of four years. Such members shall serve until their successors are appointed and have qualified. Eight of the appointed members shall be owners of businesses engaged in the various contracting industries, with at least one member appointed from each of the following contractor classes: One electrical contractor, one general building contractor, one general engineering contractor, one heating, ventilating and cooling contractor, one multifamily contractor, one piping contractor, one plumbing contractor, and one residential contractor. Two of the appointed members shall be building code officials who are not members of any contracting industry. At least three members of the board shall reside at the time of their appointment in each congressional district as existing on January 1, 1998. The commissioner of labor, the secretary of the Department of Tax and Revenue or his or her designee, and the commissioner of WorkForce West Virginia or his or her designee shall be ex officio, nonvoting members of the board.

(b) Terms of the members first appointed shall be two members for one year, two members for two years, three members for three years and three members for four years, as designated by the Governor at the time of appointment. Thereafter, terms shall be for four years. A member who has served all or part of two consecutive terms shall not be subject to reappointment unless four years have elapsed since the member last served. Vacancies shall be filled by appointment by the Governor for the unexpired term of any member whose office is vacant and shall be made within 60 days of the occurrence of the vacancy. A vacancy on the board shall not impair the right of the remaining members to exercise all the powers of the board.

(c) The board shall elect a chair from one of the voting members of the board. The board shall meet at least once annually and at such other times as called by the chair or a majority of the board. Board members shall receive compensation not to exceed the amount paid to members of the Legislature for the interim duties as recommended by the citizens legislative

	§30-11-5. Administrative duties of the board; regulations.
1	(a) The board shall propose rules for legislative approval in accordance with the provisions
2	of §29-3-1 et seq. of this code relating to the following:
3	(1) The minimum qualifications for applicants for examination and license in each of the
4	following specified classes of contractor:
5	(A) Electrical contractor;
6	(B) General building contractor:
7	(C) General engineering contractor;
8	(D) Heating, ventilating, and cooling contractor;
9	(E) Multifamily contractor;
10	(F) Piping contractor;
11	(G) Plumbing contractor;
12	(H) Residential contractor; or
13	(I) Specialty contractor.
14	(2) The content of examinations for applicants in each class;
15	(3) Procedures for application, examination, and license renewal, and the manner in which
16	the examination will be conducted;
17	(4) The continued competency of licensees for purposes of renewal and reinstatement of
18	licenses; and
19	(5) Procedures for disciplinary action before the board.
20	(b) The board shall:
21	(1) Hold at least one examination in each calendar quarter for each specific classification

22	of contractor, designate the time and place of such examinations, and notify applicants thereof;
23	(2) Request, through the division, investigation of any alleged violation of this article or of
24	the regulations;
25	(3) Forward results of examinations to the division within 20 days following the
26	examination:
27	(4) Notify the commissioner and board members of meeting dates and agenda items at
28	least five days prior to such meetings; and
29	(5) Take minutes and records of all meetings and proceedings.
	§30-11-6. Necessity for license; exemptions.
1	(a) No person may engage in this state in any act as a contractor, or submit a bid to
2	perform work as a contractor, as defined in this article, unless such person holds a license issued
3	under the provisions of this article. No firm, partnership, corporation, association or other entity
4	shall engage in contracting in this state unless an officer thereof holds a license issued pursuant
5	to this article.
6	(b) Any person to whom a license has been issued under this article shall keep the license
7	or a copy thereof posted in a conspicuous position at every construction site where work is being
8	done by the contractor. The contractor's license number shall be included in all contracting
9	advertisements and all fully executed and binding contracts. Any person violating the provisions
10	of this subsection shall be subject, after hearing, to a warning, a reprimand, or a fine of not more
11	than \$200.
12	(c) Except as otherwise provided in this code, the following are exempt from licensure:
13	(1) Work done exclusively by employees of the United States Government, the State of
14	West Virginia, a county, municipality or municipal corporation, and any governmental subdivision
15	or agency thereof;
16	(2) The sale or installation of a finished product, material, or article or merchandise, which
17	is not actually fabricated into and does not become a permanent fixed part of the structure:

18	(3) Work performed personally by an owner or lessee of real property on property the
19	primary use of which is for agricultural or farming enterprise;
20	(4) A material supplier who renders advice concerning use of products sold and who does
21	not provide construction or installation services;
22	(5) Work performed by a public utility company regulated by the West Virginia Public
23	Service Commission and its employees;
24	(6) Repair work contracted for by the owner of the equipment on an emergency basis in
25	order to maintain or restore the operation of such equipment;
26	(7) Work performed by an employer's regular employees, for which the employees are
27	paid regular wages and not a contract price, on property owned or leased by the employer which
28	is not intended for speculative sale or lease;
29	(8) Work personally performed on a structure by the owner or occupant thereof; and
30	(9) Work performed when the specifications for such work have been developed or
31	approved by engineering personnel employed by the owner of a facility by registered professional
32	engineers licensed pursuant to the laws of this state when the work to be performed because of
33	its specialized nature or process cannot be reasonably or timely contracted for within the general
34	area of the facility.
	§30-11-7. Application for and issuance of license.
1	(a) A person desiring to be licensed as a contractor under this article shall submit to the
2	board a written application requesting licensure, providing the applicant's social security number
3	and such other information as the board may require on forms supplied by the board. The
4	applicant shall pay a license fee not to exceed \$150: Provided, That electrical contractors already
5	licensed under §29-3B-4 of this code shall pay no more than \$20.
6	(b) A person holding a business registration certificate to conduct business in this state as
7	a contractor on September 30, 1991, may register with the board, certify by affidavit the
8	requirements of \$30-11-15(c) of this code, and pay such license fee not to exceed \$150 and shall

be issued a contractor's license without further examination: *Provided*, That no license may be issued without examination pursuant to this subsection after April 1, 2002: *Provided*, *however*, That any person issued a contractor's license by the board pursuant to this subsection may apply to the board for transfer of the license to a new business entity in which the license holder is the principal owner, partner, or corporate officer: *Provided*, *further*, That a license holder may hold a license on behalf of only one business entity during a given time period. The board may transfer the license issued pursuant to this subsection to the new business entity without requiring examination of the license holder.

# §30-11-8. Licenses; expiration date; fees; renewal.

- (a) A license issued under the provisions of this article expires one year from the date on
   which it is issued. The board shall establish application and annual license fees not to exceed
   \$150.
  - (b) The board may propose rules for legislative approval in accordance with the provisions of §29-3-1 *et seg.* of this code to establish license and renewal fees.

#### §30-11-9. Unlawful use, assignment, transfer of license; revocation.

No license may be used for any purpose by any person other than the person to whom the license is issued. No license may be assigned, transferred, or otherwise disposed of so as to permit the unauthorized use thereof. No license issued pursuant to the provisions of §30-11-7(b) of this code may be assigned, transferred, or otherwise disposed of except as provided in said subsection. Any person who violates this section is subject to the penalties imposed in §30-11-13 of this code.

## §30-11-10. Prerequisites to obtaining building permit; mandatory written contracts.

(a) Any person making application to the building inspector or other authority of any incorporated municipality or other political subdivision in this state charged with the duty of issuing building or other permits for the construction of any building, highway, sewer, or structure or for any removal of materials or earth, grading, or improvement, shall, before issuance of the permit,

either furnish satisfactory proof to the inspector or authority that such person is duly licensed under the provisions of this article to carry out or superintend the same, or file a written affidavit that such person is not subject to licensure as a contractor or subcontractor as defined in this article. The inspector or authority may not issue a building permit to any person who does not possess a valid contractor's license when required by this article.

(b) Effective October 1, 2002, no person licensed under the provisions of this article may perform contracting work of an aggregate value of \$10,000 or more, including materials and labor, without a written contract, setting forth a description and cost of the work to be performed, signed by the licensee and the person for whom the work is to be performed.

(c) On or before June 1, 2002, the board shall file a procedural rule setting forth a standard contract form which meets the minimum requirements of this subsection for use by licensees. The board shall post the contract form on its website and shall assist licensees in the correct completion of the form. On or before August 1, 2002, the board shall mail a written notice of the requirements imposed by the rule to each licensed contractor at the address provided to the board by the contractor on his or her last application for licensure or renewal.

#### §30-11-10a. Informational list for basic universal design features; penalties.

- (a) Ninety days after the Contractor Licensing Board certifies and makes available to the general public the standard form informational list of basic universal design features pursuant to this section, a licensed contractor of any proposed residential housing in the state shall provide to the buyer an informational list of basic universal design features that would make the home entrance, interior routes of travel, the kitchen, and the bathroom or bathrooms universally accessible. Basic universal design features are to include, but not be limited to, the following:
- (1) At least one nonstep entrance into the dwelling;
- 8 (2) All doors on the entry-level floor, including bathrooms, have a minimum of thirty-six
  9 inches;
  - (3) At least one accessible bathroom on the entry-level floor with ample maneuvering

11 space;

(4) Kitchen, general living space, and one room capable of conversion into a bedroom, all with ample maneuvering space, on the entry-level floor; and

(5) Any other external or internal feature requested at a reasonable time by the buyer and agreed to by the seller.

(b) If a buyer is interested in a specific informational feature on the list established by subsection (a) of this section, the seller or builder upon request of the buyer shall indicate whether the feature is standard, limited, optional, or not available and, if available, shall further indicate the cost of such a feature to the buyer.

(c) The standard form informational list of basic universal design features shall be certified and made available for reproduction by the board, in accordance with the provisions of subsection (a) of this section, based on mutual recommendation of the board, the American Institute of Architects-West Virginia, the Home Builders Association of West Virginia, and the West Virginia Center for Excellence in Disabilities.

#### §30-11-11. Notice included with invitations to bid and specifications.

Any architect or engineer preparing any plan and specification for contracting work to be performed in this state shall include in the plan, specification, and invitation to bid a reference to this article informing any prospective bidder that the person's contractor's license number shall be included on any bid submission. A subcontractor shall furnish his or her contractor's license number to the contractor prior to the award of the contract. If an apparent low bidder for a public improvement project, as defined in §21-1D-1 et seq. of this code, fails to submit a license number in accordance with this section, the public authority, as defined in §21-1D-1 et seq. of this code, shall promptly request by telephone and electronic mail that the low bidder and the second low bidder provide the license number within one business day of the request. Failure of the bidder to provide the license number within one business day of receiving the request shall result in disqualification of the bid.

#### §30-11-12. License renewal, lapse and reinstatement.

(a) A license which is not renewed on or before the renewal date shall lapse. The board may establish by regulation a delayed renewal fee to be paid for issuance of any license which has lapsed: *Provided*, That no license which has lapsed for a period of 90 days or more may be renewed: *Provided*, *however*, That, if a licensee is in a dispute with a state agency, and it is determined that the licensee is not at fault, the board shall renew the license.

(b) In the event that continuing education or other requirements are made a condition of license reinstatement after lapse, suspension, or revocation, such requirements must be satisfied before the license is reissued.

# §30-11-13. Violation of article; injunction; criminal penalties.

- (a)(1) Upon a determination that a person is engaged in contracting business in the state without a valid license, the board or commissioner shall issue a cease and desist order requiring such person to immediately cease all operations in the state. The order shall be withdrawn upon issuance of a license to such person.
- (2) After affording an opportunity for a hearing, the board may impose a penalty of not less than \$200 nor more than \$1,000 upon any person engaging in contracting business in the state without a valid license. The board may accept payment of the penalty in lieu of a hearing.
- (3) Within 30 days after receipt of the final order issued pursuant to this section, any party adversely affected by the order may appeal the order to the circuit court of Kanawha County. West Virginia, or to the circuit court of the county in which the petitioner resides or does business.
- (b) Any person continuing to engage in contracting business in the state without a valid license after service of a cease and desist order is guilty of a misdemeanor and, upon conviction, is subject to the following penalties:
- 14 (1) For a first offense, a fine of not less than \$200 nor more than \$1,000;
- 15 (2) For a second offense, a fine of not less than \$500 nor more than \$5,000, or confinement in jail for not more than six months, or both;

(3) For a third or subsequent offense, a fine of not less than \$1,000 nor more than \$5,000,
and confinement in jail for not less than 30 days nor more than one year.

(c) The board may institute proceedings in the circuit court of the county in which the alleged violations of the provisions of this article occurred or are now occurring to enjoin any violation of any provision of this article.

(d) Any person who undertakes any construction work without a valid license when such license is required by this article, when the total cost of the contractor's construction contract on any project upon which the work is undertaken is \$25,000 or more, shall, in addition to any other penalty herein provided, be assessed by the board an administrative penalty not to exceed \$200 per day for each day the person is in violation.

#### §30-11-14. Disciplinary powers of the board.

- (a) The board has the power and authority to impose the following disciplinary actions:
- 2 (1) Permanently revoke a license;
- 3 (2) Suspend a license for a specified period;
- 4 (3) Censure or reprimand a licensee;
- 5 (4) Impose limitations or conditions on the professional practice of a licensee;
  - (5) Impose requirements for remedial professional education to correct deficiencies in the education, training and skill of a licensee;
  - (6) Impose a probationary period requiring a licensee to report regularly to the board on matters related to the grounds for probation; the board may withdraw probationary status if the deficiencies that require the sanction are remedied;
  - (7) Order a contractor who has been found, after hearing, to have violated any provision of this article or the rules of the board to provide, as a condition of licensure, assurance of financial responsibility. The form of financial assurance may include, but is not limited to, a surety bond, a cash bond, a certificate of deposit, an irrevocable letter of credit, or performance insurance:

    Provided, That the amount of financial assurance required under this subdivision may not exceed

16	the total of the aggregate amount of the judgments or liens levied against the contractor or the
17	aggregate value of any corrective work ordered by the board or both: Provided, however, That
18	the board may remove this requirement for licensees against whom no complaints have been
19	filed for a period of five continuous years; and
20	(8) A fine not to exceed \$1,000.
21	(b) No license issued under the provisions of this article may be suspended or revoked
22	without a prior hearing before the board: Provided, That the board may summarily suspend a
23	licensee pending a hearing or pending an appeal after hearing upon a determination that the
24	licensee poses a clear, significant, and immediate danger to the public health and safety.
25	(c) The board may reinstate the suspended or revoked license of a person if, upon a
26	hearing, the board finds and determines that the person is able to practice with skill and safety.
27	(d) The board may accept the voluntary surrender of a license: Provided, That the license
28	may not be reissued unless the board determines that the licensee is competent to resume
29	practice and the licensee pays the appropriate renewal fee.
30	(e) A person or contractor adversely affected by disciplinary action may appeal to the
31	heard within 60 days of the data the dissiplinary action is taken. The heard shall hear the appeal
	board within 60 days of the date the disciplinary action is taken. The board shall hear the appeal
32	within 30 days from receipt of notice of appeal in accordance with the provisions of Chapter 29A

#### §30-11-17. Recordkeeping; fees.

(a) The division shall keep a record of all actions taken and account for moneys received. All fees paid pursuant to this article shall be paid to the Commissioner of Labor and deposited in an appropriated special revenue account in the State Treasury to be known as the West Virginia Contractor Licensing Board Fund and expended for the implementation and enforcement of this article. Through June 30, 2019, amounts collected which are found from time-to-time to exceed the funds needed for purposes set forth in this article may be utilized by the commissioner as needed to meet the division's funding obligations: *Provided*, That beginning July 1, 2019, amounts collected may not be utilized by the commissioner as needed to meet the division's funding obligations. (b) The division shall maintain at its principal office, open for public inspection during regular office hours, a complete indexed record of all applications, licenses issued, licenses renewed, and all revocations, cancellations, and suspensions of licenses. Applications shall show the date of application, name, qualifications, place of business, and place of residence of each applicant, and whether the application was approved or refused. (c) (1) All investigations, complaints, reports, records, proceedings, and other information received by the commissioner and board and related to complaints made to the commissioner or board or investigations conducted by the commissioner or board pursuant to this article, including the identity of the complainant or respondent, shall be confidential and shall not be knowingly and improperly disclosed by any member or former member of the board, the commissioner or staff,

except as follows:

(A) Upon a finding that probable cause exists to believe that a respondent has violated the provisions of this article, the complaint and all reports, records, nonprivileged and nondeliberative materials introduced at any probable cause hearing held pursuant to the

complaint are thereafter not confidential: Provided, That confidentiality of such information sl	<u>nall</u>
remain in full force and effect until the respondent has been served with a copy of the statem	ent
of charges.	

- (B) Any subsequent hearing held in the matter for the purpose of receiving evidence or the arguments of the parties or their representatives shall be open to the public and all reports, records, and nondeliberative materials introduced into evidence at such subsequent hearing, as well as the board's and commissioner's orders, are not confidential.
- (C) The commissioner or board may release any information relating to an investigation at any time if the release has been agreed to in writing by the respondent.
- (D) The complaint as well as the identity of the complainant shall be disclosed to a person named as respondent in any such complaint filed immediately upon such respondent's request.
- (E) Where the commissioner or board is otherwise required by the provisions of this article to disclose such information or to proceed in such a manner that disclosure is necessary and required to fulfill such requirements.
- (2) If, in a specific case, the commissioner or board finds that there is a reasonable likelihood that the dissemination of information or opinion in connection with a pending or imminent proceeding will interfere with a fair hearing or otherwise prejudice the due administration of justice, the commissioner or board shall order that all or a portion of the information communicated to the commissioner or board to cause an investigation and all allegations of violations or misconduct contained in a complaint shall be confidential, and the person providing such information or filing a complaint shall be bound to confidentiality until further order of the board.
- (d) If any person violates the provisions of subsection (c) of this section by knowingly and willfully disclosing any information made confidential by such section or by the commissioner or board, such person is guilty of a misdemeanor and, upon conviction thereof, shall be fined not

less than \$500 nor more than \$5,000, or confined in jail not more than one month, or both fined

(e) The commissioner shall certify to the State Auditor and to the board a detailed statement of all moneys received and spent during the preceding fiscal year.

#### §30-11-18. Reciprocity.

To the extent that other states which provide for the licensing of contractors provide for similar action, the board, in its discretion, may grant licenses of the same or equivalent classification to contractors licensed by other states, without written examination, upon satisfactory proof furnished to the board that the qualifications of such applicants are equal to the qualifications of holders of similar licenses in this state, and upon certification to the commissioner as required by §30-11-15(c) of this code, and upon payment of the required fee.

# §30-11-19. Board authorized to provide training.

- (a) On behalf of the board, the division may enter into work-sharing agreements with state vocational and technical training schools to provide classroom training to students who desire to obtain a West Virginia contractor license. The purpose of the training is limited to instruction applicable to the contractor license examinations required by the board. The terms of the work-sharing agreements shall be determined by the West Virginia contractor licensing board and county boards of education.
- (b) For the purposes of this section, the division is authorized to expend funds from its
   special revenue account, known as the Contractor Licensing Fund, to support this activity.

NOTE: The purpose of this bill is to move the provisions relating to the licensing of contractors to Chapter 30 of the Code, where other professional licensing laws are maintained.

This bill is recommended by the Joint Standing Committee on Government Organization for introduction and passage in the 2020 Regular Session.
