1 A BILL to amend and reenact §4-10-10 of the Code of West Virginia, 1931, as amended, relating  
2 to updating the regulatory board review schedule.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 10. PERFORMANCE REVIEW ACT.**

**§4-10-10. Regulatory board review schedule.**

1 (a) A regulatory board review is required for all regulatory boards.

2 (b) A regulatory board review shall be performed on each regulatory board at least once  
3 every 12 years, commencing as follows:

4 ~~(1) 2017: Board of Accountancy; Board of Respiratory Care Practitioners; and Board of~~

6 ~~(2) 2018: Board of Examiners of Psychologists; Board of Optometry; and Board of~~

NOTE: The purpose of this bill is to update the regulatory board review schedule.
