## House Bill 4444

A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, designated §29-32-1; to amend said code by adding thereto a new article, designated §29-33-1; and to amend said code by adding thereto a new article, designated §29-34-1, all relating to establishing Medals of Valor and Medals for Bravery for emergency medical services, firefighters, and law-enforcement officers; creating the Emergency Medical Services Honor Board, the Firefighters Honor Board, and the Law-Enforcement Officers Honor Board; establishing Medals of Honor for those EMS personnel, firefighters and law-enforcement officers who go above and beyond "the call of duty"; and establishing membership and duties of the boards.

Be it enacted by the Legislature of West Virginia:

### ARTICLE 32. EMERGENCY MEDICAL SERVICES HONOR BOARD.

#### §29-32-1. Emergency Medical Services Honor Board.

- (a) The Emergency Medical Services Honor Board is established as an advisory board to the Legislature. The purpose of the board is to make recommendations for persons deemed worthy to be awarded a "Medal of Valor" to recognize members of the Emergency Medical Service in West Virginia who, in the performance of their duties, go above and beyond the "call of duty" in rendering medical care to those they serve whether it be in the saving of life, eliminating or reducing pain or prevention of further injury.
- 7 <u>(b) Board membership. --</u>

- 8 (1) The board shall consist of two members from each of the state's senatorial districts;
- 9 (2) Each State Senator shall appoint one member representing his or her district;
  - (3) The board shall be comprised of emergency medical services personnel, medical officials, doctors and other professionals who are qualified to evaluate and determine whether the actions of emergency medical services first responders rise to the level of
- 13 <u>being above and beyond the "call of duty";</u>
  - (4) Members shall serve a one-year term; and

15	(5) Members of the board serve without compensation.
16	(c) The board may consider candidates for the Medal of Valor who are identified by
17	members of the board or by other citizens, and may design a system for the receipt of those
18	recommendations.
19	(d) The board shall review identified individuals to determine if those emergency medical
20	services first responders have gone above and beyond the call of duty in their professional
21	capacities. Upon determination that an emergency medical services first responder is worthy of
22	this honor, the board shall submit the nomination to Speaker of the House and the President of
23	the Senate for consideration by the Legislature.
24	(e) Upon nomination by the Emergency Medical Services Honor Board, and adoption of a
25	concurrent resolution by the Legislature, the Governor shall bestow upon the nominee the Medal
26	of Valor.
27	(f) The Division of Arts, Culture and History shall create the design for the "Medal of Valor".

Law-Enforcement Officers Honor Board. 1 (a) The Law-Enforcement Officers Honor Board is established. 2 (b) The purpose of the board is to establish a "Medal for Bravery" award to recognize law-enforcement officers in West Virginia who, in the performance of their duties, go above 3 4 and beyond the "call of duty". 5 (c) It is the intent of the Legislature that the board nominate, review and select those 6 firefighters who have gone above and beyond the "call of duty" in their professional law 7 enforcement capacities; 8 (d) Board membership. --9 (1) The board shall consist of one member from each of the state's senatorial districts; 10 (2) Members shall be appointed by the State Senator representing that district; 11 (3) The board shall be comprised of law enforcement officials such as sheriffs and 12 police captains, and other professionals who are qualified to evaluate and determine 13 whether the actions of law- enforcement officers rise to the level of being above and beyond 14 the "call of duty"; and 15 (4) Members shall serve a one-year term. (e) Members of the board serve without compensation, but are entitled to reimbursement 16

for expenses, including travel expenses, which are actually incurred by the member in the official

- 19 (f) The Arts, Culture and History shall create the design for the "Medal for Bravery".

NOTE: The purpose of this bill is to create the Emergency Medical Services Honor Board, the Firefighters Honor Board, and the Law-Enforcement Officers Honor Board. The bill establishes Medals of Valor and Medals for Bravery for those EMS personnel, firefighters and law-enforcement officers who go above and beyond "the call of duty." The bill establishes membership and duties of the boards.

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
