1 A BILL making a supplementary appropriation of federal funds out of the Treasury from the
 2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
 3 2020, to the Department of Education, State Board of Education – State Department of
 4 Education, fund 8712, fiscal year 2020, organization 0402, to the Department of
 5 Education, State Board of Education – Vocational Division, fund 8714, fiscal year 2020,
 6 organization 0402, and to the Department of Education, State Board of Education – Aid
 7 for Exceptional Children, fund 8715, fiscal year 2020, organization 0402, by
 8 supplementing and amending the appropriations for the fiscal year ending June 30, 2020.

9 Whereas, The Governor has established the availability of federal funds for expenditure
 10 in the fiscal year ending June 30, 2020 which are hereby appropriated by the terms of this
 11 supplementary appropriation bill; therefore

12 *Be it enacted by the Legislature of West Virginia:*

13 That the total appropriation for the fiscal year ending June 30, 2020, to fund 8712, fiscal
 14 year 2020, organization 0402, be supplemented and amended by increasing an existing item of
