A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
designated §5-10-22m; and to amend said code by adding thereto a new section,
designated §18-7A-26x, all relating to a \$1,000 cost-of-living adjustment to certain retirees
of the Public Employees Retirement System and the State Teachers Retirement System
by June 30, 2021; and providing for the pro rata distribution of the cost-of-living adjustment
to certain beneficiaries.

Be it enacted by the Legislature of West Virginia:

CHAPTER 5. GENERAL POWERS AND AUTHORITY OF THE GOVERNOR, SECRETARY OF STATE AND ATTORNEY GENERAL; BOARD OF PUBLIC WORKS; MISCELLANEOUS AGENCIES, COMMISSIONS, OFFICES, PROGRAMS, ETC.

ARTICLE 10. WEST VIRGINIA PUBLIC EMPLOYEES RETIREMENT ACT.

<u>§5-10-22m. Cost-of-living adjustments for certain annuitants effective on or before June</u> 30, 2021.

1 (a) As an additional cost-of-living adjustment to other retirement allowances provided, a 2 cost-of-living adjustment to retirement benefits shall be paid to retirees of the system as provided 3 in subsection (b) of this section. The cost-of-living adjustment shall equal \$1,000 and shall be 4 paid in full by June 30, 2021. (b) The cost-of-living adjustment provided by this section applies to any retiree who 5 6 currently receives an annual retirement annuity. This cost-of-living adjustment is subject to any 7 applicable limitations under section 415 of the Internal Revenue Code of 1986, as amended. 8 (c) The cost-of-living adjustment provided by this section is payable pro rata to any 9 beneficiary of a qualifying retiree who currently receives an annuity or other benefit payable by

10 the system.

ARTICLE 7A. STATE TEACHERS RETIREMENT SYSTEM.

§18-7A-26x. Cost-of-living adjustments for certain annuitants effective on or before June

<u>30, 2021.</u>

- 1 (a) As an additional cost-of-living adjustment to other retirement allowances provided, a
- 2 cost-of-living adjustment to retirement benefits shall be paid to certain retirees of the retirement
- 3 system as provided in subsection (b) of this section. The cost-of-living adjustment shall equal
- 4 <u>\$1,000 and shall be paid in full by June 30, 2021.</u>
- 5 (b) The cost-of-living adjustment provided in this section applies to any retiree who
- 6 <u>currently receives an annual retirement annuity</u>. This cost-of-living adjustment is subject to any
- 7 applicable limitations under Section 415 of the Internal Revenue Code of 1986, as amended.
- 8 (c) The cost-of-living adjustment provided by this section is payable pro rata to any
- 9 <u>beneficiary of a qualifying retiree who currently receives an annuity or other benefit payable by</u>

10 <u>the retirement system.</u>
