1 AN ACT finding and declaring certain claims against the state and its agencies to be moral
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

Be it enacted by the Legislature of West Virginia:

CLAIMS AGAINST THE STATE.

§1. Finding and declaring certain claims against the Department of Commerce, Division of Natural Resources; Department of Environmental Protection; Department of Health and Human Resources; Department of Health and Human Resources, Office of Environmental Health Services; Department of Military Affairs and Public Safety, Division of Corrections and Rehabilitation; Department of Military Affairs and Public Safety, Regional Jail Authority; Department of Military Affairs and Public Safety, Eastern Regional Jail; Department of Military Affairs and Public Safety, South Central Regional Jail; Department of Military Affairs and Public Safety, West Virginia Adjutant General’s Office; Department of Transportation, Division of Highways; and Department of Transportation, Division of Motor Vehicles, to be moral obligations of the state and directing payment thereof.

1 The Legislature has considered the findings of fact and recommendations reported to it
2 by the Legislative Claims Commission concerning various claims against the state and agencies
3 thereof and, in respect to each of the following claims, the Legislature adopts those findings of
4 fact as its own and in respect of the claims herein, the Legislature has independently made
5 findings of fact and determinations of award and hereby declares it to be the moral obligation of
6 the state to pay each such claim in the amount specified below and directs the Auditor to issue
7 warrants for the payment thereof out of any fund appropriated and available for the purpose.
