1 AN ACT supplementing and amending by decreasing an existing appropriation and adding a new
2 appropriation of federal funds out of the Treasury to the Department of Military Affairs and
3 Public Safety – Adjutant General – West Virginia National Guard Counterdrug Forfeiture
4 Fund, fund 8785, fiscal year 2020, organization 0603, by supplementing, amending,

7 Whereas, The Governor has established the availability of federal funds for expenditure
