House Bill 101

BY DELEGATES HANSHAW (MR. SPEAKER) AND SKAFF

(BY REQUEST OF THE EXECUTIVE)

[Passed June 7, 2021; in effect from passage.]

1 AN ACT making a supplementary appropriation by adding a new item of appropriation and
2 increasing the expenditure of public moneys out of the Treasury from the balance of
3 moneys remaining as an unappropriated balance in the State Fund, General Revenue, to
4 the Department of Transportation, Division of Highways, fund 0620, fiscal year 2021,
5 organization 0803, by supplementing and amending Chapter 11, Acts of the Legislature,
6 Regular Session, 2020, known as the budget bill for the fiscal year ending June 30, 2021.

7 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
8 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
9 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of
10 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
11 appropriations for the fiscal year 2021; and

12 WHEREAS, The Governor submitted to the Legislature an Executive Message dated June
13 7, 2021, which included a revised estimate of revenues for the State Fund, General Revenue, for
14 the fiscal year 2021; and

15 WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
16 General Revenue and the Executive message, there remains an unappropriated balance in the
17 State Treasury which is available for appropriation during the fiscal year ending June 30, 2021;
18 therefore

Be it enacted by the Legislature of West Virginia:

1 That Chapter 11, Acts of the Legislature, Regular Session, 2020, known as the budget
2 bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 1
3 thereof, the following:

TITLE II – APPROPRIATIONS.

Section 1. Appropriations from general revenue.
