1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
 2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
 3 2022, to the Department of Health and Human Resources, Consolidated Medical Service
 4 Fund, fund 8723, fiscal year 2022, organization 0506; to the Department of Health and
 5 Human Resources, Division of Health – Central Office, fund 8802, fiscal year 2022,
 6 organization 0506; and to the Department of Health and Human Resources, Division of
 7 Human Services, fund 8722, fiscal year 2022, organization 0511 by supplementing and
 8 amending the appropriations for the fiscal year ending June 30, 2022.
