1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the  
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,  
3 2022, to the Department of Education, State Board of Education – State Department of  
4 Education, fund 8712, fiscal year 2022, organization 0402; and to the Department of  
5 Education, State Board of Education – School Lunch Program, fund 8713, fiscal year  
6 2022, organization 0402, by supplementing and amending the appropriations for the fiscal  
7 year ending June 30, 2022.

8 Whereas, The Governor has established the availability of federal funds for expenditure  
9 in the fiscal year ending June 30, 2022, which are hereby appropriated by the terms of this  
10 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 8712, fiscal  
2 year 2022, organization 0402, be supplemented and amended by adding a new item of  
3 appropriation as follows:
