1	A BILL supplementing and amending the appropriations of public moneys out of the Treasury
2	from the balance of moneys remaining as an unappropriated balance in the State Fund,
3	General Revenue, to the Department of Transportation, State Rail Authority, fund 0506,
4	fiscal year 2021, organization 0804, by supplementing and amending Chapter 11, Acts of
5	the Legislature, Regular Session, 2020, known as the budget bill for the fiscal year ending
6	June 30, 2021.
1	WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
2	dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
3	setting forth therein the cash balance as of July 1, 2020, and further included an estimate of
4	revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
5	appropriations for the fiscal year 2021; and
1	WHEREAS, The Governor submitted to the Legislature an Executive Message dated June
2	7, 2021 which included a revised estimate of revenues for the State Fund, General Revenue and
3	a statement of the State Fund, General Revenue for the fiscal year 2021; and
1	WHEREAS, The Governor submitted to the Legislature an Executive Message dated June
2	24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue
3	and a statement of the State Fund, General Revenue for the fiscal year 2021; and
1	WHEREAS, It appears from the Statement of the State Fund, General Revenue, and
2	Executive messages, there remains an unappropriated balance in the State Treasury which is
3	available for appropriation during the fiscal year ending June 30, 2021; therefore
	Be it enacted by the Legislature of West Virginia:
1	That Chapter 11, Acts of the Legislature, Regular Session, 2020, known as the budget bill
2	fund 0506, fiscal year 2021, organization 0804, be supplemented and amended to read as
3	follows:
