A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
designated §16-63-1, establishing the food desert program under the Department of
Agriculture.

Be it enacted by the Legislature of West Virginia:

### ARTICLE 63. FOOD DESERT PROGRAM.

#### §16-63-1. Food desert program.

1 (a) The Department of Agriculture shall establish a two-year program to provide residents 2 of food desert communities with access to fresh and affordable produce. In establishing the 3 program, the department shall select one or more partnering providers to establish weekly 4 markets in three food desert communities, one of which shall be located in a rural area, in order 5 to make fruits and vegetables more affordable to families and individuals with limited access to 6 fresh food. 7 (b) The department shall: 8 (1) Solicit and select a partnering provider that demonstrates the ability to reliably provide 9 a consistent, year-round supply of reasonably priced fresh fruits and vegetables to serve food 10 desert communities; 11 (2) Work with food desert communities to identify and recruit a partnering provider to 12 establish weekly markets, which may be operated in partnership with local public schools, 13 community organizations, or nonprofit organizations; and 14 (3) Engage in appropriate outreach efforts with food desert communities, the agricultural industry, and the public concerning the availability of the program. 15 16 (c) A partnering provider that operates a market shall, at a minimum: 17 (1) Demonstrate to the department the ability to reliably provide a consistent, year-round 18 supply of reasonably priced fresh fruits and vegetables; 19 (2) Accept cash, credit, debit, and food vouchers for produce at any market operating 20 under the program;

21	(3) Offer reduced price produce packages;
22	(4) Include storage guides containing information on how to keep the produce fresh and
23	recipes for use of the produce; and
24	(5) Donate any surplus produce at the end of each market to food banks, food pantries,
25	soup kitchens, and other nonprofit organizations that distribute food to individuals in need located
26	in the state.
27	(d) Within two years after the date of enactment of this act, the department shall submit a
28	written report to the Legislature, summarizing the program established pursuant to this section;
29	identifying the partnering providers and food desert communities participating in the program, as
30	well as the number of families and individuals served by the markets, and the amount of food
31	vouchers redeemed at the markets; and providing recommendations for legislative actions to
32	expand access to, and the affordability of, fruits and vegetables to residents in food desert
33	communities throughout the state.

NOTE: The purpose of this bill is to establish the food desert program.
