1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, 2 designated §31G-6-1, §31G-6-2, §31G-6-3, and §31G-6-4, all relating generally to 3 broadband enhancement and expansion policies; providing for the creation and 4 administration of four funds in the State Treasury known as the Broadband Open Access 5 Middle Mile Fund, the Broadband Grant Matching Fund, the Wired Wonderful West 6 Virginia Fund, and the Broadband Provider Expansion Fund, all to be administered by and 7 under the control of the Office of Broadband; providing for state budgeting and legislative 8 appropriations concerning the funds; providing for the separate purposes of each of the 9 funds and the separate conditions under which moneys in each fund may be expended, 10 being generally broadband expansion in this state.

Be it enacted by the Legislature of West Virginia:

CHAPTER 31G. BROADBAND ENHANCEMENT AND EXPANSION POLICIES.

ARTICLE 6. THE WEST VIRGINIA BROADBAND FUNDS.

§31G-6-1. Creation and Administration of the Broadband Open Access Middle Mile Fund.

(a) There is hereby created in the State Treasury a fund known as the Broadband Open 1 2 Access Middle Mile Fund. The fund shall be administered by and under the control of the Office of Broadband. Expenditures from the fund shall be for the purposes set forth in this section and 3 4 are to be made only in accordance with appropriation by the Legislature and in accordance with 5 the provisions of article two, chapter eleven-b of this code. 6 (b) The fund shall consist of moneys appropriated by the Legislature. For fiscal year 2023 7 and each fiscal year thereafter, the Office of Broadband shall include in their budget requests and 8 the Governor shall include in each budget bill submitted to the Legislature, an appropriation for 9 the purposes of the fund in an amount not less than \$1,000,000. The amount appropriated shall 10 be transferred to the fund to be used solely for the purposes provided by this section.

4	to be made only in accordance with appropriation by the Legislature and in accordance with the
5	provisions of article two, chapter eleven-b of this code.
6	(b) The fund shall consist of moneys appropriated by the Legislature. For fiscal year 2023
7	and each fiscal year thereafter, the Office of Broadband shall include in their budget requests and
8	the Governor shall include in each budget bill submitted to the Legislature, an appropriation for
9	the purposes of the fund in an amount not less than \$1,000,000. The amount appropriated shall
10	be transferred to the fund to be used solely for the purposes provided by this section.
11	(c) Expenditures from the fund shall be for the purposes of facilitating broadband projects
12	which require up to a 50% match from sources other than the primary grantor and which extends
13	or improves broadband access in this state. No expenditures shall be made from this fund until
14	and unless satisfactory documentation of financial need is provided to the office and approved by
15	the director: Provided, That but for this assistance, the grantee would be unable to be awarded

15	other financial support in the eligible area, to provide service to unserved and unfunded areas
16	after the provider demonstrates to the director that they have completed the necessary
17	infrastructure build to serve a home or business premises including verifiable speed test data with
18	GPS coordinates and a signed affidavit indicating under criminal penalties that to the best of the
19	provider's knowledge no other terrestrial broadband service was available to the premises at the
20	time of installation:
21	(1) A provider shall receive \$2,000 per premises for completing infrastructure installation
22	to a residence or business with
23	(A) an actual downstream data rate of 1,000 megabits per second; and
24	(B) an actual upstream data rate of 50 megabits per second; and
25	(C) unlimited data usage without overage charges; and
26	(D) unlimited data usage without "throttling" or reduction of downstream or upstream data
27	rate due, in whole or in part, to the amount of data transferred in any period; or
28	(2) A provider shall receive \$500 per premises for completing infrastructure installation to
29	a residence or business with a terrestrial wired or fixed wireless connection with
30	(A) an actual downstream data rate of 25 megabits per second; and
31	(B) an actual upstream data rate of three megabits per second; and
32	(C) unlimited data usage without overage charges; and
33	(D) unlimited data usage without "throttling" or reduction of downstream or upstream data
34	rate due, in whole or in part, to the amount of data transferred in any period.
35	(d) Disbursements from this fund shall be made available on a first-come, first-served
36	basis and shall be expended and made available to providers until the fund is depleted. Upon
37	additional legislative appropriation into this fund, disbursements shall be disbursed again in like
38	fashion until the fund is depleted.

NOTE: The purpose of this bill is to enhance and expand broadband policies and access; provide for the creation and administration of four funds in the state treasury known as the Broadband Open Access Middle Mile Fund, the Broadband Grant Matching Fund, the Wired Wonderful West Virginia Fund, and the Broadband Provider Expansion Fund, all to be administered by and under the control of the Office of Broadband; provide for state budgeting and legislative appropriations concerning the funds; provide for the separate purposes of each of the funds and the separate conditions under which moneys in each fund may be expended, being generally broadband expansion in this state.
