1 AN ACT expiring funds to the unappropriated surplus balance in the State Fund, General  
2 Revenue, for the fiscal year ending June 30, 2021 in the amount of \$550,000 from the  
3 Department of Veterans' Assistance, Department of Veterans' Assistance, fund 0456,  
4 fiscal year 2012, organization 0613, appropriation 34400 and making a supplementary  
5 appropriation of public moneys out of the Treasury from the balance of moneys remaining  
6 as an unappropriated surplus balance in the State Fund, General Revenue, to the  
7 Department of Veterans' Assistance – Department of Veterans' Assistance - Veterans'  
8 Home, fund 0460, fiscal year 2021, organization 0618, by supplementing and amending  
9 the appropriations for the fiscal year ending June 30, 2021.

10 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,  
11 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,  
12 setting forth therein the cash balance as of July 1, 2020, and further included the estimate of  
13 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular  
14 appropriations for the fiscal year 2021 and further included recommended expirations to the  
15 surplus balance of the State Fund, General Revenue; and

16 WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,  
17 General Revenue, and this legislation, there now remains an unappropriated surplus balance in  
18 the State Treasury which is available for appropriation during the fiscal year ending June 30,  
19 2021; therefore

*Be it enacted by the Legislature of West Virginia:*

20 That the balance of the funds available for expenditure in the fiscal year ending June 30,  
21 2021, to the Department of Veterans' Assistance, Department of Veterans' Assistance, fund 0456,  
22 fiscal year 2012, organization 0613, appropriation 34400, be decreased by expiring the amount  
23 of \$550,000 to the unappropriated surplus balance of the State Fund, General Revenue to be  
24 available for appropriation during the fiscal year ending June 30, 2021.

1 And, That the total appropriation for the fiscal year ending June 30, 2021, to fund 0460,  
2 fiscal year 2021, organization 0618, be supplemented and amended by increasing an existing  
3 item of appropriation as follows:




